- 確定本公司證券持有人的受益權利,例如股息、供股和紅股等;
- 分發本公司及其附屬公司的通訊;
- 編製統計數據和股東資料;
- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關用途及/或使本公司及香港股份過戶登記分處能履行對證券持有人及/或監管機構承擔的責任及/或證券持有人不時同意的任何其他用途。

## 3. 轉交個人資料

本公司及其香港股份過戶登記分處所持有關證券持有人的個人資料將會保密,但本公司及其香港股份過戶登記分處可以在作上述任何用途之必要情況下,向或自下列任何人士披露、取得或轉交(無論在香港境內或境外)有關個人資料:

- 本公司委任的代理人,例如財務顧問、 收款銀行和海外股份過戶登記總處;
- (如證券申請人要求將證券存入中央結算系統)香港結算或香港結算代理人; 其將會就中央結算系統的運作使用有關個人資料;
- 向本公司或香港股份過戶登記分處提供 與其各自業務營運有關的行政、電訊、 電腦、付款或其他服務的任何代理人、 承包商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機 關或政府部門或其他由法例、規則或法 規所規定者;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師或股票經紀等。

# 4. 個人資料的保留

本公司及其香港股份過戶登記分處將按收 集個人資料所需的用途保留證券申請人及 持有人的個人資料。無需保留的個人資料 將會根據《條例》銷毀或處理。

## 5. 查閱和更正個人資料

證券持有人有權確定本公司或香港股份過戶登記分處是否持有其個人資料,並有權索取有關該資料的副本並更正任何不準確資料。本公司和香港股份過戶登記分處有權就處理該等查閱資料的要求收取合理費用。

所有查閱資料或更正資料的要求應按招股章程「公司資料」一節所披露或不時通知的本公司註冊地址向公司秘書或本公司的香港股份過戶登記分處屬下的私隱條例事務主任提出。
