CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders,

On behalf of the board (the "**Board**") of directors (the "**Directors**") of Wan Kei Group Holdings Limited (the "**Company**") and its subsidiaries (collectively the "**Group**"), I would like present to the shareholders of the Company (the "**Shareholders**"), the annual report of the Group for the year ended 31 March 2019 (the "**Reporting Period**" or "**YR2019**").

During the Reporting Period, the Group recorded a decrease in revenue of approximately HK\$23,332,000 or approximately 10.3% to approximately HK\$202,894,000 compared with the year ended 31 March 2018 (the "**YR2018**"). The decline in revenue was due to the decrease in revenue of foundation construction services during the Reporting Period.

Despite the fact that there has been an increase in public works funding as approved by the Legislative Councils since last year, competition among the foundation work industry was still intense. In addition, various costs of construction have been increased due to labour shortage and increasingly stringent regulatory controls, in particular the labour cost, cost of construction materials and operating costs, which affected the growth and profitability of the Group. As such, the Group recorded a net loss for the Reporting Period.

Looking ahead, the sustainability of foundation industry has been benefited from (i) the Lantau Tomorrow Vision project , (ii) Ten Major Infrastructure Projects launched in 2007, and (iii) Sustained housing demand.

致各位股東,

本人謹代表宏基集團控股有限公司(「本公 司」)及其附屬公司(統稱「本集團」)董事(「董 事」)會(「董事會」)向本公司股東(「股東」) 呈報本集團截至二零一九年三月三十一日止年 度(「報告期間」或「二零一九年度」)之年報。

於報告期間,本集團錄得的收入較截至二零 一八年三月三十一日止年度(「二零一八年 度」)減少約23,332,000港元或約10.3%至約 202,894,000港元。收入減少乃由於報告期間 地基建築服務收入減少。

地基行業的業務競爭激烈,即使立法會批准的 公共工程撥款較去年增加。此外,由於勞工短 缺及管控日益嚴格,勞工成本、建築材料成本 及營運成本等各項建築成本上漲,本集團的發 展及盈利能力受到影響。因此,本集團於報告 期間錄得淨虧損。

展望未來,地基行業的可持續發展乃得益於(i) 明日大嶼願景,(ii)二零零七年推出的十項大型 基建項目,及(iii)持續的住房需求。

CHAIRMAN'S STATEMENT 主席報告

In view of the slow down in the growth of the overall foundation industry in Hong Kong, the Company intends to seek opportunities in the investment sector as well as its money lending business in the coming years so as to broaden the income stream of the Group. In order to maintain a stable and sustainable development of the Group's existing businesses as well as diversifying and expanding the Group's businesses at the same time, the Group will leverage on its industrial experience and the advantage of its existing resources and talented team to seek cooperation and investment opportunities with high-quality companies in the emerging industries in the People's Republic of China (the "**PRC**").

On 2 October 2018, the Company, the vendors and the warrantors entered into the sale and purchase agreement, pursuant to which the Company conditionally agreed to acquire approximately 51.315% of issued share capital of the target group which is principally engaged in the business of operation of e-sports events, production of videos of e-sports events broadcast online, and filming and production of dramas broadcast online in the PRC. The acquisition is still in progress and pending for approval from the relevant authorities.

On behalf of the Board, I would like to take this opportunity to express my deepest gratitude to our Shareholders and business partners for their continued support, and to our management and staff members for their commitment and contribution to the growth of the Group.

BUSINESS REVIEW

The Group is principally engaged in providing: (i) foundation construction; (ii) ground investigation services; and (iii) financial services in Hong Kong.

Foundation Construction

During the Reporting Period, the foundation construction undertaken by the Group mainly consisted of the construction of socketed H-piles, mini piles, soldier piles, pipe piles and king posts. The Group undertook foundation construction projects in both the public and private sectors. Revenue from the foundation works contributed approximately 82.0% to the total revenue of the Group during the Reporting Period (YR2018: approximately 84.4%).

Ground Investigation Services

The Group also acted as a contractor to provide ground investigation services in both public and private sectors in Hong Kong during the Reporting Period. Revenue from the ground investigation services contributed approximately 17.6% to the total revenue of the Group during the Reporting Period (YR2018: approximately 15.6%).

Financial Services

During the Reporting Period, the money lending business has commenced. Revenue from the financial services contributed approximately 0.4% to the total revenue of the Group during the Reporting Period (YR2018: nil).

業務回顧

本集團主要於香港從事提供:(i)地基建築;(ii) 土地勘測服務;及(iii)金融服務。

地基建築

於報告期間,本集團承接的地基建築主要包括 建造插座式工字樁、微型樁、豎樁、管樁及起 重柱。本集團承接公營部門及私營部門地基 建築項目。於報告期間內,地基工程所得收入 佔本集團總收入約82.0%(二零一八年度:約 84.4%)。

土地勘測服務

於報告期間,本集團亦於香港作為承建商向公營及私營部門提供土地勘測服務。於報告期間內,土地勘測服務所得收入佔本集團總收入約 17.6%(二零一八年度:約15.6%)。

金融服務

於報告期間,借貸業務已開始營運。於報告期間 內,金融服務所得收入佔本集團總收入約0.4% (二零一八年度:無)。

FINANCIAL REVIEW

Revenue

The Group's total revenue for the Reporting Period decreased by approximately HK\$23,332,000, or approximately 10.3%, from approximately HK\$226,226,000 for the year ended 31 March 2018 to approximately HK\$202,894,000 for the Reporting Period, which was primarily due to:

Foundation Construction

The revenue from undertaking foundation construction projects decreased by approximately HK\$24,479,000, or approximately 12.8%, from approximately HK\$190,938,000 for the year ended 31 March 2018 to approximately HK\$166,459,000 for the Reporting Period. This was primarily due to the decrease of the number of sizable projects tendered by the Group during the Reporting Period.

Ground Investigation Services

The revenue from ground investigation services slightly increased by approximately HK\$394,000, or approximately 1.1%, from approximately HK\$35,288,000 for the year ended 31 March 2018 to approximately HK\$35,682,000 for the Reporting Period. This was primarily due to the increase in the number of sizable projects tendered by the Group during the Reporting Period.

Financial Services

During the Reporting Period, the money lending business has commenced. The revenue for financial services amounted to approximately HK\$753,000 for the Reporting Period (YR2018: nil).

財務回顧

收入

本集團於報告期間之總收入由截至二零一八年 三月三十一日止年度之約226,226,000港元減 少約23,332,000港元或約10.3%至報告期間之 約202,894,000港元,主要原因如下:

地基建築

承接地基建築項目收入由截至二零一八年三月 三十一日止年度之約190,938,000港元減少約 24,479,000港元或約12.8%至報告期間之約 166,459,000港元,主要由於本集團於報告期 間內所投得的大型項目數量減少。

土地勘測服務

土地勘測服務收入由截至二零一八年三月 三十一日止年度之約35,288,000港元輕微增 加約394,000港元或約1.1%至報告期間之約 35,682,000港元,主要由於本集團於報告期間 所投得的大型項目數量增加。

金融服務

於報告期間,借貸業務已開始營運。報告期間 金融服務的收入為約753,000港元(二零一八 年度:無)。

Direct Costs

The Group's direct costs amounted to approximately HK\$209,516,000 for the Reporting Period, representing a decrease of approximately 17.5% from approximately HK\$253,873,000 for the year ended 31 March 2018.

Foundation Construction

The direct costs for the foundation construction mainly consisted of construction material costs, subcontracting fees and wages of workers. The direct costs decreased by approximately 18.9%, from approximately HK\$226,376,000 for the year ended 31 March 2018 to approximately HK\$183,487,000 for the Reporting Period. This was mainly due to (i) the decrease in revenue of the foundation construction, and (ii) the reduction in depreciated last year (YR2019: approximately HK\$6,113,000; YR2018: approximately HK\$13,620,000).

Ground Investigation Services

The direct costs for the ground investigation services mainly included the subcontracting fees and the wages of workers. The decrease in direct costs by approximately 6.1%, from approximately HK\$27,498,000 for the year ended 31 March 2018 to approximately HK\$25,829,000 for the Reporting Period, was primarily due to the higher gross profit margin projects tendered by the Group during the Reporting Period.

直接成本

本集團於報告期間的直接成本約為 209,516,000港元,較截至二零一八年三月 三十一日止年度的約253,873,000港元下降約 17.5%。

地基建築

地基建築的直接成本主要包括建築材料成本、 分包費用及工人工資。直接成本由截至二零一八 年三月三十一日止年度的約226,376,000港元 減少約18.9%至報告期間的約183,487,000港 元。此乃主要由於(i)地基建築的收入減少,及(ii) 去年大部分機械已完全折舊導致機械折舊減少 (二零一九年度:約6,113,000港元;二零一八 年度:約13,620,000港元)。

土地勘測服務

土地勘測服務的直接成本主要包括分包費用 及工人工資。直接成本由截至二零一八年三月 三十一日止年度的約27,498,000港元減少約 6.1%至報告期間的約25,829,000港元,主要 由於報告期間本集團投得的項目毛利率較高。

Financial Services

The direct costs for the financial services mainly consisted of commission fees and search fees. The direct costs amounted to approximately HK\$200,000 for the Reporting Period (YR2018: nil).

Gross (Loss)/Profit and Gross (Loss)/Profit Margin

The gross loss decreased from approximately HK\$27,648,000 for the year ended 31 March 2018 to approximately HK\$6,622,000 for the Reporting Period. The Group's overall gross loss margin during the Reporting Period was approximately 3.3% (YR2018: gross loss margin amounted to approximately 12.2%).

Gross loss of the Group's foundation construction segment was approximately HK\$17,028,000 for the Reporting Period, representing a decrease of approximately HK\$18,410,000 from approximately HK\$35,438,000 gross loss as compared to that for the year ended 31 March 2018. Gross loss margin of the foundation construction segment amounted to approximately 10.2% (YR2018: gross loss margin of approximately 18.6%). The decline in gross loss margin was mainly due to (i) the reduction in depreciated last year, (ii) the impact on initial application of HKFRS 15, and (iii) the improvement of the bidding prices on the new tenders.

Gross profit of the Group's ground investigation services segment was approximately HK\$9,853,000 for the Reporting Period, representing an increase of 26.5% from approximately HK\$7,791,000 as compared to that for the year ended 31 March 2018. Gross profit margin of the ground investigation services segment increased from approximately 22.1% for the year ended 31 March 2018 to approximately 27.6% for the Reporting Period. The increase in gross profit margin was mainly due to higher gross profit margin projects tendered by the Group during the Reporting Period.

Gross profit of the Group's financial service was approximately HK\$553,000 for the Reporting Period (YR2018: nil). Gross profit margin of the financial service amounted to approximately 73.4% (YR2018: nil).

金融服務

金融服務的直接成本主要包括佣金及檢索費。 於報告期間,直接成本約為200,000港元(二零 一八年度:無)。

毛(損)/利及毛(損)/利率

毛損由截至二零一八年三月三十一日止年度的約27,648,000港元減少至報告期間的約 6,622,000港元。本集團於報告期間的整體 毛損率約為3.3%(二零一八年度:毛損率約 12.2%)。

本集團於報告期間的地基建築分部之毛損為約17,028,000港元,較截至二零一八年三月 三十一日止年度的毛損約35,438,000港元減少約18,410,000港元。地基建築分部的毛損率約 為10.2%(二零一八年度:毛損率約18.6%)。 毛損率下降乃主要由於(i)去年大部分機械已完 全折舊導致機械折舊減少,(ii)首次應用香港財 務報告準則第15號之影響,及(iii)新投標項目的 投標價格提高所致。

本集團土地勘測服務分部於報告期間的毛利 約為9,853,000港元,較截至二零一八年三 月三十一日止年度的約7,791,000港元增加 26.5%。土地勘測服務分部的毛利率由截至二 零一八年三月三十一日止年度的約22.1%上升 至報告期間的約27.6%。毛利率上升乃主要由 於報告期間本集團投得的項目毛利率較高。

本集團金融服務於報告期間的毛利約為 553,000港元(二零一八年度:無)。金融服務 的毛利率為約73.4%(二零一八年度:無)。

Other Revenue

The other revenue of the Group decreased by approximately HK\$2,427,000, or approximately 38.6%, from approximately HK\$6,295,000 for the year ended 31 March 2018 to approximately HK\$3,868,000 for the Reporting Period. The decrease was mainly due to the absence of rental income from lease of machinery during the Reporting Period (YR2018: approximately HK\$2,682,000).

Other Net Income

The other net income of the Group decreased by approximately HK\$2,353,000, from approximately HK\$4,107,000 for the year ended 31 March 2018 to approximately HK\$1,754,000 for the Reporting Period. The decrease was mainly due to the decrease of gain on disposal of property, plant and equipment (YR2019: gain of approximately HK\$1,181,000; YR2018: gain of approximately HK\$3,013,000).

General and administrative expenses

The Group's general and administrative expenses for the Reporting Period were approximately HK\$51,022,000 (YR2018: approximately HK\$45,958,000), representing an increase of approximately 11.0% as compared to that for the year ended 31 March 2018. The increase was mainly attributable to (i) the increase in the general operating expenses (mainly included salaries and other administrative expenses) for the financial services segment; and (ii) professional fees for the potential acquisition (YR2019: approximately HK\$2,386,000: YR2018: nil) during the Reporting Period.

其他收入

本集團其他收入由截至二零一八年三月 三十一日止年度的約6,295,000港元減少約 2,427,000港元或約38.6%至報告期間的約 3,868,000港元。該減少乃主要由於報告期間 並無來自機械租賃的租賃收入(二零一八年 度:約2,682,000港元)。

其他收益淨額

本集團其他收益淨額由截至二零一八年三月 三十一日止年度的約4,107,000港元減少約 2,353,000港元至報告期間的約1,754,000港 元。該減少乃主要由於出售物業、廠房及設備之 收益減少(二零一九年度:收益約1,181,000港 元;二零一八年度:收益約3,013,000港元)。

一般及行政開支

本集團於報告期間的一般及行政開支約 為51,022,000港元(二零一八年度:約 45,958,000港元),較截至二零一八年三月 三十一日止年度增加約11.0%。該增加乃主 要由於報告期間(i)金融服務分部之一般經營 開支(主要包括薪金及其他行政開支)增加; 及(ii)潛在收購的專業費用(二零一九年度:約 2,386,000港元;二零一八年度:無)。

Finance Costs

The finance costs decreased by approximately HK\$2,164,000, from approximately HK\$7,132,000 for the year ended 31 March 2018 to approximately HK\$4,968,000 for the Reporting Period. The decrease was mainly due to the decrease in the interest rate for borrowing from a related company, Bright Dynasty Trading Limited and borrowing from a former director since 1 July 2018. The interest rates were reduced from 5% to 2.5% per annum from 1 July 2018 to 31 March 2019.

Income Tax

The tax credit for the Reporting Period was approximately HK\$1,760,000 (YR2018: tax credit of approximately HK\$89,000). The change was mainly due to the change of deferred tax for the Reporting Period.

Financial assets at fair value through profit or loss

During the Reporting Period, the financial assets at fair value through profit or loss represents the subscription of the private fund and the purchase of the listed equity securities. These financial assets are measured at fair value and were subscribed and purchased by a wholly owned subsidiary of the Group. During the Reporting Period, the net fair value loss of financial assets was recognised in the statement of profit or loss amounted to approximately HK\$551,000 (YR2018: nil).

LOSS ATTRIBUTABLE TO EQUITY SHAREHOLDERS OF THE COMPANY

For the Reporting Period, the Group recorded a net loss of approximately HK\$55,229,000, as compared with the net loss of approximately HK\$70,247,000 for the year ended 31 March 2018. The decrease was mainly attributable to the decrease in overall gross loss margin as previously discussed.

融資成本

融資成本由截至二零一八年三月三十一日止年 度的約7,132,000港元減少約2,164,000港元 至報告期間的約4,968,000港元。該減少乃主 要由於自二零一八年七月一日起,來自一間關 連公司(Bright Dynasty Trading Limited)的 借貸及來自一名前董事的借貸的利率下降。由 二零一八年七月一日至二零一九年三月三十一 日,相關年利率由5%下調至2.5%。

所得税

報告期間之税項抵免約為1,760,000港元(二零一八年度:税項抵免約89,000港元)。該變動 乃主要由於報告期間的遞延税項變動所致。

按公平值計入損益之金融資產

於報告期間,按公平值計入損益之金融資產指 認購私募基金及購買上市股本證券。該等金融 資產按公平值計量,並由本集團全資附屬公司 認購及購買。於報告期間,金融資產的公平值 淨虧損於損益表確認,約為551,000港元(二零 一八年度:無)。

本公司權益股東應佔虧損

於報告期間,本集團錄得淨虧損約55,229,000 港元,而截至二零一八年三月三十一日止年度 則錄得淨虧損約70,247,000港元。該減少乃主 要由於如先前所討論的整體毛損率下降所致。

FINAL DIVIDEND

The Board did not recommend the payment of a final dividend to the Shareholders for the Reporting Period (YR2018: nil).

PROSPECTS

The Directors estimate that the growth of the overall foundation industry in Hong Kong will continue to slow down in the coming years. The Directors are of the view that the approval process of government projects from the Legislative Council is expected to be slow, which will lead to a decrease in the number of available Government project tenders in the coming years. In addition, the intense competition has continued to impact the foundation industry in Hong Kong, which will in turn affect the growth and profitability of the Group. Nevertheless, the Directors are confident that with the Group's reputation in the foundation industry and experienced management team, the Group is in a well position to compete with its competitors.

In view of the slow down in the growth of the overall foundation industry in Hong Kong, the Company intends to seek opportunities in the investment sector as well as its money lending business in the coming years so as to broaden the income stream of the Group. In order to maintain a stable and sustainable development of the Group's existing businesses as well as diversifying and expanding the Group's businesses at the same time, the Group will leverage on its industrial experience and the advantage of its existing resources and talented team to seek cooperation and investment opportunities with highquality companies in the emerging industries in the PRC.

末期股息

董事會不建議向股東派付報告期間之末期股息 (二零一八年度:無)。

前景

董事預計,香港整體地基行業的增長於來年將 繼續放緩。董事認為,香港立法會之政府項目 審批進度預計緩慢,導致來年可進行競標的政 府項目數量減少。此外,競爭加劇繼續影響香 港地基行業,進而對本集團的增長及盈利能力 產生影響。然而,董事相信,憑藉本集團在地基 行業的聲譽及經驗豐富的管理團隊,本集團具 備實力與其競爭對手展開競爭。

鑒於香港地基行業整體增長放緩,本公司擬尋 求機會於來年擴展至投資行業以及其借貸業 務,從而擴寬本集團的收入來源。為維持本集 團現有業務穩定之持續發展,同時多元化及拓 展本集團業務,本集團將利用其行業經驗和現 有資源及人才團隊的優勢,尋求與中國新興產 業的優質企業合作及投資機會。

DEBTS AND CHARGE ON ASSETS

The total interest-bearing borrowings of the Group mainly consisted of finance leases, borrowing from a former director and borrowing from a related company. The above borrowings were incurred during the Reporting Period (YR2019: approximately HK\$198,287,000; YR2018: approximately HK\$160,740,000). All borrowings were denominated in Hong Kong dollar. Except for finance leases, interest on other borrowings were charged at fixed rates. The Group currently does not have an interest rate hedging policy and the Group monitors interest risks continuously and considers hedging any excessive risk when necessary. The finance leases of the Group were secured by the Group's machinery with an aggregate net book value of approximately HK\$1,467,000).

NET CURRENT ASSETS

As at 31 March 2019, the Group's net current assets amounted to approximately HK\$251,988,000, which was approximately HK\$49,173,000 lower than net current assets of approximately HK\$301,161,000 as at 31 March 2018. As at 31 March 2019, the Group's current liabilities amounted to approximately HK\$233,508,000, representing an increase of approximately HK\$22,916,000 from approximately HK\$210,592,000 as at 31 March 2018. The increase was mainly due to (i) the borrowing from a former director during the Reporting Period, with the principal amount of HK\$38,300,000, and (ii) the interests incurred by the borrowings from a related company and a former director during the Reporting Period, with the amount of approximately HK\$4,653,000.

債務及資產押記

本集團的計息借貸總額主要包括融資租賃、來 自一名前董事的借貸及來自一間關連公司的 借貸。以上借貸均於報告期間發生(二零一九 年度:約198,287,000港元;二零一八年度:約 160,740,000港元)。所有借貸以港元計值, 除融資租賃外,其他借貸利息以固定利率計 息。本集團目前並無利率對沖政策,而本集團 持續監察利率風險及於需要時考慮對沖任何 過高風險。本集團的融資租賃以本集團賬面淨 值總額約8,267,000港元(二零一八年度:約 11,467,000港元)的機械作抵押。

流動資產淨值

於二零一九年三月三十一日,本集團的流動資產淨值約為251,988,000港元,較二零一八年 三月三十一日的流動資產淨值約301,161,000 港元減少約49,173,000港元。於二零一九 年三月三十一日,本集團的流動負債約為 233,508,000港元,較二零一八年三月三十一 日的約210,592,000港元增加約22,916,000港 元。該增加主要由於(i)報告期間內向一名前董 事取得本金額為38,300,000港元的借貸,及(ii) 報告期間內因向一間關連公司及一名前董事借 貸而產生利息約4,653,000港元。

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2019, the Group had cash and bank balances of approximately HK\$337,512,000, representing a decrease of approximately HK\$77,625,000 (as at 31 March 2018: approximately HK\$415,137,000), all of which were denominated in Hong Kong dollar.

CASH FLOW

The net cash used by the Group in its operating activities amounted to approximately HK\$118,256,000 during the Reporting Period, which was mainly used for the foundation construction and ground investigation services. Net cash generated from investing activities was approximately HK\$8,052,000, and the net cash generated from financing activities was approximately HK\$32,579,000, in which HK\$38,300,000 arose from borrowing from a former director during the Reporting Period, net off the repayment of finance leases (YR2019: approximately HK\$5,721,000).

The gearing ratio of the Group as at 31 March 2019 (defined as total interest-bearing liabilities divided by the Group's total equity) was approximately 73.9% (as at 31 March 2018: approximately 49.5%).

TREASURY POLICY

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy position of liquidity throughout the Reporting Period. The Group strives to reduce the exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

流動資金及財務資源

於二零一九年三月三十一日,本集團有現 金及銀行結餘約337,512,000港元,減少約 77,625,000港元(於二零一八年三月三十一 日:約415,137,000港元),全部以港元計值。

現金流量

於報告期間本集團經營活動所用的現金淨額 約為118,256,000港元,主要用於地基建築及 土地勘測服務。投資活動所得現金淨額約為 8,052,000港元,以及融資活動所得現金淨額約 為32,579,000港元,其中38,300,000港元來 自於報告期間向一名前董事取得的借貸,抵銷 融資租賃還款(二零一九年度:約5,721,000 港元)。

本集團於二零一九年三月三十一日的資本負債 比率(定義為總計息負債除以本集團的總權益) 約為73.9%(於二零一八年三月三十一日:約 49.5%)。

庫務政策

本集團已對其庫務政策採取審慎的財務管理方 針,故在整個報告期間內維持穩健的流動資金 狀況。本集團致力透過進行持續的信貸評估及 評估其客戶的財務狀況降低信貸風險。為管理 流動資金風險,董事會密切監察本集團的流動 資金狀況,以確保本集團資產、負債及其他承 擔的流動資金架構可滿足其不時的資金要求。

FOREIGN EXCHANGE EXPOSURE

Since the Group mainly operates in Hong Kong and most of the revenue and transactions arising from its operations were settled in Hong Kong dollar, and the Group's assets and liabilities are primarily denominated in Hong Kong dollar, the Directors believe that the Group's risk in foreign exchange is insignificant and the Group will have sufficient foreign exchange to meet its foreign exchange requirements. The Group has not experienced any material difficulties or effects on its operations or liquidity as a result of fluctuations in currency exchange rates; and it has not adopted any currency hedging policy or other hedging instruments during the Reporting Period.

CAPITAL STRUCTURE

The share capital of the Group only comprises of ordinary shares.

As at 31 March 2019, the Company's issued share capital was HK\$9,600,000 (as at 31 March 2018: HK\$9,600,000) and the number of its issued ordinary shares was 960,000,000 (as at 31 March 2018: 960,000,000) of HK\$0.01 each.

外匯風險

由於本集團主要在香港經營且大部分來自營運 的收入及交易以港元結算,而本集團的資產與 負債主要以港元計值,故董事認為本集團的外 匯風險甚微且本集團將有足夠外匯應付其匯兑 需要。於報告期間,本集團並無因匯率波動而 面臨任何經營或流動資金方面的重大困難或影 響;及本集團亦未採納任何貨幣對沖政策或其 他對沖工具。

資本結構

本集團股本僅由普通股組成。

SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSAL OF SUBSIDIARIES AND ASSOCIATED COMPANIES

On 2 October 2018, the Company, the vendors and the warrantors entered into the sale and purchase agreement, pursuant to which the Company conditionally agreed to acquire approximately 51.315% of issued share capital of the target group which is principally engaged in the business of operation of e-sports events, production of videos of e-sports events broadcast online, and filming and production of dramas broadcast online in the PRC. The transaction is subject to the approval from The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") and the Shareholders' approval at the general meeting of the Company. For further details, please refer to the announcements of the Company dated 2 October 2018, 29 October 2018, 23 November 2018, 25 February 2019, 3 April 2019 and 24 May 2019.

Save as disclosed in this report, there were no significant investments, material acquisitions or disposal of subsidiaries and associated companies made by the Group. 附屬公司及聯營公司的重大投資、重大收購 及出售事項

COMMITMENTS

The contractual commitments of the Group were primarily related to the leases of its office premises and warehouses. The Group's operating leases commitments amounted to approximately HK\$6,037,000 as at 31 March 2019 (as at 31 March 2018: approximately HK\$11,535,000). As at 31 March 2019, the Group's capital commitments amounted to HK\$215,000 (as at 31 March 2018: nil).

CONTINGENT LIABILITIES

The Group had no contingent liabilities as at 31 March 2019 and 2018.

EVENTS AFTER THE REPORTING PERIOD

There are no other significant event after the Reporting Period up to the date of this report.

LITIGATIONS

As at 31 March 2019, the Group had no material pending litigation.

EMPLOYEES AND REMUNERATION POLICIES

As at 31 March 2019, the Group had 128 fulltime employees (as at 31 March 2018: 123 full-time employees).

The remuneration policy and packages of the Group's employees are periodically reviewed. Apart from mandatory provident fund and in-house training programmes, salary increment and discretionary bonuses may be awarded to employees according to the assessment of individual performance. The total remuneration cost incurred by the Group for the Reporting Period was approximately HK\$63,242,000 as compared to approximately HK\$70,677,000 for the year ended 31 March 2018.

僱員及薪酬政策

於二零一九年三月三十一日,本集團有128名 全職僱員(於二零一八年三月三十一日:123名 全職僱員)。

本集團定期審閲僱員的薪酬政策及待遇。除強制性公積金及內部培訓課程外,本集團亦根據 個人表現評核而增加工資及授予僱員酌情花 紅。於報告期間,本集團產生的總薪酬成本約 為63,242,000港元,而截至二零一八年三月 三十一日止年度則約為70,677,000港元。

PRINCIPAL RISKS AND UNCERTAINTIES

The Group's key risk exposures are summarised as follows:

- (i) The Group has a concentrated clientele base. Any loss for major customers or decrease in the number of projects with the top 5 customers of the Group may adversely affect the Group's operations and financial results.
- (ii) The Group's past revenue and profit margin may not be an indicative of the Group's future revenue and profit margin. In particular, the Group's revenue is on project basis, which is non-recurrent in nature, and the Group may achieve lower-than expected revenue if it fails to maintain continuity of the Group's order book for its new projects.
- (iii) The Group is dependent on its Board members and senior management staff, the departure of its staff may adversely affect the Group's business operations.
- (iv) Failure to accurately estimate and control the costs of the Group's projects may adversely affect the Group's financial performance.
- (v) Any delay or default of progress payments or retention monies by the customers may affect the Group's cash flow and may have adverse impact on the Group's financial results.
- (vi) Failure to renew the Group's current registrations and licenses may adversely affect the Group's business operations. For other risks and uncertainties facing the Group, please refer to the section headed "Risks Factors" in the prospectus of the Company dated 28 July 2015 (the "**Prospectus**").

MANAGEMENT DISCUSSION AND ANALYSIS

管理層討論及分析

RELATIONSHIP WITH CUSTOMERS, SUPPLIERS, SUBCONTRACTORS AND EMPLOYEES

The Group's success also depends on the support from key stakeholders which comprise employees, customers and suppliers.

Customers

For foundation construction, the principal customers are generally from the main contractors of construction projects in Hong Kong. For ground investigation services, the principal customers are generally from the employers of construction projects in Hong Kong. During the Reporting Period, the Directors considered that the Group did not rely on any single customer. The Group also maintains a longterm relationship with its customers, some of which have established more than 10 years of working relationship with the Group.

Suppliers and Subcontractors

During the Reporting Period, the suppliers of goods and services which were specific to the business of the Group and were acquired on a regular basis to enable the Group to continue to carry its business included (i) subcontractors engaged by the Group to perform the site works; (ii) materials and equipment suppliers to supply materials and equipments used in the site works; and (iii) suppliers of miscellaneous goods and services required for the Group's business operations. The Group maintains multiple suppliers and subcontractors to avoid the overreliance on a few suppliers and subcontractors; and did not experience any material difficulties in sourcing materials from suppliers and assigning subcontractors during the Reporting Period. The Group did not have any significant disputes with any of its suppliers and subcontractors during the Reporting Period.

與客戶、供應商、分包商及僱員的關係

本集團的成功亦取決於主要持份者(包括僱 員、客戶及供應商)的支持。

客戶

就地基建築而言,主要客戶一般為香港建築項 目的總承建商。就土地勘測服務而言,主要客 戶一般為香港建築項目的僱主。於報告期間, 董事認為,本集團並不依賴任何單一客戶。本 集團亦與其客戶維持長期關係,部分客戶已與 本集團建立10年以上工作關係。

供應商及分包商

於報告期間,就本集團業務屬特定且須定期供 應貨物及服務以便本集團能繼續進行其業務的 供應商包括:(i)本集團委聘進行地盤工程的分 包商;(ii)供應地盤工程使用的物料及設備的物 料及設備供應商:及(iii)供應本集團業務營運的 料及設備供應商;及(iii)供應本集團業務營運所 需的其他各種貨品及服務的供應商。本集團維 持多名供應商及分包商以避免對少數供應商及 分包商過度依賴,於報告期間,本集團於向供 應商採購物料或委派分包商方面並無遭遇任何供 應商及分包商有任何重大糾紛。

Employees

The Group recognised employees as valuable assets of the Group. During the Reporting Period, the Group has complied with the applicable labour laws and regulations and regularly reviewed the benefits of existing staff for improvement. The Group intends to use its best effort to attract and retain appropriate and suitable personnel to serve the Group. The objective of the Group's human resource management is to reward and recognise performing staff by providing an attractive remuneration package.

The Group determines the salary of its employees mainly based on each employee's qualification, relevant experience, position and seniority. The Group conducts annual review on salary increment, bonuses and promotions based on the performance of each employee.

The Group considers that the Group has maintained a good relationship with its employees. The Group has not experienced any strikes, work stoppages or labour disputes which affected its operations during the Reporting Period. The Directors also acknowledge that the management team and the employees have maintained a good relationship and co-operated well during the Reporting Period.

ENVIRONMENTAL POLICIES

The Group places an emphasis on environmental protection when undertaking its projects. The Group was awarded the ISO 14001:2015 (environmental management system). The current ISO 14001:2015 certificate is valid from 7 April 2018 to 29 April 2021. When preparing the tender documents, the Group will take into consideration the environmental protection requirements of potential customers as well as the relevant laws and regulations in relation to environmental protection. The Group's safety officers are responsible for ensuring that the Group satisfies the applicable laws and regulations requirements and identifying and reporting on environmental issues to our project management team.

僱員

本集團視僱員為本集團的寶貴資產。於報告期 間,本集團已遵守適用勞動法律及法規,並定 期審閱及完善現有員工福利。本集團擬盡最大 努力吸引及挽留適當及合適人員為本集團服 務。本集團人力資源管理的目標為透過提供具 吸引力的薪酬待遇,以獎勵及認可表現優秀的 員工。

本集團主要根據各僱員的資格、相關經驗、職 位及年資釐定僱員薪酬。本集團每年根據各僱 員的表現對加薪、花紅及晉升進行檢討。

本集團認為本集團與其僱員關係良好。於報告 期間,本集團並無發生任何影響其營運的罷 工、停工或勞資糾紛。董事亦認為,於報告期 間管理團隊與僱員之間一直保持良好關係及合 作。

環保政策

本集團在進行項目時注重環保。本集團獲授 ISO 14001: 2015(環境管理體系)。現時ISO 14001: 2015認證的有效期由二零一八年四月 七日至二零二一年四月二十九日。於準備投標 文件時,本集團會考慮潛在客戶的環保要求以 及與環保有關的相關法律及法規。本集團的安 全主任負責確保本集團符合適用法律及法規的 規定,並找出環保方面的問題,向項目管理團 隊匯報。

管理層討論及分析

COMPLIANCE WITH LAWS AND REGULATIONS

The Group's operation are mainly carried out by the Company's subsidiaries in Hong Kong while the Company itself is a holding company. Our operations accordingly shall comply with the relevant laws and regulations in Hong Kong. During the Reporting Period and up to the date of this annual report, there is no material non-compliance with the relevant prevailing laws and regulations by the Group.

FUTURE PLANS FOR MATERIAL INVESTMENTS AND CAPITAL ASSETS

The Group did not have other plans for material investments and capital assets up to the date of this annual report.

ISSUE OF SHARES FROM THE PLACING

On 29 November 2016, the Company entered into a placing agreement with Kingston Securities Limited (the "Placing Agent"), whereby the Company conditionally agreed to place, through the Placing Agent, on a best effort basis, a maximum of 160,000,000 new ordinary shares of the Company of HK\$0.01 each (the "Placing Shares") to not less than six placees which are independent third parties at a price of HK\$0.86 per Placing Share (net placing price of HK\$0.84 per placing share) (the "Placing"). The Placing was completed on 16 December 2016. The gross proceeds of HK\$137,600,000 were received by the Company in accordance with the terms of the placing agreement. The net proceeds from the Placing, after deducting the Placing Agent's commission and other related expenses payable by the Company, amounted to approximately HK\$134,000,000. The net proceeds from the Placing are intended to be used for developing a business regarding investment and financing services and for setting up a subsidiary with money lender's license. As at 31 March 2019, we used the net proceeds from the Placing of approximately HK\$46,569,000 (YR2018: HK\$14,757,000) on the Group for the operation of money lending business, the payment of related staff costs. engaging a consultant for the application for securities licenses, administration costs and office set up cost.

遵守法律及法規

本集團的營運主要透過本公司於香港的附屬公司進行,而本公司本身為一間控股公司。因此, 我們的營運須遵守香港有關法律及法規。於報告期間內及直至本年報日期,本集團並無嚴重 違反相關現行法律及法規。

重大投資及資本資產的未來計劃

直至本年報日期,本集團並無其他重大投資及 資本資產計劃。

根據配售事項發行股份

於二零一六年十一月二十九日,本公司與金利 豐證券有限公司(「配售代理」)訂立配售協議, 據此,本公司有條件同意透過配售代理按竭盡 所能基準向不少於六名為獨立第三方之承配人 配售最多160,000,000股本公司每股0.01港元 之新普通股(「配售股份」),配售價為每股配售 股份0.86港元(淨配售價為每股配售股份0.84 港元)(「配售事項」)。配售事項已於二零一六 年十二月十六日完成。根據配售協議之條款, 本公司已收取所得款項總額137.600.000港 元。配售事項之所得款項淨額(經扣除配售代 理之佣金及本公司應付之其他相關費用)為約 134,000,000港元。配售事項之所得款項淨額 擬用於發展有關投資及金融服務業務以及設立 一間擁有放債人牌照之附屬公司。於二零一九 年三月三十一日,我們動用本集團配售事項所 得款項淨額約46,569,000港元(二零一八年 度:14,757,000港元)用於經營放債業務、支 付相關員工成本、委聘申請證券牌照之顧問、 行政費用及設立辦公室之成本。

Due to the increasing level of instability pertaining to the financial markets and competition in the financial services sector and the benefits of the proposed entry to the e-sports markets, the Board considers that the reallocation of the use of proceeds from the Placing, may bring better prospects to the Company and its Shareholders in the current situation. The Company therefore intends to change the use of up to approximately HK\$76,700,000 of such outstanding proceeds, and utilise the amount to fund the acquisition instead. For further details, please refer to the announcement of the Company dated 2 October 2018.

CORPORATE GOVERNANCE

The Company had complied with all applicable code provisions as set out in the Corporate Governance Code contained in Appendix 14 to the Rules (the "**Listing Rules**") Governing the Listing of Securities on The Stock Exchange during the Reporting Period, except for the deviation from the code provision A.2.1. For further details, please refer to the corporate governance report on pages 28 to 57 of this annual report.

CODE OF CONDUCT REGARDING DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "**Model Code**") as set out in Appendix 10 to the Listing Rules as its code of conduct regarding securities transactions by the Directors. All Directors have confirmed, following a specific enquiry by the Company, that they have complied with the required standard as set out in the Model Code throughout the Reporting Period. 鑒於金融市場的不穩定性持續上升,金融服務 行業競爭不斷加劇,以及建議進入電子競技市 場之裨益,董事會認為,在目前情況下,重新配 置配售事項之所得款項用途可為本公司及其股 東帶來更佳前景。因此,本公司擬更改有關未使 用所得款項中最多約76,700,000港元之用途, 並將該金額用作為收購事項提供資金。有關進 一步詳情,請參閱本公司日期為二零一八年十 月二日的公告。

企業管治

董事進行證券交易之操守守則

本公司已採納上市規則附錄十所載之上市發 行人董事進行證券交易之標準守則(「標準守 則」),作為董事進行證券交易之操守守則。經 本公司作出具體查詢後,全體董事確認彼等於 報告期間已遵守標準守則所載的規定標準。

EXECUTIVE DIRECTORS

Mr. Fong Hon Hung (方漢鴻), aged 61, is also the chairman of the Board (the "**Chairman**") and chief executive officer of our Group (the "**Chief Executive Officer**"). Mr. Fong has engaged in the foundation industry for more than 40 years and he is primarily responsible for the formulation of corporate strategic plans, the execution of daily management and administration of business and the operations of our Group. He is also the authorised signatory of Wan Kei Geotechnical Engineering Company Limited ("**Wan Kei Engineering**") under the register of specialist contractors (sub-register of foundation works category) maintained by the Buildings Department.

Mr. Fong has awarded a technician certificate in engineering surveying in November 1980, a certificate in civil engineering in November 1983, a higher certificate in civil engineering in November 1987 and the endorsement certificate in civil engineering project management in November 1998, which were all awarded by the Hong Kong Polytechnic University (formerly known as Hong Kong Polytechnic). The Company has complied with rules 3.10(1) and 3.10A of the Listing Rules during the Reporting Period. There are currently three independent non-executive Directors in the Board and the number of independent non-executive Directors represents more than one-third of the Board. As such, there exists a strong independent element in the Board, which can effectively exercise independent judgement. The Company has also complied with rule 3.10(2) of the Listing Rules which stipulates that one of the independent non-executive Directors must possess appropriate professional qualification or accounting or related financial management expertise. In compliance with the Code, the independent non-executive Directors.

Each of the independent non-executive Directors namely, Mr. Lo Wa Kei Roy, Mr. Leung Ka Fai Nelson and Mr. Qin Fen has entered into a service contract with the Company for a fixed term unless terminated by not less than three months' notice (except Mr. Qin Fen with one month's notice) in writing served by either party on the other. The independent non-executive Directors are subject to retirement by rotation and re-election at the annual general meeting of the Company ("**AGM**") in accordance with the articles of association of the Company (the "**Articles**").

At each AGM, one-third of the Directors are required to retire from office. Each Director shall retire from office once every three years. The Directors to be retired in every year shall be those appointed by the Board during the year and those who have been longest in office since their last election or re-election. Mr. Fong Hon Hung, Mr. Lo Wa Kei Roy and Mr. Leung Ka Fai Nelson will retire from office as Directors at the forthcoming AGM pursuant to Article 108 of the Articles, and being eligible, offer themselves for reelection at the AGM.

New Directors appointed by the Board during the year shall retire and submit themselves for re-election at the AGM immediately following their appointments. Mr. Qin Fen will retire from office as Director at the forthcoming AGM of the Company, being eligible, offer himself for re-election pursuant to Article 112 of the Articles. BOARD RESPONSIBILITIES AND DELEGATION

The Board is responsible to the Shareholders for leadership and control of the Group and be collectively responsible for promoting the success of the Group by directing and supervising the Group's affairs. The Board focuses on formulating the Group's overall strategies, approving the annual development plan and budget; monitoring financial and operating performance; reviewing the effectiveness of the internal control and risk management system and supervising and managing the management's performance.

Regarding the Group's corporate governance, during the Reporting Period, the Board has performed the following duties in accordance with the terms of reference:

- determined and reviewed the policies and practices on corporate governance of the Group and make recommendations;
- reviewed and monitored the training and continuous professional development of the Directors and senior management;

The Board gives clear directions to the management as to the matters that must be approved by the Board before decisions are made on behalf of the Group by the management. In addition, the Board has also delegated various responsibilities to the board committees of the Company (the "**Board Committee**").

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Under code provision A.2.1 of the Code, the roles of chairman and chief executive officer should be separated and should not be performed by the same individual. Since 7 September 2018 and up to the date of this report, Mr. Fong Hon Hung serves as both the Chairman and chief executive officer ("CEO") of the Company. However, after evaluation of the current situation of the Group and taking into account of the experience and past performance of Mr. Fong, the Board believes that it is appropriate and in the best interest of the Company at the present stage for vesting the roles of the Chairman and the CEO of the Company in the same person as it helps to facilitate the execution of the Group's business strategies and maximizes the effectiveness of its operation. In addition, there are various experienced individuals in charge of the daily business and the Board comprises four executive Directors and three independent non-executive Directors with the balance of skills and experience appropriate for the Group's further development. The Board will nevertheless review this structure from time to time and will consider the segregation of the two roles at the appropriate time.

The Company has adopted the Model Code as the code of conduct of the Company regarding directors' transactions of the listed securities of the Company.

The Company has made specific enquiry to all Directors, and all Directors confirmed that they have complied with the Model Code and its code of conduct during the Reporting Period.

DIRECTORS' CONTINUING PROFESSIONAL DEVELOPMENT PROGRAMME

All Directors confirmed that they have complied with code provision A.6.5 of the Code during the Reporting Period that all Directors have participated in continuous professional development to develop and refresh their knowledge and skills. The Company has arranged an inhouse training on the Listing Rules in the form of a seminar during the Reporting Period conducted by the legal advisor as to Hong Kong laws and relevant training materials were distributed to all the Directors. All Directors attended the in-house training. The training covered topics including the Code, listed company regulations and disclosure obligations in Hong Kong, disclosable transactions and connected transactions, etc.

BOARD COMMITTEES

The Board has established the (i) audit committee (the "Audit Committee"), (ii) remuneration committee (the "Remuneration Committee"), and (iii) the nomination committee (the "Nomination Committee") with defined terms of reference. The terms of reference of each of the Board Committees, which explain their respective roles and authority delegated to them by the Board, are available on the websites of the Company and the Stock Exchange. In addition to the abovementioned committees, a legal compliance committee (the "Legal Compliance Committee") was established by the Board on 9 May 2015. The Board Committees are provided with sufficient resources to discharge their duties and upon reasonable requests, are able to seek independent professional advice and other assistance under appropriate circumstances, at the Company's expenses.

AUDIT COMMITTEE

The Company has established the Audit Committee on 9 May 2015 with written terms of reference in compliance with Rule 3.21 of the Listing Rules and paragraph C3 of the Code. The Audit Committee currently consists of three independent non-executive Directors, namely, Mr. Lo Wa Kei Roy, Mr. Leung Ka Fai Nelson and Mr. Qin Fen, with Mr. Lo Wa Kei Roy being the chairman of the Audit Committee.

The primary duties of the Audit Committee are, inter alia, to assist the Board in providing an independent view of the effectiveness of the financial reporting system, internal control procedures and risk management control systems, to oversee the audit process and to perform other duties and responsibilities as assigned by the Board. During the Reporting Period, the Audit Committee has reviewed with the management on the Group's unaudited interim results, audited annual results, the consolidated financial statements and this report.

董事會多元化政策

本公司自上市日期起直至本企業管治報告日期均 有採納董事會成員多元化政策(「**董事會多元化政** 策」)。本董事會多元化政策的概要連同為執行董事 會多元化政策而制定的可計量目標以及達標進度 披露如下。

The Company recognised the benefits of having a diverse Board to enhance the quality of its performance. The Board Diversity Policy aims to set out the approach to achieve diversity on the Board. In designing the Board's composition, the Board's diversity has been considered from a number of measurable aspects including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of services, all of which the Company considers to be important to enhance the quality of its performance. All Board appointments will be based on meritocracy and candidates will be considered against objective criteria, having due regards for the benefits of diversity on the Board.

The Nomination Committee will monitor the implementation of the Board Diversity Policy and recommend any proposed changes to the Board for approval. The Nomination Committee will from time to time review the Board Diversity Policy as appropriate to ensure its effectiveness.

At the date of this report, the Board comprises 7 Directors, amongst which three of them are under 32 years old. Further, members of the Board have a variety of education backgrounds, including holding bachelor and/or master degrees in the science, law, financial management as well as the business administration fields. Most of the members also possess various finance-related experiences. The composition of the Board reflects the necessary balance of skills, professional experience and knowledge for an effective leadership of the Company.

determine the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, and to ensure that the Group establishes and maintains appropriate and effective risk management and internal control systems. However, risk-taking is an unavoidable necessity and an accepted part of the Company's business while effective risk management is an integral part to present competitive advantages and ensure the Company achieves its strategic and business objectives. The risk management and internal control systems are designed to manage rather than eliminate the risk of failing to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatements or losses.

Risk Management

CONTROL

Risk management applies to all aspects of the Group's business and is a critical component in developing strategic plans, preparing operational plans and budgets, approving investment projects and managing project plans.

Risks are evaluated by the Board and management based on the severity of impact on the Company and the probability of risk occurring.

Based on the risk evaluation, the Group will manage the risks as follows:

• Risk elimination: management may identify and implement certain changes or controls that in effect eliminate the risk entirely.

- Risk mitigation: management may implement a risk mitigation plan designed to reduce the likelihood and/ or severity of impact to an acceptable level.
- Risk acceptance: management may decide that the risk rating is acceptable for the Company meanwhile and no action is thus required. However, the risk would continue to be monitored to ensure the level of risk does not increase to an unacceptable level.

Controls and Reviews

Policies and procedures are in place to ensure that the relevant management directives are carried out and actions that may be needed to address risks are taken. These may include approvals, verifications, reviews, safeguarding of assets and segregation of duties.

Control activities can be divided into operations, financial reporting and compliance, although there may, on occasion, be some overlaps between them. The typical control activities adopted by the Group include:

- analytical reviews: such as conducting reviews of actual performance against prior periods;
- direct functional or activity management: review of performance reports;
- physical controls: ensuring equipment, inventories and other assets are safeguarded and subject to periodic checks; and
- segregation of duties: dividing and segregating duties among different people, with a view to strengthening checks and minimizing the risk of errors and abuse.

- closely communicates and seeks advice from its legal advisor in assessing the likely impact of any unexpected and significant event that may impact the price of the Shares or their trading volume, and to determine whether the relevant information is considered inside information that needs to be disclosed as soon as reasonably practicable pursuant to the SFO and the Listing Rules;
- has included in its Corporate Code of Conduct a strict prohibition on the unauthorized use of confidential or inside information; and
- ensures, through its own internal reporting process and the consideration of their outcome by senior management, the appropriate handling and dissemination of inside information.

Assessing the Effectiveness of Risk Management and Internal Control Systems

The Board, via the Audit Committee, is responsible for the review and assessment of the major risks the Group faces and the review, approval and monitoring of the Group's response to such risks annually.

The Audit Committee oversees the risk management process and reviews the effectiveness of the risk management and internal control systems by performing the following procedures:

- Review with management annually those reports on compliance with the risk management policy;
- Discuss with management annually on the Group's major risks and the steps management has taken since then or should take to address and deal with such risks; and
- Review the effectiveness of the Group's risk management practices.

Management is responsible for ensuring the Group's business operations are being conducted in line with our risk management policy, taking into consideration changes in external environment and the Group's risk tolerance level.

In addition to the Board's oversight, the Group has developed a risk management process to identify, evaluate and manage significant risks and to remediate material internal control deficiencies (if any). Management, through the engagement of the independent internal control and risk advisory team, is responsible for the annual risk reporting process. The independent internal control and risk advisory team meets with members of the senior management to review and assess risks and discuss remedial measures to address material internal control deficiencies (if any), including any changes relevant to a given year. Risks are compiled, ratings assigned and migration plans documented. The risk assessment is reviewed by management and presented to the Audit Committee and the Board for their review.

The Group has in place effective processes and systems for the identification, capture and reporting of operational, financial and compliance-related information in a form and timeframe intended to ensure that staff carry out their designated responsibilities.

Risk Management and Internal Control Process

On behalf of the Board, the Audit Committee reviews annually the continuous effectiveness of the Group's risk management and internal control systems dealing with risk and financial accounting and reporting, the effectiveness and efficiency of operations, compliance with laws and regulations, and risk management functions.

The assessment considers:

- the scope and quality of management's ongoing monitoring of risks and of the risk management and internal control systems;
- the extent and frequency with which the results of monitoring are communicated, enabling the Committee to build up a cumulative assessment of the state of control in the Group and the effectiveness with which risk is being managed;
- the incidence of any significant control failings or weaknesses that have been identified at any time during the period and the extent to which they have resulted in unforeseen outcomes or contingencies that have had, could have had, or may in the future have, a material impact on the Group's financial performance or condition;
- the effectiveness of the Group's processes in relation to financial reporting and statutory and regulatory compliance;
- areas of risk identified by management;

The Group has engaged an independent internal control and risk advisory team, ZHONGHUI ANDA Risk Services Limited, which has assisted in monitoring the corporate governance of the Group and providing an objective assessment to the Board on whether a sound internal control system is maintained and operated by management.

The internal control and risk advisory team conducted a review on a number of corporate governance areas and business cycles and provided recommendations for the improvement and strengthening of the internal control system. No significant control finding or weakness has been identified by the internal control and risk advisory team. The Audit Committee reviews the findings and recommendations of the internal control and risk advisory team on the effectiveness of the Group's internal control system and reports to the Board on such reviews.

- the Group's actual and expected financial performance;
- the liquidity position and capital requirements of the Group;
- retained earnings and distributable reserves of the Company and each of the members of the Group; and
- any other factors that the Board may consider appropriate.

The declaration and payment of dividend by the Company are also subject to restrictions under the applicable laws and the memorandum and articles of association of the Company.

For the avoidance of doubt, there can be no assurance that a dividend will be proposed or declared in any specific period.

The Board would review the Company's dividend policy from time to time considering factors including but not limited to capital investment and business plan.

All Directors have easy access to the Company Secretary and the responsibility of the Company Secretary is to ensure the Board meetings are properly held and are in compliance with the relevant laws and regulations. The Company Secretary is also responsible for giving advices with respect to the Directors' obligations on securities interest disclosure, disclosure requirements of disclosable transactions, connected transactions and inside information.

The Company Secretary, Ms. Wong Kit Ying, had taken no less than 15 hours of relevant professional training during the Reporting Period.

GENERAL MEETINGS WITH SHAREHOLDERS

SHAREHOLDERS' RIGHTS

Procedures for Convening General Meetings by Shareholders

Pursuant to Article 64 of the Articles, the Board may whenever it thinks fit call extraordinary general meetings.

Extraordinary general meetings shall also be convened on the requisition of one or more Shareholders holding, at the date of deposit of the requisition, not less than one-tenth of the paid-up capital of the Company having the right to vote at general meetings.

Such requisition shall be made in writing to the Board or the Company Secretary by mail at Room 1802, 18th Floor, Capital Centre, No. 151 Gloucester Road, Wanchai, Hong Kong for the purpose of requiring an extraordinary general meeting to be called by the Board for the transaction of any business specified in such requisition. Such meeting shall be held within 2 months after the deposit of such requisition. If within 21 days of such deposit, the Board fails to proceed to convene such meeting, the requisitionist(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

Procedures for Putting Forward Proposals at Shareholders' Meeting

Shareholders are requested to follow Article 64 of the Articles for including a resolution at an extraordinary general meeting. The requirements and procedures are set out above in the paragraph headed "Procedures for Convening General Meetings by Shareholders".

ABOUT THIS REPORT

This report was prepared for an overview of the performance of the Group on environmental, social and governance ("**ESG Report**"). This ESG Report has been prepared in accordance with the "Environmental, Social and Governance Reporting Guide" (the "**ESG Reporting Guide**") as set out in Appendix 27 of the Main Board Listing Rules of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**").

Unless otherwise stated, the ESG Report covers the overall performances, risks, strategies, measures and commitments of the Group in environmental, social, and governance areas for the year ended 31 March 2019 ("**YR2019**").

During the YR2019, the Group is principally engaged in providing foundation construction, ground investigation services and financial services in Hong Kong. The foundation construction is its major business, which mainly consists of the construction of socketed H-piles, mini piles, soldier piles, pipe piles and king posts. The Group conducts foundation construction through Wan Kei Geotechnical Engineering Company Limited and ground investigation services through Chun Shun Boring Engineering Company Limited. Therefore, the ESG Report will mainly focus on the above businesses.

For the Group's corporate governance practice information, please refer to the corporate governance report on pages 28 to 57 of this annual report.



ENVIRONMENTAL PROTECTION

The Group is engaged in foundation construction and ground investigation services, which may inevitably produce exhaust gas, greenhouse gas, dust, sewage, noises and other emissions. However, the Group has implemented detailed internal codes, and made clear guidelines on management of site environment, control on emissions, and even management of office environment, in an effort to minimise the impacts of its daily operation on the environment.

As a recognition to the Group's environment policies, its environmental management system concerning the design, supply and installation of the rock-socketed steel H-pile in pre-bored hole and mini pile work, has been identified to be in compliance with ISO 14001: 2015 after the assessment since 2007. The Group has been granted the OHSAS 18001:2007 Certification of Environment Management System by Accredited Certification International Limited, the Best Safety and Environment Protection Subcontractor Award by customers and the Onsite Best Safety and Environmental Subcontractor Award by customers, all of which prove the Group's endeavour in promoting environmentally responsible practices.

1. Emissions

Air Pollution – Exhaust Gas and Greenhouse Gas Emissions

Greenhouse gas emissions ("GHG Emission") from daily business activities mainly represent direct exhaust emissions from construction machineries and transport vehicles while carrying out projects, as well as electricity and paper consumption in office and warehouse. The Group has issued specific internal guidance for regulating and monitoring the GHG Emissions and exhaust emissions during the daily operation, including the construction process and environment management on the site, turning off all idle construction machineries and strictly enforcing "Switch off Idling Vehicles", as well as reminding staff to turn off all electric appliances while leaving the working place.

環保

本集團從事地基建築及土地勘測服務,過程中 難免會產生廢氣、溫室氣體、粉塵、污水以及噪 音及其他排放物。然而,本集團已訂立詳細的 內部守則,對工地環境管理、排放物控制,甚至 辦公室環境管理等均有明確指引,以減少其日 常營運過程中對環境的影響。

作為對本集團環境政策的認可,其有關設計、 供應及安裝預鑽孔嵌岩式工字鋼樁及微型樁工 程的環保管理系統已自二零零七年經評估並認 證為符合ISO 14001:2015要求。本集團亦先 後獲國際認可認証有限公司授予環境管理體系 的OHSAS 18001:2007認證、獲客戶授予最佳 安全及環保分包商嘉許獎狀,以及獲客戶授予 施工現場最安全最環保分包商稱號,足以證明 本集團推動環保所作出的努力。

1. 排放物

空氣污染-廢氣及溫室氣體排放

日常經營活動產生的溫室氣體排放(「**溫室氣** 體排放」)主要為項目施工時各類施工機械及運 輸車輛的直接廢氣排放,以及來自辦公室和貨 倉電力、紙張等消耗。本集團已對規管及監察 日常經營活動中的溫室氣體排放、廢氣排放發 出明確內部指引,包括工地施工流程及環境管 理、要求關掉所有閒置的施工機械及嚴格執行 「停車熄匙」,以及發通告提示員工離開工作環 境前關掉所有電器等。 The Group has complied with the Air Pollution Control Ordinance and other regulations promulgated by governments and currently applicable to the Group, as well as environmental requirements of contractor. All machineries, including leased machineries, used on the site shall obtain approval or exemption from the Environmental Protection Administration, and shall not be used on the site until the approval label or exemption label being attached. Those machineries consume ultra-low-sulfur diesel to reduce the emission of suspended particles effectively.

In addition, the Group maintains and repairs machineries, equipment and vehicles on regular basis, with a view to prevent them from generating excess emissions of exhaust caused by broken parts and other reasons, and to facilitate the reduction of fuel consumption. 本集團遵循《空氣污染管制條例》等現時政府 所頒佈且適用於本集團之規例,以及遵守承建 商之環保要求。地盤所用之機械(包括租賃機 械)均須獲環保署的核准或豁免,並附有由環 保署發出的核准標籤或豁免標籤,才可於工地 使用。這些機械均使用超低硫柴油,有效減少 懸浮粒子排放。

此外,本集團會定期保養及維修機器、設備及 車輛,預防它們因零件破損等原因而排放過量 廢氣,並有助減少耗油量。

- Scope 1: Direct GHG emissions from gasoline consumption by the Group.
- Scope 2: Indirect GHG emissions resulting from electricity consumption by the Group.
- Scope 3: Other indirect GHG emissions include emission from business travel by air by employees and emission from electricity consumption for processing fresh water and sewage.

Air Pollution – Dust

Dust is generated during construction work. Dust emissions can mainly be attributed to wind and kinesis. Construction materials such as sand and cement stored outdoor as well as the dust of the exposed construction area are easily scattered in dry and windy weather. In addition, dust is generated by external force in particular the construction trucks and machineries during the process of excavation and soil loosening.

In compliance with the Air Pollution Control Ordinance, the Group controls the emission of air pollutants by following the Group's internal guidance. It covers all vehicles carrying sand and other scraps completely with canvas to ensure that no large amount of dust is generated during transportation. In order to prevent dust spreading around, the Group installs water sprinklers on the sites to clean tires of construction vehicles while entering into or leaving the sites and roads.

空氣污染-揚塵

項目施工時產生揚塵。造成揚塵的原因可分為 風力起塵和動力起塵,其中風力起塵主要由於 天氣乾燥及大風吹起露天堆放的建材(如黃 沙、水泥等)及暴露的施工區表層浮塵;而動力 起塵,主要是在建材的裝卸、攪拌過程中,由於 外力而產生的塵粒再懸浮而造成,其中施工及 裝卸車輛造成的揚塵最為嚴重。

因此,本集團遵循《空氣污染管制條例》,根據 本集團的內部指引,控制工程所產生的空氣污 染物。本集團會利用帆布完全遮蓋所有運載砂 石等廢料的車輛,確保這些車輛不會於運載過 程中製造大量揚塵。本集團已安裝灑水器,為 進入或離開工地或道路的施工車輛清洗輪胎, 避免製造泥塵。

Hazardous and Non-hazardous Waste Treatment

Waste from daily operation includes general inert waste and non-inert construction materials from construction works. The Group manages waste from the site in accordance with the internal waste management guidance and the Waste Disposal Ordinance. In general, the Group categorises the waste from construction works. General inert waste from work, such as rocks, if applicable, shall be reused as filling materials at the site or collected by professional contractors as reclamation materials in the future. Other waste that is not applicable for recycle or reuse shall be discarded to the public dumping area. Metal and chemical waste within the site shall be collected and discarded by licensed contractors. All waste shall be well disposed before being removed from the site.

In respect of office waste, apart from dumping waste at the designated place in line with the requirements of the property management office of the office premise, the Group also categorises the waste and engages a contractor to collect toner cartridge. Meanwhile, the Group regularly monitors the consumption of paper, toner cartridges and ink cartridges.

有害及無害廢棄物處理

日常經營活動產生的廢棄物主要包括工程中 產生的一般惰性廢物及非惰性建築物料。本集 團根據內部廢棄物管理指引以及《廢物處置條 例》,管理工地廢物。一般而言,本集團會將 工程產生的廢棄物分類。工程中的一般惰性廢 物,例如石塊等,如適用,我們會重用作為地盤 填土物料,或交由專業承辦商回收作日後填海 物料之用途;對於其他廢棄物,如不適合回收 再用或再造,我們會運往公眾堆填區棄置。工 地內的金屬及化學廢料由專業承辦商回收及棄 置。所有的廢棄物於運離工地前,均會妥善放 置。

辦公室廢物方面,除了根據辦公室大廈管業處 要求,將一般垃圾棄置於指定地方外,本集團亦 會進行垃圾分類,並委聘承辦商回收碳粉盒。 同時,本集團定期監察紙張、碳粉盒及墨盒等 的消耗情況。

Sewage Discharge

The Group has complied with the Water Pollution Control Ordinance. Water consumed at the site shall be discharged to the designated environmental treatment facility in accordance with the instruction of the contractors before being discharged outside the site. The Group shall deploy adequate manholes and deposition pools in line with seasons, with an aim to mitigate the water pollution caused by garbage, oil or other materials.

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to environmental protection and pollutant emissions. During the YR2019, the Group is not aware of any material non-compliance with the Air Pollution Control Ordinance, the Waste Disposal Ordinance and other relevant laws and regulations relating to air and GHG emissions, discharges into water and land, and generation of hazardous and non-hazardous waste that would have significant impact on the environment. In addition, there was no report of significant fines or sanctions as a result of non-compliance with the relevant laws and regulations in the YR2019.

污水排放

2. Use of Resources

The Group encourages its staff to make good use of resources, and issues internal notice to all of the staff, requiring them to save energy and reduce consumption:

- Turn off all the air conditioners and lighting systems before leaving the working environment;
- Use LED lighting in the office;
- Maintain the indoor temperature at 25 degrees Celsius in the office;
- Use recycled paper and double-sided printing as well as old envelops for internal documents or non-important/unclassified documents;
- Use electronic documents such as email as possible and reduce paper usage;
- Reduce the use of disposable goods and reuse office stationery;
- Make use of telephone/video conferencing equipment to avoid unnecessary business travelling.

The Group considers water resources to be quite valuable and the Group is committed to promoting the concept of saving water. There is a wide range of water use at construction sites. Although the water supply facilities at the sites are provided by the contractors, the Group calls on the construction workers from time to time not to waste water. 3. The Environment and Natural Resource

Noise Management

As certain procedures would produce noises during the construction, which cause impacts to the residents nearby, the Group adopts necessary measures to minimize noises in compliance with the Noise Control Ordinance. The Group conducts construction during designated time (e.g. 7 a.m. to 7 p.m. on normal working days) and applies for Noise Control Permit (NCP) for certain works or construction ways.

The Group would set noise barriers or noise enclosure at the early stage during construction period to suppress the noise level.

Enhancing Environmental Awareness

The Group actively enhances the environmental awareness of its staff in addition to enhancing environmental measures, including issuing of internal environmental guidance and sharing of relevant environmental information in relation to green office.

SOCIETY

Employment and Labour Practices

1. Employment

Employment Policy

The Group has established a series of internal policies related to employment according to the guidance under Hong Kong Employment Ordinance, industry features and practices to ensure that its employees are provided with equal promotion opportunity and other packages, such as minimum wage security, maximum working hours, compensatory leave, mandatory provident fund or pension security and rewards for long-term services.

In general, subsidiaries of the Group would make proper upward or downward adjustment to the number of existing staff in the recruitment process based on the scale and actual situation or progress of the existing sites and the sites awarded. As all employees on the sites are paid on a daily basis, the employee turnover is relatively at a high level.

As general foundation construction and ground investigation services involve certain high-risk activities, only staff possessed of the Construction Industry Safety Training Certificate can carry out related work on the site.

Besides, as our subsidiaries engage in construction business, they will also subcontract some projects to other subcontractors. In order to ensure that the employees of the subcontractors could receive reasonable wages, we usually pay the wages to such employees responsible for relevant projects on behalf of the subcontractors.

During the YR2019, the Group did not involve any illegal activities related to employment that had caused material impact on the Group.

社會

僱傭及勞工慣例

1. 僱傭

僱傭政策

本集團根據香港《僱傭條例》指引、行業特性 和慣例制訂一系列僱傭相關內部政策,確保員 工獲得平等晉升機會及其他待遇,如最低工資 保障、最高工時、補假、強積金或退休保障、長 期服務獎勵等。

一般情況下,本集團旗下附屬公司,在招聘過程 中會視乎現有地盤及中標地盤之規模及實際情 況或進度,適當的增聘或減少現有員工數目。 由於所有工地員工均為日薪員工,故僱員流動 性相對較大。

由於日常地基建築及土地勘測服務涉及部分高 危活動,只有持有建造業安全訓練証明書的員 工方可在工地進行有關工作。

另外,我們的附屬公司由於從事建築業務,亦 會分判部份工程予其他分包商。為確保分包商 員工可取得合理薪金,我們通常代分包商向員 工發放其所負責相關項目之薪金。

於二零一九年度,本集團並無牽涉任何有關僱 傭且對本集團構成重大影響的違法活動。

Equal Opportunity and Diversity Policy

The Group's principal businesses are foundation construction and ground investigation services, which demand plenty of physical labour force, hence traditionally male employees are a majority in the workforce of construction business.

The Group is impartial in choosing its employees, and has gradually established and improved its recruitment mechanism. Recruitment of employees is based on their work experience, techniques and skills, work performance. The Group does not discriminate our employees on the basis of their gender, age, origin, nationality, race, religious belief, sexual orientation, physical disability, marital status and so on.

Staff Communication

The Group places high priority on staff communication through various activities and channels, by which it can understand its staff's needs and strengthen our relationship. In some traditional Chinese festivals, such as Chinese New Year Eve, the Company organised New Year Eve's dinner for all staff in order to create a harmonious and friendly working atmosphere and strengthen communication with staff.

Dismissal

The Group complies with the guidance under Hong Kong Employment Ordinance. If terminating the employment of staff, the Group will follow the process to make reasonable compensation to the dismissed employees. The relevant provisions on termination of the employment relationship are set out in the employment contracts of every employee.

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to employment during the course of operation. During the YR2019, the Group is not aware of any material non-compliance with the Employment Ordinance and other relevant laws and regulations relating to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination and other benefits and welfare in Hong Kong. In addition, there was no report of significant fines or sanctions as a result of non-compliance with the relevant laws and regulations in the YR2019.

2. Health and Work Safety

Occupational Safety

The Group cares about the health and well-being of our employees. Due to the nature of its businesses, some employees have to operate a variety of large machines during daily work, which involves certain safety risk. As such, the Group implemented various safety measures to ensure the occupational safety of the employees.

All employees who perform engineering operation must undergo mandatory basic safety training. Only those awarded with the Construction Industry Safety Training Certificate, commonly known as the "Green Card", can be employed to carry out related work on the site. In order to enhance site safety supervision and staff's safety awareness, the Group has also engaged professional safety consultants to conduct inspection on site safety so as to rectify site safety problems immediately and reduce the occurrence of industrial injury incidents. The Group's professional safety consultants also regularly provide certain safety courses and guidelines on site safety for site staff and supervisors.

As there are many machinery and other equipment in the construction sites, employees will be more prone to industrial accidents. The Group strictly requires workers to wear safety protection equipment such as safety helmets and obey the safety guidelines of contractors and the Group. 本集團嚴格規管其業務營運,以確保於營運過 程中遵守與僱傭相關的當地法律及法規。於二 零一九年度,本集團概無知悉在香港有任何嚴 重違反《僱傭條例》及與補償及解僱、招聘及 晉升、工作時數、休息時間、平等機會、多元 化、反歧視及其他待遇和福利有關的其他相關 法律及法規的情況。此外,於二零一九年度,並 無因違反相關法律及法規而招致重大罰款或制 裁的報告。

2. 健康及工作安全

工作安全

本集團關注僱員的健康與福祉,由於本集團業務性質,部分僱員在日常工作中需要操作各類 大型機械,其中存在一定安全風險。因此,本集 團已實施多項安全措施,以確保僱員的工作安 全。

所有參與工程作業的僱員均須接受強制性基本 安全訓練。僅獲發建造業安全訓練證明書(俗 稱「綠咭」)的人員方可受僱在地盤開展相關工 作。為加強地盤安全監督及僱員的安全意識, 本集團亦已委聘專業安全顧問負責檢查地盤安 全,以便即時糾正地盤安全問題,減少工傷事 故的發生。本集團的專業安全顧問亦會定期向 地盤人員及監工提供若干關於地盤安全的安全 課程及指引。

由於建造地盤有眾多機械及其他設備,僱員更 易發生工傷事故。本集團嚴格要求工人佩戴安 全帽等防護設備,以及遵守承建商及本集團的 安全指引。

Physical and mental health

Apart from daily work, the Group encourages employees to participate in various types of outdoor activities which benefit to the body fitness and mind and keep healthy to promote the physical and mental development of employees and maintain a work-life balance.

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to health and safety during the course of operation. In YR2019, there was no case of material non-compliance with the Occupational Safety and Health Ordinance (Chapter 509 of the Laws of Hong Kong) and the relevant laws and regulations relating to providing a safe working environment and protecting employees from occupational hazards that have a significant impact in Hong Kong. In addition, there was no record significant safety accidents and occupational injuries, nor did it have any events regarding safe working environment and protecting employees from occupational hazards; and no violation of health and safety laws and regulations was found in YR2019.

3. Development and Training

The Group actively attracts and retains talents, and trains employees who have the potential to become managers in the long run. Therefore, the Group encourages its employees to receive further education in relation to the development needs of the Group and make good use of their talents to achieve their career goals. The Group offers sufficient internal promotion opportunities to its employees. The Group promotes its staff based on their staff performance evaluation results. The Group's senior management has extensive experience in the industry and will actively share their knowledge to facilitate the development of our employees. Employees may also communicate with and seek professional advice from their department heads on their personal career development planning.

身心健康

除日常工作以外,本集團鼓勵僱員參與各類有 益身心的戶外活動,注意健康,促進僱員身心 發展,保持工作及生活平衡。

All staff on the construction site are required to attend site safety lectures organised by the contractor that last for half a day to one and a half days depending on requirements of such contractor. The Group has also asked staff to attend lectures on construction site safety and crisis training organised by professionals.

The Group has appointed professionals to provide its Directors and senior management with trainings on various aspects such as the Listing Rules and corporate governance.

4. Labour Standards

The Group rigidly complies with all relevant labour standards in Hong Kong and actively protects the basic personal rights and interests of its employees, ensuring that they work in a fair environment and are respected. The Group strictly forbids unlawful acts such as child and forced labour. In order to combat illegal employment of child and forced labour, the Human Resources Department of the Group requires job seekers to provide valid identification before confirming employment to ensure that applicants can be employed in accordance with the law.

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to labour standards during the course of operation. In YR2019, there was no case of material non-compliance with the Employment Ordinance and the relevant laws and regulations relating to preventing child or forced labour in Hong Kong. In addition, the Group did not employ child and forced labour, nor did it record any cases of discrimination involving race, religion, age or disability in YR2019. 所有建造地盤員工均需參加由承建商舉辦的為 期半天至一天半(視相關承建商的要求而定) 的地盤安全講座。本集團亦要求員工參加由專 業人士組織的建造地盤安全講座及危機培訓。

本集團已聘請專業人士為董事及高級管理層提供關於上市規則及企業管治等各方面的培訓。

4. 勞工準則

本集團嚴格遵守香港的所有相關勞工準則, 積極保障僱員的基本個人權益,確保僱員在公 平、受尊重的環境中工作。本集團嚴禁童工及 強制勞工等非法行為。為防止非法僱用童工及 強制勞工情況的發生,本集團人力資源部門在 確認僱傭前,會要求求職者提供有效的身份證 明,以確保可依法僱用申請人。

本集團嚴格規範自身業務經營,確保經營過程 中遵守與勞工準則相關的本地法例及規例。於 二零一九年度,概無發生就《僱傭條例》及香 港關於禁止童工及強迫勞工的相關法例及規例 的重大不合規情況。此外,於二零一九年度,本 集團未僱用童工及強迫勞工,亦未發生任何涉 及種族、宗教、年齡、殘疾的歧視案件。

OPERATING PRACTICE

5. Supply Chain Management

The Group has a total of 181 suppliers, mainly including subcontractors and material suppliers which are Hong Kong based companies. There was no major change in the regional ratio during the year.

The Group has long-term relationships and mutual trust with its major suppliers (including subcontractors, material suppliers, etc.) based on long term cooperation and mutual trust, and all of them have been our material suppliers for more than a decade. As the Group's businesses are based in Hong Kong, it chooses to purchase from suppliers in Hong Kong to save transportation costs.

In addition to geographical factors, the Group chooses and evaluates its suppliers based on their professional qualifications, product quality, service capabilities and pricing, etc. and in accordance with our procurement policy. Furthermore, the Group strictly stipulated that all purchase orders on materials are placed by the office's purchaser, and purchase orders must be signed by Directors to be valid.

6. Product Responsibility

Product quality

The Group has been engaged in foundation construction and ground investigation services for over a decade and has completed hundreds of projects one after another. The Group is widely recognised and highly praised by its clients as it focuses on service quality and is committed to providing its clients with top-tier service portfolio. To meet the demand of its clients, the Group has developed its internal management system and closely monitored its project execution process, with an aim to render premium and reliable service to its clients.

營運慣例

5. 供應鏈管理

本集團共有181名供應商,主要為分包商及材料 供應商。分包商及材料供應商均為香港公司。 年內地區比例並沒有重大改變。

本集團與主要供應商(包括分包商、材料供應 商等)均建有長期合作關係及互信基礎,主要供 應商均為本集團提供材料超過10年。由於本集 團之業務均在香港,因此,為節省運輸成本,我 們選擇向香港的供應商採購。

除了地理因素,本集團會根據採購政策考慮供 應商的專業資質、產品質量、服務能力、價格等 進行篩選與評估。此外,本集團嚴格規定所有 物料採購均由辦公室之採購員負責落單,而採 購單均須由董事簽字方為有效。

6. 產品責任

產品質量

本集團在提供地基建築及現場土地勘測服務已 逾10年,先後完成數百個項目。本集團獲得客 戶廣泛支持和認可,主要由於我們重視服務質 素,致力為客戶提供優質服務組合。本集團以 滿足客戶需求為目標,建立內部管理體系,嚴 格管理項目執行流程,為客戶提供優質、可靠 的服務。

All foundation construction and ground investigation services provided by the Group shall be verified by the contractor or surveyor, and the Group believes that this will also help enhance its clients' confidence on and recognition of its services. The Group's quality control system on the design, supply and installation of Rocksocketed Steel H-pile in Pre-bored Hole and Minipile work has been accredited with ISO9001:2015 certification of quality management system by Accredited Certification International Limited. During the YR2019, the Group received no complaints or claims from our customers arising from the quality issues of the work performed by the Group or sub-contractors, which in the view of Directors, is attributable to the effective quality control measures.

Policies of privacy

The Group acts as a provider of money lending services and has access to personal data of its customers, hence ensuring privacy of its customers' information is one of the most important issues. The Group attaches great attention to the protection of privacy and intellectual property. The Group ensures that all the business data of its customers which may be accessible will be properly dealt with by its staff and will not be used or leaked without authorisation.

Communication with customers

The Group actively communicates with its customers to understand their needs and their feedbacks on the services provided by the Group. In the event that the Group's projects could not reach the requirements and expectation of the customers, the Group will actively cooperate with the customers and make some remedies so as to satisfy the requirements of the contractors or surveyors. 本集團所提供的地基建築及土地勘測服務均 須由承建商或測量師驗證,而本集團相信此舉 亦有助提升客戶對我們服務的信心及認可。 本集團有關設計、供應及安裝預鑽孔嵌岩式 工字鋼樁及微型樁工程的質量管理體系已獲 國際認可認証有限公司授予品質管理體系的 ISO9001:2015。於二零一九年度,本集團概 無由於與本集團或再分包商完成的工程有關的 品質問題而接獲客戶的任何投訴或任何賠償要 求,而董事將之歸功於有效的品質控制措施。

客戶溝通

Credit approval policy

Money Lending Policy adopted by the Group has been designed to ensure that the Group's business operates in accordance with the Money Lenders Ordinance (Cap. 163, Laws of Hong Kong). The Group will regularly monitor, review and, when necessary, update the existing policy to ensure the money lending business is strictly in compliance with the Money Lenders Ordinance (Cap. 163, Laws of Hong Kong).

The Group is not aware of any material non-compliance with the Personal Data (Privacy) Ordinance (Cap. 486, Laws of Hong Kong), the Trade Descriptions Ordinance, the Money Lenders Ordinance (Cap. 163, Laws of Hong Kong) and other applicable laws and regulations that have a significant impact relating to advertising, labelling and privacy matters relating to products and services provided by the Group in Hong Kong in YR2019.

7. Anti-Corruption

The Group and its subsidiaries all strictly adhere to the Prevention of Bribery Ordinance promulgated by the Hong Kong SAR Government. The Group seeks to further review the customers' information through understanding customers' background by way of interview, thereby identifying and preventing the customers and employees from bribery, blackmail, fraud and money-laundering in any way. The Group will regularly review the implementation of relevant systems and put more resources in improving the mechanism, if necessary.

The Group has developed a Whistle-blowing Policy internally. Staff may report to relevant department managers or senior management in the event that they identify any irregularities, and the Group will protect the identity of the informer. The Group shall conduct detailed investigation on the reported event and take appropriate actions according to the result.

The Group has engaged an independent internal control and risk advisory team, which has assisted in monitoring the corporate governance of the Group and in providing an objective assessment to the Board on whether a sound internal control system is maintained and operated by management. The Group also engaged independent auditors to conduct external audit, in order to prevent and control the fraud or wrongdoings within the Group.

In addition, there was no report of significant fines or sanctions as a result of noncompliance with the relevant laws and regulations in YR2019.

Options granted to substantial Shareholders or independent non-executive Directors or any of their respective associates (including a discretionary trust whose discretionary objects include a substantial Shareholders. independent non-executive Directors, or any of their respective associates) in any 12-month period in excess of 0.1% of the Company's share capital or with a value in excess of HK\$ 5 million must be approved in advance by the Company's Shareholders.

Options granted must be taken up within seven days inclusive of the day on which such offer was made, upon payment of HK\$1 per option. Options may be exercised at any time during a period as the Directors may determine which shall not exceed ten years from the date of grant. The exercise price is determined by the Directors, and will be at least the higher of (i) the closing price of the Company's shares on the date of grant; (ii) the average closing price of the shares for the five business days immediately preceding the date of grant; and (iii) the nominal value of the Company's share.

1. GENERAL INFORMATION

Wan Kei Group Holdings Limited (the "**Company**") was incorporated in the Cayman Islands as an exempted company with limited liability on 7 October 2014 under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands.

The address of the Company's registered office is Clifton House, 75 Fort Street, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of the Company's principal place of business in Hong Kong is Room 1802, 18th Floor, Capital Centre, No. 151 Gloucester Road, Wanchai, Hong Kong. The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 15 to the consolidated financial statements.

2. SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("**HKFRSs**"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("**HKASs**") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited. A summary of the significant accounting policies adopted by the Group is set out below.

1. 一般資料

(a) 合規聲明

(a) Statement of compliance (Continued)

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 2(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

(b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 March 2019 comprise the Company and its subsidiaries (together referred to as the "**Group**").

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis, except certain assets and liabilities are stated at their fair value.

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

2. 重大會計政策(續)

(a) 合規聲明(續)

香港會計師公會已頒佈若干於本集團及本公司 當前會計期間首次生效或可供提早採納之新訂 及經修訂香港財務報告準則。附註2(c)就該等 綜合財務報表內所反映於當前及過往會計期間 首次應用該等與本集團有關之準則所導致會計 政策之任何變動提供資料。

(b) 財務報表的編製基準

截至二零一九年三月三十一日止年度之綜合財 務報表包括本公司及其附屬公司(統稱「**本集** 團」)。

編製綜合財務報表使用歷史成本基準作為計量 基準,惟若干資產及負債以公平值列賬。

編製符合香港財務報告準則之綜合財務報表需 要管理層作出判斷、估計及假設,而有關判斷、 估計及假設會影響會計政策的應用及資產、負 債、收入及支出之呈報數額。該等估計及相關 假設乃根據以往經驗及在有關情況下認為合理 的其他多種因素作出,而有關結果乃作為就該 等不可基於其他資料來源而顯易地得出的資產 及負債賬面值的判斷基準。實際結果可能會與 此等估計不同。

HKFRS 15 requires an entity to adjust the transaction price for the time value of money when a contract contains a significant financing component, regardless of whether the payments from customers are received significantly in advance of revenue recognition or significantly deferred.

Where payment schemes include a significant financing component, the transaction price is adjusted to separately account for this component. (d) **Basis of consolidation**

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company (i.e. its subsidiaries). If a subsidiary prepares its financial statements using accounting policies other than those adopted in the consolidated financial statements for like transactions and events in similar circumstances, appropriate adjustments are made to that subsidiary's financial statements in preparing the consolidated financial statements to ensure conformity with the Group's accounting policies.

Control is achieved where the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group's returns. When the Group has less than a majority of the voting rights of an investee, power over the investee may be obtained through: (i) a contractual arrangement with other vote holders; (ii) rights arising from other contractual arrangements; (iii) the Group's voting rights and potential voting rights; or (iv) a combination of the above, based on all relevant facts and circumstances.

The Company reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of these elements of control stated above.

Consolidation of a subsidiary begins when the Group obtains control of the subsidiary and cease when the Group loses control of the subsidiary.

Income and expenses of subsidiaries are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income of subsidiaries are attributed to the equity shareholders of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the equity shareholders of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group are eliminated in full on consolidation.

(e) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances, transactions and cash flows and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the non-controlling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests are presented as financial liabilities in the consolidated statement of financial position in accordance with notes 2(n) or (o) depending on the nature of the liability.

Changes in the Group's interests in a subsidiary that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling and non-controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

In the Company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 2(j)), unless the investment is classified as held for sale.

(f) Other investments in debt and equity securities

The Group's policies for investments in debt and equity securities, other than investments in subsidiaries, associates and joint ventures, are set out below.

Investments in debt and equity securities are recognised/ derecognised on the date the Group commits to purchase/ sell the investment. The investments are initially stated at fair value plus directly attributable transaction costs, except for those investments measured at fair value through profit or loss ("**FVPL**") for which transaction costs are recognised directly in profit or loss. For an explanation of how the Group determines fair value of financial instruments, see note 27(f). These investments are subsequently accounted for as follows.

Non-equity investments held by the Group are classified into one of the following measurement categories:

Property, plant and equipment is stated at cost less accumulated depreciation and impairment losses (see note 2(j)).

Gains or losses arising from the retirement or disposal of an item of property, plant and equipment are determined as the difference between the net disposal proceeds and the carrying amount of the item and are recognised in profit or loss on the date of retirement or disposal. Any related revaluation surplus is transferred from the revaluation reserve to retained profits and is not reclassified to profit or loss.

Depreciation is calculated to write off the cost or valuation of items of property, plant and equipment, less their estimated residual value, if any, using the straight line method over their estimated useful lives as follows:

•	Furniture and fixtures	3-5 years
•	Leasehold improvements	5 years

- Motor vehicles 5 years
- Machinery
 4-5 years

Where parts of an item of property, plant and equipment have different useful lives, the cost of the item is allocated on a reasonable basis between the parts and each part is depreciated separately. Both the useful life of an asset and its residual value, if any, are reviewed annually.

(h) Club memberships

Club memberships are stated in the consolidated statement of financial position at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses (see note 2(j)).

Amortisation of club memberships with finite useful life is charged to profit or loss on a straight-line basis over the assets' estimated useful lives. Both the period and method of amortisation are reviewed annually.

Club memberships are not amortised while their useful lives are assessed to be indefinite. Any conclusion that the useful life of an intangible asset is indefinite is reviewed annually to determine whether events and circumstances continue to support the indefinite useful life assessment for that asset. If they do not, the change in the useful life assessment from indefinite to finite is accounted for prospectively from the date of change and in accordance with the policy for amortisation of intangible assets with finite lives as set above. 2. 重大會計政策(續)

Finance charges implicit in the lease payments are charged to profit or loss over the period of the leases so as to produce an approximately constant periodic rate of charge on the remaining balance of the obligations for each accounting period. Costs that relate directly to an existing contract or to a specifically identifiable anticipated contract may include direct labour, direct materials, allocations of costs, costs that are explicitly chargeable to the customer and other costs that are incurred only because the Group entered into the contract (for example, payments to sub-contractors). Other costs of fulfilling a contract, which are not capitalised as inventory, property, plant and equipment or intangible assets, are expensed as incurred.

Capitalised contract costs are stated at cost less accumulated amortisation and impairment losses. Impairment losses are recognised to the extent that the carrying amount of the contract cost asset exceeds the net of (i) remaining amount of consideration that the Group expects to receive in exchange for the goods or services to which the asset relates, less (ii) any costs that relate directly to providing those goods or services that have not yet been recognised as expenses.

Amortisation of capitalised contract costs is charged to profit or loss when the revenue to which the asset relates is recognised. The accounting policy for revenue recognition is set out in note 2(t).

A contract asset is recognised when the Group recognises revenue (see note 2(t)) before being unconditionally entitled to the consideration under the payment terms set out in the contract. When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method (see note 2(t)).

A receivable is recognised when the Group has an unconditional right to receive consideration. Receivables are stated at amortised cost using the effective interest method less allowance for credit losses (see note 2(j)(i)).

Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows. Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. (t) Revenue and other income

Income is classified by the Group as revenue when it arises from the sale of goods, the provision of services or the use by others of the Group's assets under leases in the ordinary course of the Group's business.

Revenue is recognised when control over a product or service is transferred to the customer, or the lessee has the right to use the asset, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Where the contract contains a financing component which provides a significant financing benefit to the customer for more than 12 months, revenue is measured at the present value of the amount receivable, discounted using the discount rate that would be reflected in a separate financing transaction with the customer, and interest income is accrued separately under the effective interest method. Where the contract contains a financing component which provides a significant financing benefit to the Group, revenue recognised under that contract includes the interest expense accreted on the contract liability under the effective interest method. The Group takes advantage of the practical expedient in paragraph 63 of HKFRS 15 and does not adjust the consideration for any effects of a significant financing component if the period of financing is 12 months or less.

Further details of the Group's revenue and other income recognition policies are as follows:

A contract with a customer is classified by the Group as a construction contract when the contract relates to work on construction under the control of the customer and therefore the Group's construction activities create or enhance an asset under the customer's control.

When the outcome of a construction contract can be reasonably measured, revenue from the contract is recognised progressively over time using the output method, based on direct measurements of the value to the customer of goods or services transferred to date ("Value to the Customer") provided that the Value to the Customer is established according to the progress payment application (by reference to the amount of completed works confirmed by in-house surveyor) submitted to the customers or progress certificate (by reference to the amount of completed works confirmed by customer) issued by the customer.

Rental income receivable from lease of machinery is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Contingent rentals are recognised as income in the accounting period in which they are earned.

(iv) Interest income

Interest income is recognised as it accrues under the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see note 2(j)(i)).

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates.

The Group uses provision matrix to calculate ECLs for the trade and other receivables, contract assets and loan receivable. The provision matrix is based on the Group's historical default rates taking into consideration forwardlooking information that is reasonable and supportable available without undue costs or effort. At each reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In addition, trade and other receivables, contract assets and loan receivable with significant balances and credit impaired are assessed for ECLs individually. The provision of ECLs is sensitive to changes in circumstances and forecast general economic conditions. The information about the ECLs and the Group's trade and other receivables, contract assets and loan receivable are disclosed in note 27. If the financial condition of the customers or the forecast economic conditions were to deteriorate, the actual loss allowance would be higher than estimated.

In the comparative period, the Group evaluated whether there was any objective evidence that trade receivables were impaired, and estimates allowances for doubtful debts as a result of the inability of the debtors to make required payments. The Group based on the estimates on the ageing of the trade receivables balance, creditworthiness of the customer and historical write-off experience. If the financial condition of the debtors were to deteriorate, actual write-offs would be higher than estimated.

Exposure to credit, liquidity and interest rate risks arises in the normal course of the Group's business. The Group is also exposed to equity price risk arising from its equity investments in other entities. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group.

The Group's credit risk is primarily attributable to trade and other receivables. The Group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks and financial institutions with sound credit ratings. Given their high credit ratings, management does not expect any of these financial institutions and counterparties will fail to meet their obligations.

The Group has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

For loan receivable, the Group's management manages and analyses the credit risk for each of their new and existing customers before standard payment terms and conditions are offered. The management assesses the collateral and credit quality of each customer based on customer's background information, financial position, past experience and relevant factors. The Group also reviews from time to time the financial position of the customers.

For all other instruments including other receivables and loan receivable, the Group measures the loss allowance equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised based on significant increases in the likelihood or risk of a default occurring since initial recognition. The Group has assessed and concluded that the risk of default rate for the other instruments are steadily based on the Group's assessment of the financial health of the counterparties.

Trade receivables and contract assets

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At the end of the reporting period, 23% (2018: 3%) and 51% (2018: 3%) of the total trade receivables was due from the Group's largest customer and the five largest customers respectively within the foundation construction segment.

The Group's fund investment is held for strategic purposes. The performance is assessed periodically against performance of similar listed entities, based on the limited information available to the Group, together with an assessment of its relevance to the Group's strategic plans.

At 31 March 2019, it is estimated that an increase/ (decrease) of 5% (2018: 5%) in the relevant stock market index as applicable, with all other variables held constant, would have increased/decreased approximately HK\$82,000 (2018: nil) of the Group's loss after tax and retained profits.

The sensitivity analysis indicates the instantaneous change in the Group's loss after tax and retained profits that would arise assuming that the changes in the stock market index or other relevant risk variables had occurred at the end of the reporting period and had been applied to remeasure those financial instruments held by the Group which expose the Group to equity price risk at the end of the reporting period. After initial recognition of this asset and liability, the lessee will recognise interest expense accrued on the outstanding balance of the lease liability, and the depreciation of the right-of-use asset, instead of the current policy of recognising rental expenses incurred under operating leases on a systematic basis over the lease term.
