CHAIRMAN'S STATEMENT 主席報告

Dear Shareholders,

On behalf of the board (the "**Board**") of directors (the "**Directors**") of Wan Kei Group Holdings Limited (the "**Company**") and its subsidiaries (collectively the "**Group**"), I would like to present to the shareholders of the Company (the "**Shareholders**"), the annual report of the Group for the year ended 31 March 2023 (the "**Reporting Period**" or "**YR2023**").

During the Reporting Period, the Group recorded an increase in revenue of approximately HK\$52,230,000 or approximately 19.8% to approximately HK\$315,447,000 compared with the year ended 31 March 2022 (the "**YR2022**"). The increase in revenue was primarily due to increase of the number of sizable projects tendered by the Group during the Reporting Period.

The Board is of the view that with the gradual decline in COVID-19 cases and increased uptake of vaccination in Hong Kong and abroad, there are hopeful signs of a steady recovery in the longterm development of construction and foundation industry in Hong Kong. The Group will be prudent in tendering potential project while future strategy will depend on the evolvement of the pandemic.

Meanwhile, in order to maintain a stable and sustainable development of the Group's existing businesses as well as diversifying and expanding the Group's businesses at the same time, the Company will leverage on its industrial experience and the advantage of its existing resources and talented team to seek cooperation and investment opportunities with high-quality companies in the emerging industries.

On behalf of the Board, I would like to take this opportunity to express my deepest gratitude to our Shareholders and business partners for their continued support, and to our management and staff members for their commitment and contribution to the growth of the Group.

BUSINESS REVIEW AND OUTLOOK

The Group is principally engaged in providing: (i) foundation construction; (ii) ground investigation services; (iii) financial services; and (iv) trading of beauty and skin care products in Hong Kong.

Foundation construction

During the Reporting Period, the foundation construction undertaken by the Group mainly consisted of the construction of socketed H-piles, mini piles, soldier piles, pipe piles and king posts. The Group undertook foundation construction projects in both the public and private sectors. Revenue from the foundation works contributed approximately 80.9% to the total revenue of the Group during the Reporting Period (YR2022: approximately 83.0%).

Ground investigation services

The Group also acted as a contractor to provide ground investigation services in both public and private sectors in Hong Kong during the Reporting Period. Revenue from the ground investigation services contributed approximately 18.3% to the total revenue of the Group during the Reporting Period (YR2022: approximately 14.7%).

Financial services

During the Reporting Period, revenue from financial services contributed approximately 0.8% to the total revenue of the Group (YR2022: approximately 1.2%).

業務回顧及前景

本集團主要於香港從事提供:(i)地基建築;(ii) 土地勘測服務;(iii)金融服務;及(iv)美容及護 膚產品貿易。

地基建築

於報告期間,本集團承接的地基建築主要包括 建造插座式工字樁、微型樁、豎樁、管樁及起 重柱。本集團承接公營及私營部門地基建築項 目。於報告期間,地基工程所得收入佔本集團 總收入約80.9%(二零二二年度:約83.0%)。

土地勘測服務

於報告期間,本集團亦於香港作為承建商向公 營及私營部門提供土地勘測服務。於報告期 間,土地勘測服務所得收入佔本集團總收入約 18.3%(二零二二年度:約14.7%)。

金融服務

於報告期間,金融服務所得收入佔本集團總收入約0.8%(二零二二年度:約1.2%)。

Trading of beauty and skin care products

There was no revenue generated from the Group's trading business during the Reporting Period. Revenue from trading business contributed approximately 1.1% of the total revenue of the Group for the year ended 31 March 2022.

Outlook

The Board is of the view that with the gradual decline in COVID-19 cases and increased uptake of vaccination in Hong Kong and abroad, there are hopeful signs of a steady recovery in the longterm development of construction and foundation industry in Hong Kong. The Group will be prudent in tendering potential project while future strategy will depend on the evolvement of the pandemic.

FINANCIAL REVIEW

Revenue

The Group's total revenue for the Reporting Period increased by approximately HK\$52,230,000 or approximately 19.8%, from approximately HK\$263,217,000 for the year ended 31 March 2022 to approximately HK\$315,447,000 for the Reporting Period, which was primarily due to:

Foundation construction

The revenue from undertaking construction foundation projects increased by approximately HK\$36,868,000 or approximately 16.9%, from approximately HK\$218,460,000 for the year ended 31 March 2022 to approximately HK\$255,328,000 for the Reporting Period. This was primarily due to the increase in the number of sizable projects tendered by the Group during the Reporting Period.

Ground investigation services

The revenue from ground investigation services increased by approximately HK\$18,853,000 or approximately 48.6%, from approximately HK\$38,758,000 for the year ended 31 March 2022 to approximately HK\$57,611,000 for the Reporting Period. This was primarily due to the increase in the number of sizable projects tendered by the Group during the Reporting Period.

Financial services

During the Reporting Period, revenue for financial services amounted to approximately HK\$2,507,000 (YR2022: approximately HK\$3,190,000).

Trading of beauty and skin care products

During the Reporting Period, no revenue for trading business was generated by the Group (YR2022: approximately HK\$2,810,000).

財務回顧

收入

本集團於報告期間之總收入由截至二零二二 年三月三十一日止年度之約263,217,000港 元增加約52,230,000港元或約19.8%至報告 期間之約315,447,000港元,主要原因如下:

地基建築

承接地基建築項目所得收入由截至二零二二 年三月三十一日止年度之約218,460,000港 元增加約36,868,000港元或約16.9%至報告 期間之約255,328,000港元。此乃主要由於本 集團於報告期間所投得的大型項目數量增加。

土地勘測服務

土地勘測服務所得收入由截至二零二二年三 月三十一日止年度之約38,758,000港元增加 約18,853,000港元或約48.6%至報告期間之 約57,611,000港元。此乃主要由於本集團於 報告期間所投得的大型項目數量增加。

金融服務

於報告期間,金融服務的收入為約2,507,000 港元(二零二二年度:約3,190,000港元)。

美容及護膚產品貿易

於報告期間,本集團概無產生貿易業務收入 (二零二二年度:約2,810,000港元)。

Gross profit and gross profit margin

The gross profit increased from approximately HK\$52,813,000 for the year ended 31 March 2022 to approximately HK\$53,789,000 for the Reporting Period. The Group's overall gross profit margin during the Reporting Period was approximately 17.1% (YR2022: approximately 20.1%).

The gross profit of the Group's foundation construction segment decreased from approximately HK\$35,123,000 for the year ended 31 March 2022 to approximately HK\$34,383,000 for the Reporting Period. During the Reporting Period, gross profit margin of the foundation construction segment amounted to approximately 13.5% (YR2022: approximately 16.1%). The decrease in gross profit margin was mainly due to the increase in subcontractor fee.

Gross profit of the Group's ground investigation services segment was approximately HK\$16,900,000 for the Reporting Period, representing an increase of approximately 44.6% from approximately HK\$11,691,000 as compared to that for the year ended 31 March 2022. Gross profit margin of the ground investigation services segment slightly decreased from approximately 30.2% for the year ended 31 March 2022 to approximately 29.3% for the Reporting Period.

Gross profit of the Group's financial service was approximately HK\$2,507,000 for the Reporting Period (YR2022: approximately HK\$3,189,000). Gross profit margin of the financial services amounted to approximately 100% (YR2022: approximately 100%).

There was no revenue generated from the Group's trading business during the Reporting Period. Gross profit of the Group's trading business was approximately HK\$2,810,000 for the YR2022.

毛利及毛利率

毛利由截至二零二二年三月三十一日止年 度的約52,813,000港元增加至報告期間的 約53,789,000港元。本集團於報告期間的 整體毛利率約為17.1%(二零二二年度:約 20.1%)。

本集團的地基建築分部的毛利由截至二零 二二年三月三十一日止年度的約35,123,000 港元減少至報告期間的約34,383,000港元。 於報告期間,地基建築分部之毛利率約為 13.5%(二零二二年度:約16.1%)。毛利率下 降乃主要由於分包商費用增加。

本集團土地勘測服務分部於報告期間的毛利 約為16,900,000港元,較截至二零二二年三 月三十一日止年度的約11,691,000港元增加 約44.6%。土地勘測服務分部的毛利率由截至 二零二二年三月三十一日止年度的約30.2% 輕微減少至報告期間的約29.3%。

本 集 團 金 融 服 務 於 報 告 期 間 的 毛 利 約 為 2,507,000港元 (二零二二年度:約3,189,000 港元)。金融服務的毛利率為約100% (二零 二二年度:約100%)。

於報告期間,本集團的貿易業務並無產生收入。本集團貿易業務於二零二二年度的毛利約 為2,810,000港元。

Other income, other gains and losses, net

The other income, other gains and losses, net of the Group decreased by approximately HK\$2,595,000, from approximately HK\$19,124,000 for the year ended 31 March 2022 to approximately HK\$16,529,000 for the Reporting Period. The decrease was mainly due to (i) fair value gain of financial assets at fair value through profit or loss (Reporting Period: approximately HK\$73,000; YR2022: approximately HK\$17,054,000); (ii) gain reclassified on disposal of debt investment at fair value through other comprehensive income was approximately HK\$7,223,000 (YR2022: nil); and (iii) government grants was approximately HK\$4,385,000 for the Reporting Period (YR2022: approximately HK\$34,000).

General and administrative expenses

The Group's general and administrative expenses for the Reporting Period were approximately HK\$82,350,000 (YR2022: approximately HK\$59,713,000), representing an increase of approximately 37.9% as compared to that for the year ended 31 March 2022. The increase was mainly attributable to the recognition of impairment losses on a credit-impaired trade receivable and credit-impaired loan receivables (Reporting Period: approximately HK\$25,406,000; YR2022: approximately HK\$4,192,000). For the detailed information, please refer to the paragraph "Provision for expected credit losses in relation to trade receivable and loan receivables".

Finance costs

The finance costs decreased by approximately HK\$241,000 from approximately HK\$10,886,000 for the year ended 31 March 2022 to approximately HK\$10,645,000 for the Reporting Period. The decrease was mainly due to the repayment of amount due to a related company of the Group during the Reporting Period.

其他收入、其他收益及虧損淨額

本集團其他收入、其他收益及虧損淨額由 截至二零二二年三月三十一日止年度的約 19,124,000港元減少約2,595,000港元至報 告期間的約16,529,000港元。該減少乃主要 由於(i)按公平值計入損益的金融資產的公平 值收益(報告期間:約73,000港元;二零二二 年度:約17,054,000港元);(ii)出售按公平值 計入其他全面收益之債務投資之撥回收益約 7,223,000港元(二零二二年度:無);及(iii) 報告期間的政府補貼約4,385,000港元(二零 二二年度:約34,000港元)。

一般及行政開支

本集團於報告期間的一般及行政開支約 為82,350,000港元(二零二二年度:約 59,713,000港元),較截至二零二二年三月 三十一日止年度增加約37.9%。該增加乃主要 由於就出現信貸減值的貿易應收款項及出現 信貸減值的應收貸款確認減值虧損(報告期 間:約25,406,000港元;二零二二年度:約 4,192,000港元)。有關詳情,請參閱「有關貿 易應收款項及應收貸款的預期信貸虧損撥備」 一段。

融資成本

融資成本由截至二零二二年三月三十一日止 年度的約10,886,000港元減少約241,000港 元至報告期間的約10,645,000港元。該減少 乃主要由於報告期間償還應付本集團一間關 連公司款項。

Income tax

The tax expense for the Reporting Period was approximately HK\$938,000 (YR2022: tax credit of approximately HK\$628,000). The change was mainly due to the increase in assessable profits of Hong Kong Profits Tax and the change of deferred tax for the Reporting Period.

Financial asset at fair value through other comprehensive income

As at 31 March 2023, the financial asset at fair value through other comprehensive income represents approximately 19.7% equity interest of Matsu Gami IP Development Limited ("**Matsu Gami**"). During the Reporting Period, the Group partially exercise the put option to dispose approximate by 15.3% of the entire issued share capital of the Matsu Gami which was completed on 27 March 2023. There was no fair value change recognised during the Reporting Period.

Financial assets at fair value through profit or loss

The financial assets at fair value through profit or loss represents the (i) put option in relation to acquisition of an associate; and (ii) other unlisted investment.

Put option is measured at fair value using the Monte Carlo simulation model and binomial options pricing model. During the Reporting Period, the fair value loss of put option amounted to approximately HK\$8,000 (YR2022: the net fair value gain of profit guarantee, put option and call option amounted to approximately HK\$30,363,000).

The other unlisted investment represents investment in wealth management product issued by bank. During the Reporting Period, the relevant gain including bank interest income and fair value gain amounted to approximately HK\$112,000 (YR2022: approximately HK\$156,000).

所得稅

報告期間之稅項支出約為938,000港元(二零 二二年度:稅項抵免約628,000港元)。該變動 乃主要由於報告期間香港利得稅的應課稅溢 利增加及遞延稅項變動所致。

按公平值計入其他全面收益之金融資產

於二零二三年三月三十一日,按公平值計入其 他全面收益之金融資產指松神IP發展有限公司 (「**松神**」)股權的約19.7%。於報告期間,本 集團部分行使認沽期權,出售松神全部已發行 股本之約15.3%,有關出售於二零二三年三月 二十七日已完成。於報告期間,並無確認公平 值變動。

按公平值計入損益之金融資產

按公平值計入損益之金融資產指(i)有關收購 一間聯營公司的認沽期權;及(ii)其他非上市 投資。

認沽期權使用蒙特卡羅模擬模型及二項式期 權定價模型按公平值計量。於報告期間,認沽 期權的公平值虧損約8,000港元(二零二二年 度:溢利擔保、認沽期權及認購期權的公平值 收益淨額約30,363,000港元)。

其他非上市投資指於銀行發行的理財產品的 投資。於報告期間,銀行利息收入及公平值收 益等相關收益約為112,000港元(二零二二年 度:約156,000港元)。

Debt investment at fair value through other comprehensive income

During the Reporting Period, the debt investment at fair value through other comprehensive income represents the private fund. The debt investment is measured at fair value and were subscribed and purchased by a wholly owned subsidiary of the Group. The debt investment was matured on 18 March 2023. The gain on disposal of the debt investment amounted to approximately HK\$7,223,000. The net fair value loss including expected credit loss adjustment of debt investment was recognised in the consolidated statement of other comprehensive income (Reporting Period: nil; YR2022: approximately HK\$2,407,000).

Share of results of an associate

The share of profit of Matsu Gami was approximately HK\$4,141,000 for the period from 1 April 2022 to 27 March 2023 (YR2022: share of loss approximately HK\$9,385,000). This amount of profit was attributable to (i) share of the post-acquisition profit amounted to approximately HK\$5,519,000; and (ii) amortisation expense and deferred tax impact on the intangible asset arised from the fair value adjustments made on the acquisition date amount of approximately HK\$1,378,000.

按公平值計入其他全面收益之債務投資

於報告期間,按公平值計入其他全面收益之債 務投資指私募基金。債務投資按公平值計量, 並由本集團全資附屬公司認購及購買。 該項 債務投資已於二零二三年三月十八日到期。 出售債務投資之收益為約7,223,000港元。債 務投資的公平值淨虧損(包括預期信貸虧損調 整)於綜合其他全面收益表確認(報告期間: 無;二零二二年度:約2,407,000港元)。

應佔一間聯營公司之業績

於二零二二年四月一日至二零二三年三 月二十七日止期間,應佔松神的溢利約為 4,141,000港元(二零二二年度:應佔虧損約 9,385,000港元)。該筆溢利歸因於(i)收購後應 佔溢利約5,519,000港元;及(ii)因於收購日期 作出公平值調整而產生之無形資產之攤銷費 用及遞延稅項影響約1,378,000港元。

Loss on disposal of interest in an associate

On 27 March 2023, the Group partially exercised the put option to dispose approximately 15.3% of entire share capital of Matsu Gami in the total amount of approximately HK\$21,680,000 (being the amount held in the escrow account as maintained by escrow agent) and extended the remaining put option. Loss on disposal of interest in an associate amounted to approximately HK\$27,523,000.

Provision for expected credit losses in relation to trade receivable and loan receivables

In relation to the trade receivable for trading beauty and skin care products and loan receivables, the Group recognised provision for expected credit losses of approximately HK\$25,406,000 for the Reporting Period, in the aggregate amount of approximately HK\$35,250,000 (after provision was made) as at 31 March 2023 (the "**Impairment Loss**").

(a) Trade receivable

Trade receivable for trading of beauty and skin care products, was past due during the Reporting Period. The Company is closely negotiating with the customer and closely monitoring the repayment status. Despite several subsequent settlements, a supplemental agreement and a new guarantee agreement were signed with the customer and its fellow subsidiary, the Company has adopted a prudent approach to measure the expected credit losses ("**ECL**") of the trade receivable. According to the signed supplemental agreement and guarantee agreement, the last installment will be repayable on or before 31 January 2024 based on the repayment schedule.

出售於一間聯營公司的權益之虧損

於二零二三年三月二十七日,本集團部分行 使認沽期權,以總金額約21,680,000港元(即 託管代理於託管賬戶中保管的金額)出售松 神全部股本之約15.3%及延長剩餘認沽期 權。出售於一間聯營公司的權益之虧損為約 27,523,000港元。

有關貿易應收款項及應收貸款的預期信貸虧損撥 備

有關美容及護膚產品貿易之貿易應收款項及 應收貸款,本集團於報告期間內確認預期信貸 虧損撥備約25,406,000港元,於二零二三年 三月三十一日合共約35,250,000港元(經計提 撥備後)(「**減值虧損**」)。

(a) 貿易應收款項

美容及護膚產品貿易的貿易應收款項 已於報告期間內逾期。本公司現正與客 戶進行緊密協商,並密切監察還款之狀 況。儘管幾次期後結算,及本公司已與 客戶及其同系附屬公司簽訂補充協議及 新擔保協議,本公司仍採取審慎的方法 計量貿易應收款項的預期信貸虧損(「**預** 期信貸虧損」)。根據簽訂的補充協議及 擔保協議,最後一期款項將按還款時間 表於二零二四年一月三十一日或之前償 還。

(b) Loan receivables

Loan receivables for money lending business are represented by loan receivable A ("Loan receivable A") and loan receivable B ("Loan receivable B").

Prior to the grant of the Loan receivable A and Loan receivable B, the Group performed various due diligence and credit assessment work on each of the borrowers and guarantors, which include (i) obtaining of the latest management financial statements, statutory records and credit history (where applicable) to assess the background and financial position of the borrowers and to identify any indicators of high default risks; and (ii) considering the key terms by referencing the prevailing market interest rate and the financial position of the borrowers to compensate the associated credit risk (the "Credit Risk Assessments"). The Group, having not identified any indication of high default risk of the loans and having assessed the terms and conditions for the grant of the Loan receivable A and Loan receivable B based on Credit Risk Assessments, considered that the initial grant of the loans based on such terms and conditions was fair and reasonable and in the interest of the Company and its shareholders as a whole.

Loan receivable A was past due during the Reporting Period. The Company is closely negotiating with the customer and closely monitoring the repayment status. Despite a supplemental agreement and a new guarantee agreement signed with the customer and its fellow subsidiary, the Company has adopted a prudent approach to measure the ECL of the relevant receivable. According to the signed supplemental agreement and guarantee agreement (which was additional to the existing personal guarantees executed by the ultimate beneficial owners of the borrower in favour of the lender), the last installment will be repayable on or before 31 October 2023 based on the repayment schedule.

(b) 應收貸款

借貸業務的應收貸款指應收貸款A(「應 收貸款A」)及應收貸款B(「應收貸款 B」)。

應收貸款A於報告期間內已逾期。本公 司現正與客戶進行緊密協商,並密切監 察還款之狀況。儘管已與客戶及其同系 附屬公司簽訂補充協議及新擔保協議, 本公司仍採取審慎的方法計量相關應收 款項的預期信貸虧損。根據已簽署的 人以貸款人為受益人簽署的現將 還款時間表於二零二三年十月三十一日 或之前償還。

Loan receivable B was past due since June 2020. As at 31 March 2023, the outstanding principal was approximately HK\$16,900,000. The Company has commenced the winding up process against the customer company responsible for the nonpayment of Loan receivable B in April 2023. The hearing of winding-up petition originally fixed on 28 June 2023 is adjourned to 7 August 2023, and the Group has been liaising with the borrower in the interim with the view of settling the outstanding repayment amount. Subject to the signing of legally binding agreement between the parties agreeing to any repayment schedule of the outstanding amount, the Group is exploring the proposal with the borrower on repayment by instalments whereby the last instalment will be repayable on or before 30 September 2025.

(c) Impairment loss and key value of inputs used and assumptions adopted in valuation

The Group has engaged an independent valuer (the "**Valuer**") to conduct a valuation in relation to impairment assessment over its trade receivable and loan receivables as at 31 March 2023 (the "**Valuation**").

The Valuer adopted the expected credit loss model (the "**ECL Model**") to measure the ECL of the trade receivable and loan receivables. The ECL Model was adopted in accordance with Hong Kong Financial Reporting Standards 9. Major inputs of the ECL Model include (i) probability of default (the "**PD**") of the borrowers which in turn affecting the credit specific factor by, inter alia, assessing the loss stages and checking forward looking assumptions involved; (ii) loss given default; (iii) exposure at default; and (iv) discount factor reflecting time value of money. 應收貸款B自二零二零年六月起已逾 期。於二零二三年三月三十一日,未償 還本金約為16,900,000港元。本公司已 於二零二三年四月啟動針對就未履行應 收貸款B負有責任的客戶公司的清盤 6,原定於二零二三年六月二十八月 時 開定請聆訊押後至二零二三年八月七 日,本集團在此期間一直與借款人保集團 正與借款人探討分期還款的建議,而最 後一期款項將於二零二五年九月三十日 或之前償還,惟須經訂約方簽立具法律 約束力之協議,同意未償還金額的任何 還款時間表。

(c) 減值虧損及估值所用主要輸入數據及所採 納的假設

本集團已委聘獨立估值師(「估值師」)就 貿易應收款項及應收貸款於二零二三年 三月三十一日的減值評估進行估值(「估 值」)。

估值師採納預期信貸虧損模型(「預期信 貸虧損模型」)來衡量貿易應收款項及 應收貸款的預期信貸虧損。預期信貸虧 損模型乃根據香港財務報告準則第9號 而採用。預期信貸虧損模型的主要輸入 數據包括(i)借款人的違約概率(「違約概 率」),其通過(其中包括)評估虧損階段 和檢查所涉及的前瞻性假設影響信貸特 定因素;(ii)違約虧損;(iii)違約風險;及 (iv)反映貨幣時間價值的折現因素。

The expected credit loss rate (the "ECL rate") for trade receivable and Loan receivable A was relatively high in the Reporting Period due to significant increase in credit risks of the relevant receivables since initial recognition. Despite that the Company has been closely negotiating with the borrower and entered into the supplemental agreement and additional guarantee to further secure the repayment of the outstanding amount of the loan on or before 31 October 2023, the Board adopted a prudent approach when assessing the credit risk of Loan receivable A since initial recognition due to (i) the adverse impact the COVID-19 pandemic has on the local and global economy affecting the recovery of the borrower's sales and accounts receivables and (ii) the trade receivable and Loan receivable A were past due during the Reporting Period. The ECL rate increased to 52.9%, resulting in the provision for expected credit losses of approximately HK\$10,386,000 for trade receivable with gross carrying amount of approximately HK\$19,634,000 and approximately HK\$7,964,000 for Loan receivable A with gross carrying amount of approximately HK\$15,054,000 as at 31 March 2023 which is credit-impaired. After the end of the Reporting Period and as at the date of this report, approximately HK\$3,000,000 and approximately HK\$9,000,000 have been received for the settlement of trade receivable and Loan receivable A, respectively.

The ECL rate for Loan receivable B was relatively high in the Reporting Period due to significant increase in credit risks of the loan receivable since initial recognition. Due to (i) the adverse impact the COVID-19 pandemic has on the local and global economy, (ii) the Loan receivable B was past due since June 2020, and (iii) the Company has commenced the winding up process against the customer company responsible for the nonpayment of the Loan receivable B in April 2023, The Group has provided a full provision of approximately HK\$16,900,000 for Loan receivable B with gross carrying amount of approximately HK\$16,900,000 as at 31 March 2023.

於報告期間,貿易應收款項及應收貸款 A的預期信貸虧損率(「**預期信貸虧損 率」**)相對較高,乃由於自初始確認以 來,相關應收款項的信貸風險顯著上 升。儘管本公司已與借款人進行密切 磋商並訂立補充協議及額外擔保以進 一步確保於二零二三年十月三十一日 或之前償還貸款的未償還金額,惟由於 (i)2019冠狀病毒疫情對本地和全球經 濟的不利影響,影響借款人的銷售額 及應收賬款的收回及(ii)於報告期間貿 易應收款項及應收貸款A已逾期,董事 會於評估應收貸款A自初始確認以來的 信貸風險時採取審慎方針。預期信貸 虧損率增加至52.9%,導致二零二三年 三月三十一日賬面總值約19.634.000 港元的貿易應收款項計提預期信貸虧 損撥備約10,386,000港元及賬面總值 約15.054.000港元的已出現信貸減值 的應收貸款A計提預期信貸虧損撥備約 7,964,000港元。於報告期末後及於本 報告日期,已分別就結算貿易應收款項 及應收貸款A收到約3,000,000港元及 約9,000,000港元。

於報告期間,應收貸款B的預期信貸虧 損率相對較高,乃由於自初步確認以 來,應收貸款的信貸風險顯著上升。鑒 於(i)2019冠狀病毒疫情對地方及全球經 濟產生的不利影響,(ii)應收貸款B自二 零二零年六月起已逾期,及(iii)本公司已 於二零二三年四月啟動針對就未履行應 收貸款B負有責任的客戶公司的清盤程 序,本集團已就二零二三年三月三十一 日賬面總值約16,900,000港元的應收 貸款B全數計提撥備約16,900,000港 元。

Money lending business

Within the Group's money lending business, prospective borrowers are sourced from the management's business networks. A credit committee ("**Credit Committee**") is established and the primary responsibility of this committee is to assess and approve loans. During the credit assessment phase, multiple approval criteria are considered, including the client's income source, outstanding debt, credit history, loan history with our company and relevant assessment results obtained during the application procedure.

As of 31 March 2023, the combined outstanding balances of the top two clients in the money lending business equated to 100% of the Group's total loan receivables.

Business model of the Group's money lending business

The Group's money lending business is managed through a wholly-owned subsidiary, Fortune Shiny (Hong Kong) Limited ("Fortune Shiny"), which holds a money lenders license issued under the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong). Fortune Shiny provides loan financing services to both individual and corporate clients who are third parties independent of the Company and its connected persons (as defined in the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Corporate loans are offered to corporate clients requiring loan financing for their corporate needs, while individual loans are provided to clients who require loan financing for their personal needs.

Fortune Shiny is capable of granting loan financing services to both corporate and individual clients with greater flexibility compared to licensed banks and was established to generate interest income by providing loan financing services in Hong Kong. The Group's money lending business is primarily financed through internal resources.

借貸業務

於本集團的借貸業務中,潛在借貸人來自管理 層的業務網絡。信貸委員會(「信貸委員會」)已 告成立,該委員會的主要職責為評估及審批貸 款。信用評估階段考慮多個審批標準,包括客 戶的收入來源、未償還債務、信貸記錄、與本 公司的貸款記錄及申請程序中獲取的相關評 估結果。

截至二零二三年三月三十一日,借貸業務的前 兩大客戶的合併未償還結餘相當於本集團應 收貸款總額的100%。

本集團借貸業務之業務模式

本集團的借貸業務乃透過全資附屬公司富暉 (香港)有限公司(「**富暉**」)管理,其持有根據 《放債人條例》(香港法例第163章)發出之放 債人牌照。富暉為獨立於本公司及其關連人 士(定義見香港聯合交易所有限公司(「**聯交** 所」)證券上市規則(「上市規則」))的第三方的 個人及企業客戶提供貸款融資服務。企業貸款 提供予需要貸款融資以滿足企業需求的企業 客戶,而個人貸款則提供予需要貸款融資以滿 足個人需求的客戶。

富暉可向企業和個人客戶提供貸款融資服務,與持牌銀行相比具有更大的靈活性,並透 過在香港提供貸款融資服務賺取利息收入。本 集團的借貸業務主要由內部資源撥付。

Credit assessment policy

Loan applications are evaluated and processed on a caseby-case basis, with each application assessed based on its individual merit. Prior to granting loans, the management conducts a financial background and credit check procedure.

The process for loan application involves collecting customer information including identity and financial documents, performing a customer due diligence check to verify identity and understand the purpose of the loan, conducting a background check including legal and property ownership searches, performing a valuation check on the collateral, conducting a credit assessment to determine the borrower's ability to repay, and performing an assessment to ensure compliance with the relevant requirements and regulations of anti-money laundering and counter-terrorist financing. The details of each step may vary depending on the specific circumstances of the loan application.

Overall, the loan application process involves a thorough evaluation of the borrower's financial standing, legal and financial history, collateral, and ability to repay the loan. By performing these checks and assessments, the Group can reduce the risk of default and ensure that their loans are being used for legitimate purposes.

信貸評估政策

信貸申請按個別情況評估及處理,每項申請均 根據其個別價值進行評估。於發放貸款前,管 理層會進行財務背景及信用檢查程序。

貸款申請的過程涉及收集客戶資料(包括身份 和財務文件),進行客戶盡職調查以核實身份 並了解貸款目的,進行背景調查(包括法律和 財產所有權調查),對抵押品進行估值檢查, 進行信用評估以確定借款人的還款能力,並進 行評估以確保遵守反洗錢和反恐融資的相關 規定及規例。各步驟的詳情或會因貸款申請的 具體情況而有所差異。

整體而言,貸款申請過程包括對借貸人的財務 狀況、法律和財務記錄、抵押品和償還貸款的 能力進行全面評估。通過進行該等檢查和評 估,本集團可以減少違約風險,確保其貸款用 於合法目的。

Ongoing monitoring of loan recoverability and loan collection

To ensure recoverability, the Group places particular emphasis on the financial background, assets or capital base, repayment ability, and reputation of the borrower when establishing loan terms. The manager communicates with borrowers regularly to monitor the recoverability of loans and assess the conditions of the borrowers. Any delays in payment or defaults on significant terms of the loan agreement are reported to the management. To mitigate risk and potential credit losses, various measures may be implemented, including but not limited to revising repayment terms, executing a settlement agreement. and/or initiating legal proceedings against the borrower to recover any late payments and default interest. These measures are taken after considering the normal market practice and the actual circumstances during the credit collection processes and negotiations with the relevant customers with the ultimate goal of reducing the possibility of credit losses.

Credit committee

To manage credit risk and operations, the Credit Committee has been established, consisting of Mr. Chan Kwan, Mr. Yan Shuai, and Mr. Zhu Jiayu, with full authority to handle all credit-related matters of Fortune Shiny. All loans must be approved by the Credit Committee, following the authorization matrix for final approval.

The primary responsibilities of the Credit Committee include approving and supervising the Group's money lending business and monitoring the loan portfolio. The Credit Committee is also responsible for overseeing compliance and governance matters such as regularly reviewing and modifying the money lending policy to in line with changes in the market environment.

持續監測貸款可收回性及貸款催收

為確保可收回性,本集團於確定貸款條件時 特別強調借貸人的財務背景、資產或資本基 礎、還款能力及信譽。管理人定期與借款人溝 通,以監測貸款的可收回性並評估借貸人的狀況。任何延遲還款或違反貸款協議重要條款的 情況均會報告管理層。為減少風險和潛在的 貸虧損,本公司或會採取各種措施,包括但不 限於修改還款條件、簽署和解協議及/或對借 貸人提起法律訴訟以收回任何逾期付款和違 約利息。採取該等措施經考慮一般市場慣例和 實際情況,並於征信過程中與相關客戶進行磋 商,最終目的為降低信貸虧損的可能性。

信貸委員會

為管理信貸風險和業務,本公司成立信貸委 員會,由陳昆先生、嚴帥先生及朱佳瑜先生組 成,全權處理富暉所有信貸相關事宜。所有貸 款必須由信貸委員會批准,按照權限矩陣進行 最終批准。

信貸委員會的主要職責包括批准和監督本集團的借貸業務和監測貸款組合。信貸委員會亦 負責監督合規和治理事項,如定期審查和修改 借貸政策,以適應市場環境的變化。

Major terms of loans granted

Under the Group's money lending business for the Reporting Period, the Group offered a credit period of 6 months (YR2022: 6 months) for the loan to its corporate customer with interest rate of 7.5% p.a. (YR2022: 7.5% p.a.) secured by personal guarantee.

Breakdowns of material loan receivables

As of 31 March 2023, the Group had a total outstanding loan principal amount of approximately HK\$31,900,000 (YR2022: approximately HK\$32,900,000) before taking into account the ECL. The outstanding principal amounts relate to Loan receivable A and Loan receivable B, which was two corporate loans (YR2022: two corporate loans). Notably, the corporate loans accounted for 100% (YR2022: 100%) of the outstanding principal amounts, with an average outstanding principal amount of approximately HK\$15,950,000 (YR2022: approximately HK\$16,500,000) per loan account.

The interest rate for the outstanding principal amounts of the loan accounts ranged between 7.5% to 12% per annum (YR2022: 7.5% to 12%). All loan receivables accounts as of 31 March 2023 were secured by guarantees.

Loan interest income

For the Reporting Period, the total loan interest income from the Group's money lending business was approximately HK\$2,507,000 (YR2022: approximately HK\$3,190,000).

LOSS ATTRIBUTABLE TO EQUITY SHAREHOLDERS OF THE COMPANY

For the Reporting Period, the Group recorded a net loss of approximately HK\$46,996,000 as compared with approximately HK\$12,757,000, for the year ended 31 March 2022.

本集團於報告期間的借貸業務中,本集團為其 企業客戶貸款提供六個月(二零二二年度:六 個月)信貸期,年利率為7.5%(二零二二年度: 年利率7.5%),以個人擔保作抵押。

重大應收貸款明細

截至二零二三年三月三十一日,本集團有未 償還貸款本金總額為約31,900,000港元(二 零二二年度:約32,900,000港元)(未計及預 期信貸虧損)。未償還貸款本金額與應收貸款 A及應收貸款B有關,為兩筆企業貸款(二零 二二年度:兩筆企業貸款)。值得注意的是, 該等企業貸款佔未償還本金額的100%(二零 二二年度:100%),每個貸款賬戶的平均未 償還本金額為約15,950,000港元(二零二二年 度:約16,500,000港元)。

貸款賬戶的未償還本金額的年利率介乎7.5% 至12%(二零二二年度:7.5%至12%)。截至 二零二三年三月三十一日,所有應收貸款賬戶 均有擔保作抵押。

於報告期間,本集團錄得淨虧損約 46,996,000港元,而截至二零二二年三月 三十一日止年度為約12,757,000港元。

The Board did not recommend the payment of a final dividend to the equity shareholders for the Reporting Period (YR2022: nil).

Part of the Net Proceeds from the Placing were utilised up to 31 March 2023 and are intended to be applied in accordance with the revised proposed application set out in the announcement dated 3 January 2023. The below table sets out the details of the application of the Net Proceeds:

On 3 January 2023, the Company resolved to change the use of the outstanding Net Proceeds, being approximately HK\$70,700,000 as at 31 March 2022 (the "Unutilised Net Proceeds") as follows: (i) as to approximately HK\$25,700,000, to fund further possible acquisition(s) and (ii) as to the remaining balance of approximately HK\$45,000,000, for general working capital. As at 31 March 2023, the Board has not exercised the call option to acquire 16% of the issued share capital of Matsu Gami. For details, please refer to the 2023 Announcement and the announcement of the Company dated 3 January 2023.

The remaining Unutilised Net Proceeds as at 31 March 2023 were placed as bank balances with licensed bank in Hong Kong and will be applied in the manner consistent with the proposed allocations.

DEBTS AND CHARGE ON ASSETS

The total interest-bearing borrowings of the Group mainly consisted of leases liabilities, borrowing from a director of a subsidiary and borrowing from a related company of the Group. The above borrowings were incurred during the Reporting Period (YR2023: approximately HK\$188,909,000; YR2022: approximately HK\$245,357,000). All borrowings were mainly denominated in Hong Kong dollar. Interest on borrowings are charged at fixed rates. The Group currently does not have an interest rate hedging policy and the Group monitors interest risks continuously and considers hedging any excessive risk when necessary.

NET CURRENT ASSETS

As at 31 March 2023, the Group's net current assets amounted to approximately HK\$101,612,000 which was approximately HK\$39,413,000 lower than net current assets of approximately HK\$141,025,000, as at 31 March 2022, the decrease was mainly due to the exercise of the put option in relation to acquisition at an associate. As at 31 March 2023, the Group's current liabilities amounted to approximately HK\$234,216,000 representing a decrease of approximately HK\$50,405,000 from approximately HK\$284,621,000 as at 31 March 2022, the decrease was mainly due to the repayment of amount due to a related company and a director at a subsidiary.

LIQUIDITY AND FINANCIAL RESOURCES

As at 31 March 2023, the Group had cash and bank balances of approximately HK\$116,478,000, representing a decrease of approximately HK\$15,816,000 (as at 31 March 2022: approximately HK\$132,294,000), which were mainly denominated in Hong Kong dollar.

債務及資產押記

本集團的計息借貸總額主要包括租賃負債、來 自一名附屬公司董事的借貸及來自本集團一 間關連公司的借貸。以上借貸均於報告期間發 生(二零二三年度:約188,909,000港元;二零 二二年度:約245,357,000港元)。所有借貸主 要以港元計值。借貸利息以固定利率計息。本 集團目前並無利率對沖政策,而本集團持續監 察利率風險及於需要時考慮對沖任何過高風 險。

流動資產淨值

於二零二三年三月三十一日,本集團的流 動資產淨值約為101,612,000港元,較二 零二二年三月三十一日的流動資產淨值約 141,025,000港元減少約39,413,000港元, 該減少主要由於行使就收購一間聯營公司之 認沽期權。於二零二三年三月三十一日,本集 團的流動負債約為234,216,000港元,較二零 二二年三月三十一日的約284,621,000港元 減少約50,405,000港元,該減少主要由於償 還應付一間關連公司及一間附屬公司之一名 董事款項。

於二零二三年三月三十一日,本集團有現 金及銀行結餘約116,478,000港元,減少約 15,816,000港元(於二零二二年三月三十一 日:約132,294,000港元),主要以港元計值。

CASH FLOW

The net cash generated from the Group in its operating activities amounted to approximately HK\$24,359,000 during the Reporting Period, which was mainly generated from the foundation construction and ground investigation services. Net cash from investing activities was approximately HK\$28,543,000 in which approximately HK\$21,680,000 arose from the proceeds from disposal of interest in an associate, HK\$5,000,000 from the proceeds from redemption of debt investment at fair value through other comprehensive income, approximately HK\$2,030,000 arose from the payment for the purchase of property, plant and equipment. The net cash used in financing activities was approximately HK\$68,345,000 mainly arose from the repayment of amount due to a related company of HK\$55,000,000 and repayment of amount due to a director of a subsidiary of HK\$10.000.000.

The gearing ratio of the Group as at 31 March 2023 (defined as total interest-bearing liabilities divided by the Group's total equity) was approximately 161.0% (as at 31 March 2022: approximately 142.9%).

TREASURY POLICY

The Group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy position of liquidity throughout the Reporting Period. The Group strives to reduce the exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

現金流量

庫務政策

本集團已對其庫務政策採取審慎的財務管理 方針,故在整個報告期間內維持穩健的流動資 金狀況。本集團致力透過進行持續的信貸評估 及評估其客戶的財務狀況降低信貸風險。為管 理流動資金風險,董事會密切監察本集團的流 動資金狀況,以確保本集團資產、負債及其他 承擔的流動資金架構可滿足其不時的資金要 求。

FOREIGN EXCHANGE EXPOSURE

Since the Group mainly operates in Hong Kong and most of the revenue and transactions arising from its operations were mainly settled in Hong Kong dollar, and the Group's assets and liabilities are primarily denominated in Hong Kong dollar. The Directors believe that the Group's risk in foreign exchange is insignificant and the Group will have sufficient foreign exchange to meet its foreign exchange requirements. The Group has not experienced any material difficulties or effects on its operations or liquidity as a result of fluctuations in currency exchange rates; and it has not adopted any currency hedging policy or other hedging instruments during the Reporting Period.

CAPITAL STRUCTURE

The share capital of the Group only comprises of ordinary shares.

As at 31 March 2023, the Company's issued share capital was HK\$9,600,000 (as at 31 March 2022: HK\$9,600,000) and the number of its issued ordinary shares was 960,000,000 (as at 31 March 2022: 960,000,000) of HK\$0.01 each.

GUARANTEED PROFIT IN RESPECT OF THE ACQUISITION OF 35% ISSUED SHARE CAPITAL OF MATSU GAMI

Reference is made to the announcements of the Company dated 10 December 2019, 9 June 2020, 4 September 2020, 10 August 2021, 10 September 2021, 29 August 2022, 20 September 2022, 20 October 2022, 18 November 2022, 20 December 2022, 20 January 2023 and 27 March 2023 and the circular of the Company dated 8 February 2023 (the "**Circular**") in relation to the acquisition of the 35% issued share capital of Matsu Gami which is principally engaged in the business of provision of food and beverage catering services utilising well-known IP Rights and provision of related advising service. Unless otherwise defined, capitalised terms used shall have the same meanings as those defined in the Circular.

Under the terms of the Sale and Purchase Agreement (as amended by the 1st Supplemental Agreement, the 2nd Supplemental Agreement, the 3rd Supplemental Agreement and the 4th Supplemental Agreement), Massive Dynamic Venture Limited and Shen Garden Holdings Limited (collectively the "**Vendors**") and Mr. Shao Chao and Mr. Shen Kan (collectively the "**Vendor Guarantors**") conditionally agreed that:

(a) subject to the Company's right to exercise the remaining put option in (b) below, if the actual profit is less than the guaranteed profit of HK\$13,000,000 during YR2022-2023, the Vendors and the Vendor Guarantors shall compensate the Company in the amount calculated (the "YR2022-2023 Compensation Amount") based on the following:

YR2022-2023 Compensation Amount = HK\$13,000,000 - actual profit; and

(b) if the actual profit is less than the minimum guaranteed profit of HK\$7,400,000 during YR2022-2023, the Company shall have the right to exercise the remaining put option to require the Vendors to purchase the remaining approximately 19.7% interest held by the Company in the Matsu Gami pursuant to the terms and conditions under the 3rd Supplemental Agreement (as amended and supplemented by the 4th Supplemental Agreement) ((a) and (b) collectively, the "**Profit Guarantee Terms**").

In respect of the 2022-2023 Guaranteed Period, based on the information made available to the Board, the actual profit had exceeded HK\$13,000,000. - (i) for the Company to partially exercise the put option to require the Vendors to purchase approximately 15.3% of the entire issued share capital of the Matsu Gami in the total amount of approximately HK\$21,680,000 (being the amount held in the escrow account as maintained by the escrow agent) as the aggregated amount of the partial option consideration and the premium in the amount equals to the partial option consideration multiplied by the 10% annualised rate of return; and
- (ii) for the Vendors to grant an extension to the remaining put option conferring the right to the Company to require the Vendors to purchase approximately 19.7% (i.e. the remaining interest held in the Matsu Gami by the Company) of the entire issued share capital of the Matsu Gami if the actual profit for the year ended 31 March 2023 (the "YR2022-2023") recorded is less than HK\$7,400,000.

(b) Significant investments

During the Reporting Period, the debt investment was matured on 18 March 2023. The redemption price of the debt investment was approximately HK\$41,926,000 and the gain on disposal of the debt investment amounted to approximately HK\$7,223,000. For details, please refer to the paragraph "Debt investment at fair value through other comprehensive income".

As at 31 March 2023, the Group had no material pending litigation.

EMPLOYEES AND REMUNERATION POLICIES

As at 31 March 2023, the Group had 123 fulltime employees (as at 31 March 2022: 124 full-time employees).

The remuneration policy and packages of the Group's employees are periodically reviewed. Apart from mandatory provident fund and in-house training programmes, salary increment and discretionary bonuses may be awarded to employees according to the assessment of individual performance. The total remuneration cost incurred by the Group for the Reporting Period was approximately HK\$69,330,000 as compared to approximately HK\$70,015,000 for the year ended 31 March 2022.

本集團定期審閱僱員的薪酬政策及待遇。除強制性公積金及內部培訓課程外,本集團亦根據 個人表現評核而增加工資及授予僱員酌情花 紅。於報告期間,本集團產生的總薪酬成本約 為69,330,000港元,而截至二零二二年三月 三十一日止年度則約為70,015,000港元。

PRINCIPAL RISKS AND UNCERTAINTIES

The Group's key risk exposures are summarised as follows:

- (i) The Group has a concentrated clientele base. Any loss for major customers or decrease in the number of projects with the top 5 customers of the Group may adversely affect the Group's operations and financial results.
- (ii) The Group's past revenue and profit margin may not be an indicative of the Group's future revenue and profit margin. In particular, the Group's revenue is on project basis, which is non-recurrent in nature, and the Group may achieve lower-than expected revenue if it fails to maintain continuity of the Group's order book for its new projects.
- (iii) The Group is dependent on its Board members and senior management staff, the departure of its staff may adversely affect the Group's business operations.
- (iv) Failure to accurately estimate and control the costs of the Group's projects may adversely affect the Group's financial performance.
- (v) Any delay or default of progress payments or retention monies by the customers may affect the Group's cash flow and may have adverse impact on the Group's financial results.
- (vi) Failure to renew the Group's current registrations and licenses may adversely affect the Group's business operations. For other risks and uncertainties facing the Group, please refer to the section headed "Risks Factors" in the prospectus of the Company dated 28 July 2015 (the "Prospectus").

主要風險及不確定性

RELATIONSHIP WITH CUSTOMERS, SUPPLIERS, SUBCONTRACTORS AND EMPLOYEES

The Group's success also depends on the support from key stakeholders which comprise employees, customers and suppliers.

Customers

For foundation construction, the principal customers are generally from the main contractors of construction projects in Hong Kong. For ground investigation services, the principal customers are generally from the employers of construction projects in Hong Kong. During the Reporting Period, the Directors considered that the Group did not rely on any single customer. The Group also maintains a longterm relationship with its customers, some of which have established more than 10 years of working relationship with the Group.

Suppliers and Subcontractors

During the Reporting Period, the suppliers of goods and services which were specific to the business of the Group and were acquired on a regular basis to enable the Group to continue to carry its business included (i) subcontractors engaged by the Group to perform the site works; (ii) materials and equipment suppliers to supply materials and equipments used in the site works; and (iii) suppliers of miscellaneous goods and services required for the Group's business operations. The Group maintains multiple suppliers and subcontractors to avoid the overreliance on a few suppliers and subcontractors; and did not experience any material difficulties in sourcing materials from suppliers and assigning subcontractors during the Reporting Period. The Group did not have any significant disputes with any of its suppliers and subcontractors during the Reporting Period.

與客戶、供應商、分包商及僱員的關係

本集團的成功亦取決於主要持份者(包括僱員、客戶及供應商)的支持。

客戶

就地基建築而言,主要客戶一般為香港建築項 目的總承建商。就土地勘測服務而言,主要客 戶一般為香港建築項目的僱主。於報告期間, 董事認為,本集團並不依賴任何單一客戶。本 集團亦與其客戶維持長期關係,部分客戶已與 本集團建立10年以上工作關係。

供應商及分包商

於報告期間,就本集團業務屬特定且須定期供 應貨物及服務以便本集團能繼續進行其業務 的供應商包括:(i)本集團委聘進行地盤工程的 分包商;(ii)供應地盤工程使用的物料及設備供應商;及(iii)供應本集團業務營 運所需的其他各種貨品及服務的供應商。本集 團維持多名供應商及分包商以避免對少數供 應商及分包商過度依賴;於報告期間,本集團 於向供應商採購物料及委派分包商方面並無 遭遇任何重大困難。本集團於報告期間並無與 其任何供應商及分包商有任何重大糾紛。

Employees

The Group recognised employees as valuable assets of the Group. During the Reporting Period, the Group has complied with the applicable labour laws and regulations and regularly reviewed the benefits of existing staff for improvement. The Group intends to use its best effort to attract and retain appropriate and suitable personnel to serve the Group. The objective of the Group's human resource management is to reward and recognise performing staff by providing an attractive remuneration package.

The Group determines the salary of its employees mainly based on each employee's qualification, relevant experience, position and seniority. The Group conducts annual review on salary increment, bonuses and promotions based on the performance of each employee.

The Group considers that the Group has maintained a good relationship with its employees. The Group has not experienced any strikes, work stoppages or labour disputes which affected its operations during the Reporting Period. The Directors also acknowledge that the management team and the employees have maintained a good relationship and co-operated well during the Reporting Period.

ENVIRONMENTAL POLICIES

The Group places an emphasis on environmental protection when undertaking its projects. The Group was awarded the ISO 14001:2015 (environmental management system). During the Reporting Period, the ISO 14001:2015 certificate was valid from 24 March 2021 to 29 April 2024. When preparing the tender documents, the Group will take into consideration the environmental protection requirements of potential customers as well as the relevant laws and regulations in relation to environmental protection. The Company has complied with rules 3.10(1) and 3.10A of the Listing Rules during the Reporting Period. There are currently three independent non-executive Directors in the Board and the number of independent non-executive Directors represents more than one-third of the Board. As such, there exists a strong independent element in the Board, which can effectively exercise independent judgement. The Company has also complied with rule 3.10(2) of the Listing Rules which stipulates that one of the independent non-executive Directors must possess appropriate professional qualification or accounting or related financial management expertise. In compliance with the Code, the independent non-executive Directors.

Each of the independent non-executive Directors namely, Mr. Lo Wa Kei Roy, Mr. Leung Ka Fai Nelson and Mr. Eric, Todd has entered into a service contract with the Company for a fixed term of two years, renewable automatically for successive terms of one year each upon expiration of the initial term, and can be terminated by not less than three months' notice in writing served by either party on the other. The independent non-executive Directors are subject to retirement by rotation and re-election at the annual general meeting of the Company ("**AGM**") in accordance with the articles of association of the Company (the "**Articles**").

At each AGM, one-third of the Directors are required to retire from office. Each Director shall retire from office once every three years. The Directors to be retired in every year shall be those appointed by the Board during the year and those who have been longest in office since their last election or re-election. Mr. Chui Kwong Kau, Mr. Lo Wa Kei Roy and Mr. Eric, Todd will retire from office as Directors at the forthcoming AGM pursuant to Article 108 of the Articles, and being eligible, offer themselves for re-election at the AGM.

No Director proposed for re-election at the AGM has a service contract with the Company which is not determinable by the Company within one year without payment of compensation other than statutory compensation.

BOARD AND GENERAL MEETING

The Board meets regularly and, in addition to regular meetings, it meets as and when warranted by particular circumstances. During the Reporting Period, 14 board meetings were held. BOARD RESPONSIBILITIES AND DELEGATION

The Board is responsible to the Shareholders for leadership and control of the Group and be collectively responsible for promoting the success of the Group by directing and supervising the Group's affairs. The Board focuses on formulating the Group's overall strategies, approving the annual development plan and budget; monitoring financial and operating performance; reviewing the effectiveness of the internal control and risk management system and supervising and managing the management's performance.

Regarding the Group's corporate governance, during the Reporting Period, the Board has performed the following duties in accordance with the terms of reference:

- determined and reviewed the policies and practices on corporate governance of the Group and make recommendations;
- reviewed and monitored the training and continuous professional development of the Directors and senior management;
- reviewed and monitored the Group's policies and practices on compliance with legal and regulatory requirements;
- developed, reviewed and monitored the code of conduct applicable to Directors and employees; and
- reviewed the Company's compliance with the Code and disclosure in this corporate governance report.

The Board delegates the day-to-day management, administration and operation of the Group to the management. The delegated functions are reviewed by the Board periodically to ensure they remain appropriate to the needs of the Group. The Board gives clear directions to the management as to the matters that must be approved by the Board before decisions are made on behalf of the Group by the management. In addition, the Board has also delegated various responsibilities to the board committees of the Company (the "**Board Committee**").

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

Under code provision C.2.1 of the Code, the roles of chairman and chief executive officer should be separated and should not be performed by the same individual. Mr. Yan Shuai, the Chairman of the Board, is responsible for providing strategic advice and guidance for the development of the Group, leading the Board and guaranteeing effective operation of the Board in accordance with sound corporate governance practice and procedures, as well as advocating an open and active discussing culture to promote the Directors to effectively contribute to the Board. The Company has not appointed the chief executive officer during the Reporting Period.

MODEL CODE FOR SECURITIES TRANSACTIONS BY DIRECTORS

The Company has adopted the Model Code as the code of conduct of the Company regarding directors' transactions of the listed securities of the Company.

The Company has made specific enquiry to all Directors, and all Directors confirmed that they have complied with the Model Code and its code of conduct during the Reporting Period.

DIRECTORS' CONTINUING PROFESSIONAL DEVELOPMENT PROGRAMME

All Directors confirmed that they have complied with code provision C.1.4 of the Code during the Reporting Period that all Directors have participated in continuous professional development to develop and refresh their knowledge and skills. The Company has arranged an inhouse training on the Listing Rules in the form of a seminar during the Reporting Period conducted by the legal advisor as to Hong Kong laws and relevant training materials were distributed to all the Directors. All Directors attended the in-house training. The training covered topics including the Code, listed company regulations and disclosure obligations in Hong Kong, disclosable transactions and connected transactions, etc.

BOARD COMMITTEES

The Board has established the (i) audit committee (the "Audit Committee"), (ii) remuneration committee (the "Remuneration Committee"), (iii) the nomination committee (the "Nomination Committee") and (iv) the investment committee (the "Investment Committee") with defined terms of reference. The terms of reference of each of the Board Committees, which explain their respective roles and authority delegated to them by the Board, are available on the websites of the Company and the Stock Exchange. The Board Committees are provided with sufficient resources to discharge their duties and upon reasonable requests, are able to seek independent professional advice and other assistance under appropriate circumstances, at the Company's expenses.

AUDIT COMMITTEE

The Company has established the Audit Committee on 9 May 2015 with written terms of reference in compliance with Rule 3.21 of the Listing Rules and paragraph D.3 of the Code. The Audit Committee currently consists of three independent non-executive Directors, namely, Mr. Lo Wa Kei Roy, Mr. Leung Ka Fai Nelson and Mr. Eric, Todd, with Mr. Lo Wa Kei Roy being the chairman of the Audit Committee.

The primary duties of the Audit Committee are, inter alia, to assist the Board in providing an independent view of the effectiveness of the financial reporting system, internal control procedures and risk management control systems, to oversee the audit process and to perform other duties and responsibilities as assigned by the Board. During the Reporting Period, the Audit Committee has reviewed with the management on the Group's unaudited interim results, audited annual results, the consolidated financial statements and this report.

NOMINATION COMMITTEE

The Company established a Nomination Committee on 9 May 2015. As at the date of this report, the Nomination Committee comprises an executive Director, namely Mr. Yan Shuai, and two independent non-executive Directors, namely Mr. Lo Wa Kei Roy and Mr. Leung Ka Fai Nelson. Mr. Lo Wa Kei Roy is the chairman of the Nomination Committee.

The written terms of reference of the Nomination Committee adopted by the Board are in line with the Code and are available on the websites of the Company and the Stock Exchange.

The principal duties of the Nomination Committee are to review the structure, size, diversity and competition of the Board, assess the independence of independent nonexecutive Directors and make recommendations to the Board on matters relating to the appointment of Directors.

Nomination Policy

The director nomination policy sets out the approach and procedures the Board adopts for the nomination and selection of Directors including the appointment of additional directors, replacement of directors, and reelection of directors. The selection criteria in assessing the suitability of potential candidates includes, but not limited to, their professionalism and personal ethics, reputation for integrity, character and integrity, board experience, expertise, time commitment, measurable objectives set out in the board diversity policy. The Nomination Committee may use any process it considers appropriate for evaluating and shortlisting candidates, which may include, personal interviews, background checks, written submission by the candidates and third party references. The selection process for each of their appointments shall be evaluated using a substantially similar process and shall be fair and transparent.

BOARD DIVERSITY POLICY

The Company adopted a board diversity policy (the "**Board Diversity Policy**") from the date of Listing up to the date of this corporate governance report. A summary of this Board Diversity Policy, together with the measurable objectives set for implementing this Board Diversity Policy, and the progress made towards achieving those objectives are disclosed below.

The Company recognised the benefits of having a diverse Board to enhance the quality of its performance. The Board Diversity Policy aims to set out the approach to achieve diversity on the Board. In designing the Board's composition, the Board's diversity has been considered from a number of measurable aspects including but not limited to gender, age, cultural and educational background, professional experience, skills, knowledge and length of services, all of which the Company considers to be important to enhance the quality of its performance. Currently, all Board members are male. The Company plans to appoint at least one female Director by the end of December 2024. In order to cultivate a pipeline of suitable female successors to the Board, such steps will include providing existing female senior management with comprehensive training on areas such as business operation, management and corporate governance, and giving due consideration to gender diversity when recruiting or promoting candidates for senior managerial roles and/ or directorship based on existing nomination and board diversity policies. All Board appointments will be based on meritocracy and candidates will be considered against objective criteria, having due regards for the benefits of diversity on the Board.

The Nomination Committee will monitor the implementation of the Board Diversity Policy and recommend any proposed changes to the Board for approval. The Nomination Committee will from time to time review the Board Diversity Policy as appropriate to ensure its effectiveness.

At the date of this report, the Board comprises 7 Directors, members of the Board have a variety of education backgrounds, including holding bachelor and/or master degrees in the science, law, financial management as well as the business administration fields. Most of the members also possess various finance-related experiences. The composition of the Board reflects the necessary balance of skills, professional experience and knowledge for an effective leadership of the Company.

董事會多元化政策

本公司自上市日期起直至本企業管治報告日 期均有採納董事會多元化政策(「**董事會多元 化政策**」)。本董事會多元化政策的概要連同 為執行本董事會多元化政策而制定的可計量 目標以及達標進度披露如下。

本公司深明董事會多元化對提升公司的表現 裨益良多。董事會多元化政策旨在載列為達致 董事會多元化而採取的方針。本公司在設定 董事會成員組合時,會從多個可計量方面考慮 董事會多元化,包括(但不限於)性別、年齡、 文化及教育背景、專業經驗、技能、知識及服 務年期等,本公司認為此等因素對提升其表現 甚為重要。目前,所有董事會成員均為男性。 本公司計劃於截止二零二四年十二月年底前 任命至少一名的女性董事。為培育合適的董事 會女性繼任者,有關措施將包括為現有的女性 高級管理層提供全面培訓,例如業務營運、管 理及企業管治,並根據現有的提名及董事會成 員多元化政策,在招聘或晉升高級管理層職位 及/或董事職位候選人時充分考慮性別多元 化。董事會所有委任均以用人唯才為原則,並 在考慮人選時以客觀條件充分顧及董事會多 元化之裨益。

提名委員會將負責監察董事會多元化政策之 執行,並將任何擬更改的建議提交董事會審 批。提名委員會將在適當時候不時檢討董事會 多元化政策,以確保其行之有效。

於本報告日期,董事會由7名董事組成,董事 會成員具備不同的教育背景,包括持有科學、 法律、金融管理以及工商管理範疇的學士及/ 或碩士學位。大多數成員亦具備多項金融相關 經驗。董事會組成反映技能、專業經驗及知識 的必要平衡,以便有效領導本公司。

The Nomination Committee has reviewed the Board Diversity Policy to ensure its effectiveness and considered that the Group achieved the objectives in Board Diversity Policy during the Reporting Period.

INVESTMENT COMMITTEE

The Company has established the Investment Committee on 2 March 2022. As at the date of this report, the Investment Committee comprises two executive Directors, namely Mr. Yan Shuai and Mr. Zhu Jiayu and one nonexecutive Director, namely Mr. Zhang Zhenyi. Mr. Yan Shuai is the chairman of the Investment Committee.

The specific written terms of reference of the Investment Committee were approved and adopted by the Board.

Pursuant to the terms of reference, the primary duties of the Investment Committee are (a) to study and make recommendations to the Board in relation to investment activities, recommendations must be submitted to the Board for approval; (b) to advise on the investment policies of the Company; (c) to discuss, formulate views and advise the Board on asset allocation, selection of external portfolio investment advisor/fund manager(s) and quantum to be invested with collective investment schemes/fund managers and appointment of custodian(s); (d) to consider such other topics and matters relating to financial investments of the Company as may be assigned by the Board; and (e) to review these terms of reference on at least an annual basis and recommend any changes it considers appropriate for the Board's approval.

During the Reporting Period, the Investment Committee held 3 meeting.

The Directors are of the view that the consolidated financial statements of the Group for each financial year have been prepared on this basis.

EXTERNAL AUDITORS' REMUNERATION

The Company engaged HLB Hodgson Impey Cheng Limited as its external auditors for the year ended 31 March 2023. There was no disagreement between the Board and the Audit Committee on the selection, appointment, resignation or dismissal of the external auditor. RISK MANAGEMENT AND INTERNAL CONTROL

The Board acknowledges its responsibility to evaluate and determine the nature and extent of the risks it is willing to take in achieving the Group's strategic objectives, and to ensure that the Group establishes and maintains appropriate and effective risk management and internal control systems. However, risk-taking is an unavoidable necessity and an accepted part of the Company's business while effective risk management is an integral part to present competitive advantages and ensure the Company achieves its strategic and business objectives. The risk management and internal control systems are designed to manage rather than eliminate the risk of failing to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatements or losses.

Risk Management

Risk management applies to all aspects of the Group's business and is a critical component in developing strategic plans, preparing operational plans and budgets, approving investment projects and managing project plans.

Risks are evaluated by the Board and management based on the severity of impact on the Company and the probability of risk occurring.

Based on the risk evaluation, the Group will manage the risks as follows:

• Risk elimination: management may identify and implement certain changes or controls that in effect eliminate the risk entirely.

風險管理及內部控制

董事會明白其有責任評估及釐定本集團就達 成策略目標所願意接納的風險性質及程度,并 確保本集團設立及維持適當有效的風險管理 及內部監控制度。然而,本公司業務無法完全 避免風險,此亦為必要及固有部分,有效的風 險管理對呈現競爭優勢及確保本公司達成 策略及業務目標至關重要。風險管理及內部監 控制度旨在管理而非消除導致未能達成業務 目標的風險,並且僅能提供合理而非絕對保證 可防範重大錯誤陳述或損失。

風險管理

風險管理適用於本集團業務的各層面,且為制 定戰略計劃、編製營運計劃及預算、批准投資 項目及管理項目計劃的關鍵組成部分。

董事會與管理層的風險評估乃基於對本公司 影響的嚴重性及風險發生的概率。

本集團將根據風險評估結果,按以下方式管理 風險:

 排除風險:管理層可確認並實施若干變 動或控制,完全排除風險。

- Risk mitigation: management may implement a risk mitigation plan designed to reduce the likelihood and/ or severity of impact to an acceptable level.
- Risk acceptance: management may decide that the risk rating is acceptable for the Company meanwhile and no action is thus required. However, the risk would continue to be monitored to ensure the level of risk does not increase to an unacceptable level.

Controls and Reviews

Policies and procedures are in place to ensure that the relevant management directives are carried out and actions that may be needed to address risks are taken. These may include approvals, verifications, reviews, safeguarding of assets and segregation of duties.

Control activities can be divided into operations, financial reporting and compliance, although there may, on occasion, be some overlaps between them. The typical control activities adopted by the Group include:

- analytical reviews: such as conducting reviews of actual performance against prior periods;
- direct functional or activity management: review of performance reports;
- physical controls: ensuring equipment, inventories and other assets are safeguarded and subject to periodic checks; and
- segregation of duties: dividing and segregating duties among different people, with a view to strengthening checks and minimizing the risk of errors and abuse.

- 直接職能或工作管理:審閱表現報告;
- 實物監控:確保設備、存貨及其他資產 得到保護并定期接受檢查;及
- 職責分權:劃分不同人員之間的職責,
 以加強檢查及盡量減少出錯及濫權的風險。

Inside Information

With respect to procedures and internal controls for the handling and dissemination of inside information, the Group:

- conducts its affairs with high regard to the "Guidelines on Disclosure of Inside Information" issued by the Securities and Futures Commission;
- closely communicates and seeks advice from its legal advisor in assessing the likely impact of any unexpected and significant event that may impact the price of the Shares or their trading volume, and to determine whether the relevant information is considered inside information that needs to be disclosed as soon as reasonably practicable pursuant to the SFO and the Listing Rules;
- has included in its Corporate Code of Conduct a strict prohibition on the unauthorized use of confidential or inside information; and
- ensures, through its own internal reporting process and the consideration of their outcome by senior management, the appropriate handling and dissemination of inside information.

Assessing the Effectiveness of Risk Management and Internal Control Systems

The Board, via the Audit Committee, is responsible for the review and assessment of the major risks the Group faces and the review, approval and monitoring of the Group's response to such risks annually.

The Audit Committee oversees the risk management process and reviews the effectiveness of the risk management and internal control systems by performing the following procedures:

- Review with management annually those reports on compliance with the risk management policy;
- Discuss with management annually on the Group's major risks and the steps management has taken since then or should take to address and deal with such risks; and
- Review the effectiveness of the Group's risk management practices.

Management is responsible for ensuring the Group's business operations being conducted in line with our risk management policy, taking into consideration changes in external environment and the Group's risk tolerance level.

In addition to the Board's oversight, the Group has developed a risk management process to identify, evaluate and manage significant risks and to remediate material internal control deficiencies (if any). Management, through the engagement of the independent internal control and risk advisory team, is responsible for the annual risk reporting process. The independent internal control and risk advisory team meets with members of the senior management to review and assess risks and discuss remedial measures to address material internal control deficiencies (if any), including any changes relevant to a given year. Risks are compiled, ratings assigned and migration plans documented. The risk assessment is reviewed by management and presented to the Audit Committee and the Board for their review.

除董事會進行監督外,本集團已設立風險管理 程序以識別、評估及管理重大風險及補救重大 內部監控缺漏(如有)。管理層透過委聘獨立內 部監控及風險諮詢團隊,負責年度風險報告程 序。獨立內部監控及風險諮詢團隊與高級管理 人員會面,檢討及評估風險並商討應對重大內 部監控缺漏(如有)的補救措施,包括某一年份 有關的任何變動。該等風險將予以匯編、評級 並記錄有關緩解計劃。管理層檢討風險評估及 向審核委員會及董事會呈報以供彼等審閱。

The Group has in place effective processes and systems for the identification, capture and reporting of operational, financial and compliance-related information in a form and timeframe intended to ensure that staff carry out their designated responsibilities.

Risk Management and Internal Control Process

On behalf of the Board, the Audit Committee reviews annually the continuous effectiveness of the Group's risk management and internal control systems dealing with risk and financial accounting and reporting, the effectiveness and efficiency of operations, compliance with laws and regulations, and risk management functions.

The assessment considers:

- the scope and quality of management's ongoing monitoring of risks and of the risk management and internal control systems;
- the extent and frequency with which the results of monitoring are communicated, enabling the Committee to build up a cumulative assessment of the state of control in the Group and the effectiveness with which risk is being managed;
- the incidence of any significant control failings or weaknesses that have been identified at any time during the period and the extent to which they have resulted in unforeseen outcomes or contingencies that have had, could have had, or may in the future have, a material impact on the Group's financial performance or condition;
- the effectiveness of the Group's processes in relation to financial reporting and statutory and regulatory compliance;
- areas of risk identified by management;

風險管理與內部監控程序

審核委員會代表董事會每年就本集團對處理 風險與財務會計及報告的風險管理及內部監 控制度是否持續有效、營運是否有效及有效 率、有否遵守有關法律法規和風險管理職能等 方面進行檢討。

評估工作會考慮:

- 管理層持續監察風險以及風險管理及內 部監控制度的工作範疇及質素;
- 監控結果獲得傳達的程度及頻密度,以 便委員會就本集團的監控狀況及風險管 理的有效程度進行累積評估;
- 期內任何時候發現的任何重大監控失誤 或監控不足的次數,及因此導致未能預 見的後果或緊急情況的嚴重程度,而這 些後果或情況對本集團的財務表現或狀 況已經產生、可能已經產生或將來可能 會產生重大影響;
- 本集團有關財務報告及法定和合規程序 的有效性;
- 管理層識別的風險範疇;

- significant risks reported by the independent internal control and risk advisory team;
- work programs proposed by the independent internal control and risk advisory team and the external auditors; and
- significant issues arising from internal and external audit.

As a result of the above review, the Board considers that the Group's risk management and internal control systems are effective and adequate and have complied with the Code Provisions on risk management and internal control throughout the year and up to the date of this annual report.

Internal Audit

The Group has engaged an independent internal control and risk advisory team, Riskory Consultancy Limited, which has assisted in monitoring the corporate governance of the Group and providing an objective assessment to the Board on whether a sound internal control system is maintained and operated by management.

The internal control and risk advisory team conducted a review on a number of corporate governance areas and business cycles and provided recommendations for the improvement and strengthening of the internal control system. No significant control finding or weakness has been identified by the internal control and risk advisory team. The Audit Committee reviews the findings and recommendations of the internal control and risk advisory team on the effectiveness of the Group's internal control system and reports to the Board on such reviews.

For the avoidance of doubt, there can be no assurance that a dividend will be proposed or declared in any specific period.

The Board would review the Company's dividend policy from time to time considering factors including but not limited to capital investment and business plan.

Such meeting shall be held within 2 months after the deposit of such requisition. Unless otherwise stated, the ESG Report covers the overall performances, risks, strategies, measures and commitments of the Group in environmental, social, and governance areas for the year ended 31 March 2023 ("**YR2023**").

During the YR2023, the Group is principally engaged in providing foundation construction, ground investigation services, financial services and trading of beauty and skin care products in Hong Kong. The foundation construction is its major business, which mainly consists of the construction of socketed H-piles, mini piles, soldier piles, pipe piles and king posts. The Group conducts foundation construction through Wan Kei Geotechnical Engineering Company Limited and ground investigation services through Chun Shun Boring Engineering Company Limited. Therefore, the ESG Report will mainly focus on the above businesses.

For the Group's corporate governance practice information, please refer to the corporate governance report on pages 39 to 68 of this annual report.


The Group carried out materiality assessment on a number of ESG issues in order to identify which issues were crucial to the Group's business and were of the material concerns to stakeholders. The Group has identified 22 ESG issues covering environmental, social and operation. Management and employees of the Group have participated in the preparation of the materiality assessment and assessed the importance of these 22 ESG issues to businesses of the Group and stakeholders, and make disclosure of relevant information.

重要性評估

ENVIRONMENTAL PROTECTION

The Group is engaged in foundation construction and ground investigation services, which may inevitably produce exhaust gas, greenhouse gas, dust, sewage, noises and other emissions. However, the Group has implemented detailed internal codes, and made clear guidelines on management of site environment, control on emissions, and even management of office environment, in an effort to minimise the impacts of its daily operation on the environment.

The Group has put a great effort into minimalising the environmental impact of its activities through adopting industrial best practices targeted at reducing natural resources consumption and effective emission management. The Group regularly assesses the environmental risks of its business, and adopt preventive measures as necessary to reduce the risks and ensure the compliance of relevant laws and regulations.

As a recognition to the Group's environment policies, its environmental management system concerning the design, supply and installation of the rock-socketed steel H-pile in pre-bored hole and mini pile work, has been identified to be in compliance with ISO 14001: 2015 after the assessment since 2021. The Group has been granted the OHSAS 450001:2018 Certification of Environment Management System by Accredited Certification International Limited, the Best Safety and Environment Protection Subcontractor Award and the Onsite Best Safety and Environmental Subcontractor Award by customers, all of which prove the Group's endeavour in promoting environmentally responsible practices.

1. Emissions

Air Pollution – Exhaust Gas and Greenhouse Gas Emissions

Greenhouse gas emissions ("**GHG Emission**") from daily business activities mainly represent direct exhaust emissions from construction machineries and transport vehicles while carrying out projects, as well as electricity and paper consumption in office and warehouse. To reduce gas emissions, the Group has issued specific internal guidance for regulating and monitoring the GHG Emissions and exhaust emissions during the daily operation, including the construction process and environment management on the site, turning off all idle construction machineries and strictly enforcing "Switch off Idling Vehicles", as well as reminding staff to turn off all electric appliances while leaving the working place.

環保

本集團從事地基建築及土地勘測服務,過程中 難免會產生廢氣、溫室氣體、粉塵、污水、噪 音及其他排放物。然而,本集團已訂立詳細的 內部守則,對工地環境管理、排放物控制、甚 至辦公室環境管理等均有明確指引,以盡量減 少其日常營運過程中對環境的影響。

本集團投入大量精力,通過採用針對減少天然 資源消耗及高效排放管理的行業最佳實踐,減 輕其業務對環境的潛在影響。本集團定期評估 其業務的環境風險,採取必要的預防措施以降 低風險並遵守相關法律法規。

作為對本集團環境政策的認可,其有關設計、 供應及安裝預鑽孔嵌岩式工字鋼樁及微型樁 工程的環保管理系統已自二零二一年經評估 並認證為符合ISO 14001:2015要求。本集團 亦先後獲國際認可認証有限公司授予環境管 理體系的OHSAS 450001:2018認證、獲客戶 授予最佳安全及環保分包商嘉許獎狀及施工 現場最安全最環保分包商稱號,足以證明本集 團推動環保負責的生產常規所作出的努力。

1. 排放物

空氣污染-廢氣及溫室氣體排放

日常經營活動產生的溫室氣體排放(「**溫室氣** 體排放」)主要為項目施工時各類施工機械及 運輸車輛的直接廢氣排放,以及來自辦公室和 貨倉電力、紙張等消耗。為減少氣體排放,本 集團已對規管及監察日常經營活動中的溫室 氣體排放、廢氣排放發出明確內部指引,包括 工地施工流程及環境管理、關閉所有閒置的施 工機械及嚴格執行「停車熄匙」,以及提醒員工 離開工作場所前關掉所有電器等。

The Group has complied with the Air Pollution Control Ordinance and other regulations promulgated by governments and currently applicable to the Group, as well as environmental requirements of contractor. All machineries, including leased machineries, used on the site shall obtain approval or exemption from the Environmental Protection Administration, and shall not be used on the site until the approval label or exemption label being attached. Those machineries consume ultra-low-sulfur diesel to reduce the emission of suspended particles, thus reaching our environmental protection target.

The Group has performed several actions, please refer to the paragraph "Hazardous and Non-hazardous Waste Treatment". No formal policy on waste reduction has been established to regulate its sub-contractors. Nevertheless, they are encouraged to reduce waste and reuse resources to minimise the environmental impacts.

In addition, the Group maintains and repairs machineries, equipment and vehicles on regular basis, with a view to prevent them from generating excess emissions of exhaust caused by broken parts and other reasons, and to facilitate the reduction of fuel consumption. 本集團遵循《空氣污染管制條例》及政府所頒 佈且現時適用於本集團之其他規例,以及遵守 承建商之環保要求。地盤所用之所有機械(包 括租賃機械)均須獲環保署的核准或豁免,且 未貼上核准標籤或豁免標籤前不得在工地使 用。這些機械均使用超低硫柴油,有效減少懸 浮粒子排放,從而達到環保目標。

本集團已採取多項行動,請參閱「有害及無害 廢棄物處理」一段。本集團並無制定有關減少 廢棄物的正式政策以規管其分包商。儘管如 此,我們亦鼓勵彼等減少廢棄物及重複利用資 源,以將對環境造成的影響降至最低。

此外,本集團會定期保養及維修機械、設備及 車輛,以防止因零件破損及其他原因而排放過 量廢氣,促進減少油耗。

- Scope 1: Direct GHG emissions from gasoline consumption by the Group.
- Scope 2: Indirect GHG emissions resulting from electricity consumption by the Group.
- Scope 3: Other indirect GHG emissions include emission from business travel by air by employees and emission from electricity consumption for processing fresh water and sewage.

Air Pollution – Dust

Dust is generated during construction work. Dust emissions can mainly be attributed to wind and kinesis. Construction materials such as sand and cement stored outdoor as well as the dust of the exposed construction area are easily scattered in dry and windy weather. In addition, dust is generated by external force in particular the construction trucks and machineries during the process of excavation and soil loosening.

In compliance with the Air Pollution Control Ordinance, the Group controls the emission of air pollutants by following the Group's internal guidance. To reduce dust pollution, all vehicles carrying sand and other scraps are covered completely with canvas to ensure that no large amount of dust is generated during transportation. In order to prevent dust spreading around, the Group installs water sprinklers on the sites to clean tires of construction vehicles while entering into or leaving the sites and roads.

Hazardous and Non-hazardous Waste Treatment

Waste from daily operation includes general inert waste and non-inert construction materials from construction works. The Group manages waste from the site in accordance with the internal waste management guidance and the Waste Disposal Ordinance. In general, the Group categorises the waste from construction works. General inert waste from work, such as rocks, if applicable, shall be reused as filling materials at the site or collected by professional contractors as reclamation materials in the future. Other waste that is not applicable for recycle or reuse shall be discarded to the public dumping area. Metal and chemical waste within the site shall be collected and discarded by licensed contractors. All waste shall be well disposed before being removed from the site.

空氣污染-揚塵

施工工程會產生揚塵。揚塵排放主要歸因於風 力起塵和動力起塵。露天堆放的砂石、水泥等 建材及無遮蓋施工區的浮塵在乾燥大風天氣 容易起塵。此外,外力因素亦會產生揚塵,特 別是工程車及機械在挖掘及鬆土時。

遵循《空氣污染管制條例》,本集團根據其內部 指引控制空氣污染物排放。為減少揚塵污染, 本集團會用帆布完全遮蓋所有運載砂石及其 他廢料的車輛,確保運載過程中不會產生大量 揚塵。為防止揚塵飛散,本集團在工地安裝灑 水器,於施工車輛進入或離開工地及道路時清 洗輪胎。

有害及無害廢棄物處理

日常營運產生的廢棄物包括施工工程產生的 一般惰性廢物及非惰性建築物料。本集團根據 內部廢棄物管理指引以及《廢物處置條例》,管 理工地廢物。一般而言,本集團會將施工工程 產生的廢棄物分類。工程中的一般惰性廢物, 例如石塊(如適用),我們會重用作為地盤填 土物料,或交由專業承辦商回收作日後填海物 料;對於其他廢棄物,如不適合回收或再用, 我們會運往公眾堆填區棄置。工地內的金屬及 作學廢料由持牌承辦商回收及棄置。所有的廢 棄物於運離工地前,均會妥善處置。

In respect of office waste, apart from dumping waste at the designated place in line with the requirements of the property management office of the office premise, the Group also categorises the waste and engages a contractor to collect toner cartridge. Meanwhile, the Group regularly monitors the consumption of paper, toner cartridges and ink cartridges to reach our waste reduction target. 辦公室廢物方面,除根據辦公室大廈管業處 要求,將垃圾棄置於指定地方外,本集團亦會 進行垃圾分類,並委聘承辦商回收碳粉盒。同 時,本集團定期監察紙張、碳粉盒及墨盒等的 消耗情況以達到減廢目標。

Sewage Discharge

The Group has complied with the Water Pollution Control Ordinance. Water consumed at the site shall be discharged to the designated environmental treatment facility in accordance with the instruction of the contractors before being discharged outside the site. The Group shall deploy adequate manholes and deposition pools in line with seasons, with an aim to mitigate the water pollution caused by garbage, oil or other materials.

污水排放

本集團遵守《水污染管制條例》。工地用水須 按照承建商之指示,排放到指定之環保處理 設施,方可排出工地外。為減少因垃圾、油或 其他物料造成的水污染,本集團會因應季節變 化,配置足夠的隔沙井及沉積池。

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to environmental protection and pollutant emissions. During the YR2023, the Group is not aware of any material non-compliance with the Air Pollution Control Ordinance, the Waste Disposal Ordinance and other relevant laws and regulations relating to air and GHG emissions, discharges into water and land, and generation of hazardous and non-hazardous waste that would have significant impact on the environment. In addition, there was no report of significant fines or sanctions as a result of non-compliance with the relevant laws and regulations in the YR2023.

Climate Change

The management of the Group has been aware that climate change and global warming pose a huge impact to global environment which may adversely impact our businesses and the economy as a whole. Extreme weather events could interrupt our supply chain logistics and could delay project delivery leading to potential financial losses of the Group, threatening the stability of the Group's business and operations. In view of this, we have conducted regular reviews of environmental standard and regulations and formulated ESG targets and goals in order to minimize the aforesaid risks.

2. Use of Resources

The Group encourages its staff to make good use of resources, and issues internal notice to all of the staff, requiring them to save energy and reduce consumption:

- Turn off all the air conditioners and lighting systems before leaving the working environment;
- Use LED lighting in the office;
- Maintain the indoor temperature at 25 degrees Celsius in the office;
- Use recycled paper and double-sided printing as well as old envelops for internal documents or nonimportant/unclassified documents;
- Use electronic documents such as email as possible and reduce paper usage;

本集團嚴格規管其業務營運,確保符合當地有 關環保及污染物排放的法律及法規。於二零 二三年度,本集團並不知悉任何違反《空氣污 染管制條例》、《廢物處置條例》及其他與廢氣 及溫室氣體排放、向水及土地排污、產生有害 及無害廢棄物有關的法律及法規的重大違規 情況,而將對環境產生重大影響。此外,於二 零二三年度,並無有關因違反相關法律及法規 而受到重大罰款或處罰的報告。

氣候變化

本集團管理層已知悉氣候變化及全球變暖對 全球環境造成巨大影響,可能會對我們業務及 整體經濟產生不利影響。極端天氣事件或會中 斷我們供應鏈物流並延遲項目交付,導致本集 團潛在財務虧損,威脅本集團業務及營運的穩 定性。有鑒於此,我們定期對環境標準及法規 進行審查,並制定ESG目標及指標,以盡量減 少上述風險。

2. 資源使用

本集團鼓勵其員工善用資源,並向所有員工發 出內部通告,要求員工節能減耗:

- 離開工作環境前關閉所有空調及照明系統;
- 於辦公室內使用LED照明;
- 辦公室室內溫度保持於25攝氏度;
- 內部文件或非重要/非保密文件應使用 環保紙及雙面打印、以及使用舊信封;
- 盡量使用電郵等電子文件,減少用紙;

- Reduce the use of disposable goods and reuse office stationery; and
- Make use of telephone/video conferencing equipment to avoid unnecessary business travelling.

The Group considers water resources to be quite valuable and the Group is committed to promoting the concept of saving water. There is a wide range of water use at construction sites. Although the water supply facilities at the sites are provided by the contractors, the Group urges on the construction workers from time to time not to waste water. As for offices, the Group puts up some slogans with saving water near taps to remind staff to save water. 本集團認為水資源相當珍貴,所以本集團致力 提倡節約用水觀念。建築工地的用水情況較為 廣泛。雖然工地的供水設備由承辦商提供,本 集團不時敦促建築工人切勿浪費水資源。辦公 室方面,本集團於水喉附近位置張貼節約用水 標語,提醒員工節約用水。

3. The Environment and Natural Resource

Noise Management

As certain procedures would produce noises during the construction, which cause impacts to the residents nearby, the Group adopts necessary measures to minimize noises in compliance with the Noise Control Ordinance. The Group conducts construction during designated time (e.g. 7 a.m. to 7 p.m. on normal working days) and applies for Noise Control Permit (NCP) for certain works or construction ways.

The Group would set noise barriers or noise enclosure at the early stage during construction period to suppress the noise level.

Enhancing Environmental Awareness

The Group actively enhances the environmental awareness of its staff in addition to enhancing environmental measures, including issuing of internal environmental guidance and sharing of relevant environmental information in relation to green office.

SOCIETY

Employment and Labour Practices

1. Employment

Employment Policy

The Group has established a series of internal policies related to employment according to the guidance under Hong Kong Employment Ordinance, industry features and practices to ensure that its employees are provided with equal promotion opportunity and other packages, such as minimum wage security, maximum working hours, compensatory leave, mandatory provident fund or pension security and rewards for long-term services.

In general, subsidiaries of the Group would make proper upward or downward adjustment to the number of existing staff in the recruitment process based on the scale and actual situation or progress of the existing sites and the sites awarded. As all employees on the sites are paid on a daily basis, the employee turnover is relatively high.

3. 環境及天然資源

噪音管理

由於施工過程中的部分工序會產生噪音,影響 附近居民,故此本集團遵守《噪音管制條例》, 採取必要措施盡量降低噪音。本集團於指定時 間(如正常工作日上午七時至下午七時)施工, 並就個別工程或施工方式申請噪音管制許可 証。

於施工前期,本集團將設置隔音屏障或隔音 罩,遏制噪音水平。

提升環保意識

除加強執行環保措施外,本集團亦積極提升員 工的環保意識,包括發出內部環保指引及分享 綠色辦公室等相關環保資訊。

社會

僱傭及勞工慣例

1. 僱傭

僱傭政策

本集團根據香港《僱傭條例》指引、行業特性和 慣例制訂一系列僱傭相關內部政策,確保員工 獲得平等晉升機會及其他待遇,如最低工資保 障、最高工時、補假、強積金或退休保障及長 期服務獎勵等。

一般情況下,本集團旗下附屬公司,在招聘過 程中會視乎現有地盤及中標地盤之規模及實 際情況或進度,適當的增聘或減少現有員工數 目。由於所有工地員工均為日薪員工,故僱員 流動性相對較大。

As general foundation construction and ground investigation services involve certain high-risk activities, only staff possessed of the Construction Industry Safety Training Certificate can carry out related work on the site.

Besides, as our subsidiaries engage in construction business, they will also subcontract some projects to other subcontractors. In order to ensure that the employees of the subcontractors could receive reasonable wages, we usually pay the wages to such employees responsible for relevant projects on behalf of the subcontractors.

During the YR2023, the Group did not involve any illegal activities related to employment that had caused material impact on the Group.

Equal Opportunity and Diversity Policy

The Group's principal businesses include foundation construction and ground investigation services, which demand plenty of physical labour force, hence traditionally male employees are a majority in the workforce of construction business.

The Group is impartial in choosing its employees, and has gradually established and improved its recruitment mechanism. Recruitment of employees is based on their work experience, techniques and skills, work performance. The Group does not discriminate our employees on the basis of their gender, age, origin, nationality, race, religious belief, sexual orientation, physical disability, marital status and so on.

Staff Communication

The Group places high priority on staff communication through various activities and channels, by which it can understand its staff's needs and strengthen our relationship. In some traditional Chinese festivals, such as Chinese New Year Eve, the Company organised New Year Eve's dinner for all staff in order to create a harmonious and friendly working atmosphere and strengthen communication with staff.

Dismissal

The Group complies with the guidance under Hong Kong Employment Ordinance. If terminating the employment of staff, the Group will follow the process to make reasonable compensation to the dismissed employees. The relevant provisions on termination of the employment relationship are set out in the employment contracts of every employee. 由於日常地基建築及土地勘測服務涉及部分 高危活動,只有持有建造業安全訓練証明書的 員工方可在工地進行有關工作。

另外,我們的附屬公司由於從事建築業務,亦 會外包部分工程予其他分包商。為確保分包商 員工可取得合理薪金,我們通常代分包商向有 關員工發放其所負責相關項目之薪金。

於二零二三年度,本集團並無牽涉任何有關僱 傭且對本集團構成重大影響的違法活動。

平等機會及多元政策

本集團之主營業務包括地基建築及土地勘測 服務,需要大量體力勞動,因此在傳統上,男 性員工是建築業務的主要勞動力。

本集團秉持公平的用人風格,逐步建立完善人 才招聘機制,以工作經驗、技術技能、工作表 現為員工招聘基準,不以性別、年齡、地域、 國籍、種族、宗教信仰、性取向、身體殘疾、婚 姻狀況等歧視員工。

員工溝通

本集團高度重視員工溝通,透過各種活動及渠 道,了解員工需求,加強雙方關係。在除夕等 一些傳統中國節日,本公司組織年夜飯,與全 體員工聚餐,營造和諧友善的工作氣氛,加強 與員工的溝通。

解僱

本集團遵守香港《僱傭條例》指引,如解僱員 工,本集團將按照流程處理,給予被解僱員工 合理賠償。解除僱傭關係的相關條文已載列於 各員工的僱傭合約中。

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to employment during the course of operation. During the YR2023, the Group is not aware of any material non-compliance with the Employment Ordinance and other relevant laws and regulations relating to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity, anti-discrimination and other benefits and welfare in Hong Kong. In addition, there was no report of significant fines or sanctions as a result of non-compliance with the relevant laws and regulations in the YR2023.

2. Health and Work Safety

Occupational Safety

The Group cares about the health and well-being of our employees. Due to the nature of its businesses, some employees have to operate a variety of large machines during daily work, which involves certain safety risk. As such, the Group implemented various safety measures to ensure the occupational safety of the employees.

All employees who perform engineering operation must undergo mandatory basic safety training. Only those awarded with the Construction Industry Safety Training Certificate, commonly known as the "Green Card", can be employed to carry out related work on the site. In order to enhance site safety supervision and staff's safety awareness, the Group has also engaged professional safety consultants to conduct inspection on site safety so as to rectify site safety problems immediately and reduce the occurrence of industrial injury incidents. The Group's professional safety consultants also regularly provide certain safety courses and guidelines on site safety for site staff and supervisors.

As there are many machinery and other equipment in the construction sites, employees will be more prone to industrial accidents. The Group strictly requires workers to wear safety protection equipment such as safety helmets and obey the safety guidelines of contractors and the Group. 本集團嚴格規管其業務營運,以確保於營運過 程中遵守與僱傭相關的當地法律及法規。於二 零二三年度,本集團概無知悉在香港有任何嚴 重違反《僱傭條例》及與補償及解僱、招聘及晉 升、工作時數、休息時間、平等機會、多元化、 反歧視及其他待遇和福利有關的其他相關法 律及法規的情況。此外,於二零二三年度,並 無因違反相關法律及法規而招致重大罰款或 制裁的報告。

2. 健康及工作安全

職業安全

本集團關注僱員的健康與福祉,由於本集團業 務性質,部分僱員在日常工作中需要操作各類 大型機械,其中存在一定安全風險。因此,本 集團已實施多項安全措施,以確保僱員的職業 安全。

所有參與工程作業的僱員均須接受強制性基 本安全訓練。僅獲發建造業安全訓練證明書 (俗稱「綠咭」)的人員方可受僱在地盤開展相 關工作。為加強地盤安全監督及僱員的安全意 識,本集團亦已委聘專業安全顧問負責檢查地 盤安全,以便即時糾正地盤安全問題,減少工 傷事故的發生。本集團的專業安全顧問亦會定 期向地盤人員及監工提供若干關於地盤安全 的安全課程及指引。

由於建造地盤有眾多機械及其他設備,僱員更 易發生工傷事故。本集團嚴格要求工人佩戴安 全帽等防護設備,以及遵守承建商及本集團的 安全指引。

Physical and mental health

Apart from daily work, the Group encourages employees to participate in various types of outdoor activities which benefit to the body fitness and mind and keep healthy to promote the physical and mental development of employees and maintain a work-life balance.

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to health and safety during the course of operation. In YR2023, there was no case of material non-compliance with the Occupational Safety and Health Ordinance (Chapter 509 of the Laws of Hong Kong) and the relevant laws and regulations relating to providing a safe working environment and protecting employees from occupational hazards that have a significant impact in Hong Kong. In addition, there was no record of significant safety accidents and occupational injuries, nor did it have any events regarding safe working environment and protecting employees from occupational hazards; and no violation of health and safety laws and regulations was found in YR2023.

3. Development and Training

The Group actively attracts and retains talents, and trains employees who have the potential to become managers in the long run. Therefore, the Group encourages its employees to receive further education in relation to the development needs of the Group and make good use of their talents to achieve their career goals. The Group offers sufficient internal promotion opportunities to its employees. The Group promotes its staff based on their staff performance evaluation results. The Group's senior management has extensive experience in the industry and will actively share their knowledge to facilitate the development of our employees. Employees may also communicate with and seek professional advice from their department heads on their personal career development planning.

身心健康

除日常工作以外,本集團鼓勵僱員參與各類有 益身心的戶外活動,注意健康,促進僱員身心 發展,保持工作及生活平衡。

本集團嚴格規範自身業務經營,確保經營過 程中遵守與健康及安全相關的本地法例及規 例。於二零二三年度,概無發生就《職業安全 及健康條例》(香港法例第509章)及在香港有 重大影響的關於提供安全工作環境及保護僱 員不受職業危害的相關法例及規例的重大不 合規情況。此外,於二零二三年度,本集團並 未發生重大安全事故及職業傷害,且並未發生 任何關於安全工作環境及保護僱員不受職業 危害的事件,且未發現存在任何違反健康及安 全法例及規例的情況。

3. 發展及培訓

本集團積極吸引及挽留人才,並培養有潛力在 未來成為管理人員的僱員。因此,本集團鼓勵 僱員結合本集團發展需求接受進修,充分發掘 自身才能,實現事業抱負。本集團為僱員提供 足夠的內部晉升機會。本集團依據員工績效評 估的結果,決定員工晉升。本集團的高級管理 層擁有豐富行業經驗,並會積極分享自身知 識,幫助僱員發展。僱員亦可就其個人職業發 展規劃,與其部門主管溝通,獲取專業的指導 意見。

All staff on the construction site are required to attend site safety lectures organised by the contractor that last for half a day to one and a half days depending on requirements of such contractor. The Group has also asked staff to attend lectures on construction site safety and crisis training organised by professionals.

All staff of the money lending business have attended seminar regarding to overview of licensing conditions of money lenders licence, international anti-money laundering standards and Hong Kong regulatory regime for licensed money lenders, money laundering and terrorist financing methods, suspicious transaction reporting and risk assessment and mitigation in relation to proliferation financing.

The Group has appointed professionals to provide its Directors and senior management with trainings on various aspects such as the Listing Rules and corporate governance.

During the YR2023, the training information of Directors and senior management are as followed:

4. Labour Standards

The Group rigorously complies with all relevant labour standards in Hong Kong and actively protects the basic personal rights and interests of its employees, ensuring that they work in a fair environment and are respected. The Group strictly forbids unlawful acts such as child and forced labour. In order to combat illegal employment of child and forced labour, the Human Resources Department of the Group requires job seekers to provide valid identification before confirming employment to ensure that applicants can be employed in accordance with the law.

4. 勞工準則

本集團嚴格遵守香港的所有相關勞工準則, 積極保障僱員的基本個人權益,確保僱員在公 平、受尊重的環境中工作。本集團嚴禁童工及 強制勞工等非法行為。為防止非法僱用童工及 強制勞工情況的發生,本集團人力資源部門在 確認僱傭前,會要求求職者提供有效的身份證 明,以確保可依法僱用申請人。

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to labour standards during the course of operation. In YR2023, there was no case of material non-compliance with the Employment Ordinance and the relevant laws and regulations relating to preventing child or forced labour in Hong Kong. In addition, the Group did not employ child and forced labour, nor did it record any cases of discrimination involving race, religion, age or disability in YR2023.

OPERATING PRACTICE

5. Supply Chain Management

The Group has a total of 185 suppliers, mainly including subcontractors and material suppliers which are Hong Kong based companies. There was no major change in the regional ratio during the year.

The Group has long-term relationships and mutual trust with its major suppliers (including subcontractors, material suppliers, etc.) based on long term cooperation and mutual trust, and all of them have been our material suppliers for more than a decade. As the Group's businesses are based in Hong Kong, it chooses to purchase from suppliers in Hong Kong to save transportation costs and minimise environmental impact.

In addition to geographical factors, the Group chooses and evaluates its suppliers based on their professional qualifications, product quality, service capabilities and pricing, etc. and in accordance with our procurement policy. The Group ensures suppliers and subcontractors comply with relevant local and international standards, and follow up with periodic performance assessment. Evaluation is conducted on existing and new (if applicable) annually) on product and service quality. We will only work with approved suppliers and subcontractors. Furthermore, the Group strictly stipulated that all purchase orders on materials are placed by the office's purchaser, and purchase orders must be signed by Directors to be valid.

The Group's business in money lending has no significant suppliers.

5. 供應鏈管理

本集團共有185名供應商,主要為分包商及材 料供應商。分包商及材料供應商均為香港公 司。年內地區比例並沒有重大改變。

本集團與主要供應商(包括分包商、材料供應 商等)均建有長期合作關係及互信基礎,主要 供應商均為本集團提供材料超過10年。由於 本集團之業務均在香港,因此,為節省運輸成 本及盡可能減少環境影響,我們選擇向香港的 供應商採購。

除了地理因素,本集團會根據採購政策考慮供 應商的專業資質、產品質量、服務能力及價格 等進行篩選與評估。本集團確保供應商及分包 商遵守相關地方及國際守則,並定期進行表現 評估。每年對現有及新(如適用)產品及服務質 量進行評估。我們僅與獲批的供應商及分包商 合作。此外,本集團嚴格規定所有物料採購均 由辦公室之採購員負責落單,而採購單均須由 董事簽字方為有效。

本集團的借貸業務並無重大供應商。

6. Product Responsibility

Product quality

The Group has been engaged in foundation construction and ground investigation services for over a decade and has completed hundreds of projects one after another. The Group is widely recognised and highly praised by its clients as it focuses on service quality and is committed to providing its clients with top-tier service portfolio. To meet the demand of its clients, the Group has developed its internal management system and closely monitored its project execution process, with an aim to render premium and reliable service to its clients.

All foundation construction and ground investigation services provided by the Group shall be verified by the contractor or surveyor, and the Group believes that this will also help enhance its clients' confidence on and recognition of its services. The Group's quality control system on the design, supply and installation of Rocksocketed Steel H-pile in Pre-bored Hole and Minipile work has been accredited with ISO9001:2015 certification of quality management system by Accredited Certification International Limited. During the YR2022, the Group received no complaints or claims from our customers arising from the quality issues of the work performed by the Group or sub-contractors, which in the view of Directors, is attributable to the effective quality control measures.

Policies of privacy and property rights

Protection of Intellectual Property Rights

The Group is committed to strengthening the protection of intellectual property rights. Therefore, we require employees to strictly abideby the laws and regulations such as the Copyright Ordinance in Hong Kong. We also have clear requirements for the application, management, use and protection of intellectual property for our customers and the Group. The Group keeps a complete record of its intellectual property rights, and only uses genuine software, and employees are required to submit an application to the Group before installing any software to avoid infringing on the intellectual property rights of others. The Group will seek legal advice and take appropriate action if any of its intellectual property rights are infringed upon. If the Group's staff is discovered to be in violation of applicable rules and regulations, they will not only face disciplinary action, but they may also face criminal or civil liability, as stated in the Group's staff handbook.

6. 產品責任

產品質量

本集團從事提供地基建築及土地勘測服務已 逾10年,先後完成數百個項目。本集團獲得客 戶廣泛支持和認可,主要由於我們重視服務質 素,致力為客戶提供優質服務組合。本集團以 滿足客戶需求為目標,建立內部管理體系,嚴 格管理項目執行流程,為客戶提供優質、可靠 的服務。

本集團所提供的地基建築及土地勘測服務均 須由承建商或測量行驗證,而本集團相信此舉 亦有助提升客戶對我們服務的信心及認可。 本集團有關設計、供應及安裝預鑽孔嵌岩式 工字鋼樁及微型樁工程的質量管理體系已獲 國際認可認証有限公司授予品質管理體系已獲 ISO9001:2015認證。於二零二二年度,本集 團概無由於與本集團或分包商完成的工程有 關的品質問題而接獲客戶的任何投訴或任何 賠償要求,而董事將之歸功於有效的品質控制 措施。

私隱及產權政策

保護知識產權

本集團致力加強保護知識產權,因此我們規 定員工必須嚴格遵守香港《版權條例》等法律 及法規。我們亦已就客戶及自身知識產權的 申請、管理、使用及保護作出明確規定。本集 團保留完整的知識產權記錄,且僅使用正版軟 件,僱員在安裝任何軟件前必須向本集團提出 申請,以避免侵犯他人的知識產權。倘知識產 權受到侵犯,本集團將尋求法律建議並採取適 當行動。誠如本集團員工手冊所述,倘發現本 集團的員工違反適用規章制度,彼等將面臨紀 律處分,還可能面臨刑事或民事責任。

During the Year, no violation of laws and regulations relating to intellectual property was involved or discovered by the Group.

Customer Privacy Protection

Apart from the provision of foundation construction and ground investigation services, the Group is also involved in other services and acts as a provider of money lending business.

During the operation of the Group's business, it will have access to personal data of its customers, hence ensuring privacy of its customers' information is one of the most important issues. The Group attaches great attention to the protection of privacy and intellectual property. The Group only collect personal data for its operational needs and clearly informs all customers or persons about the intended use of the data and their rights to review and revise their information. Employees must abide by relevant laws and regulations, such as the Personal Data (Privacy) Ordinance of Hong Kong. They are forbidden to disclose customers' information to third-party without prior consent, adhering to professional ethics at all times. All collected personal data is treated as confidential and securely kept and processed only for the purposes of which it had been collected. Only authorised personnel are able to access and manage sensitive data and information. The Group's employees are prohibited from revealing or capitalising on any confidential matters or client's information no matter during employment or after termination of employment. Any employee who is found to have divulged confidential information to any third parties without authorisation will be subjected to disciplinary actions.

During the Reporting Period, we were not aware of any significant non-compliance with relevant laws and regulations. We did not receive any compliant concerning breaches of clients' privacy nor we have identified any leak or loss of client data. 年內,本集團並無涉及或發現違反知識產權相 關法律法規的情況。

客戶隱私保護

除提供地基建築及土地勘測服務外,本集團亦 提供其他服務,並作為借貸業務提供商。

本集團於其業務過程中會接觸到客戶的個人 資料,因此確保其客戶資料的私隱乃最重要的 事項之一。本集團高度重視對私隱及知識產權 的保護。本集團僅因應營運需要而收集個人資 料,並明確告知所有客戶或人士相關資料的擬 定用涂以及彼等審閱及修改資料的權利。僱員 必須遵守行業相關法律法規,例如香港《個人 資料(私隱)條例》,在未經批準前,不得向第 三方透露客戶資料,時刻堅守職業道德。所有 收集的個人數據均被視為機密,並獲安全地保 存及處理,僅用於收集數據的目的。僅獲授權 人員方可訪問及管理敏感數據及資料。無論於 在職期間亦或是離職後,本集團的僱員均不得 洩露或利用任何機密事項或客戶資料。

任何未 經授權向第三方洩露機密資料的僱員均將受 到紀律處分。

於報告期間,我們並不知悉任何嚴重違反相關 法律及規例的情況。我們並無接獲任何關於侵 犯客戶私隱的投訴,亦無發現洩露或丟失任何 客戶數據。

Communication with customers

The Group actively communicates with its customers to understand their needs and their feedbacks on the services provided by the Group. In the event that the Group's projects could not reach the requirements and expectation of the customers, the Group will actively cooperate with the customers and provide remedies so as to satisfy the requirements of the contractors or surveyors.

Credit approval policy

Money Lending Policy adopted by the Group has been designed to ensure that the Group's business operates in accordance with the Money Lenders Ordinance (Cap. 163, Laws of Hong Kong). The Group will regularly monitor, review and, when necessary, update the existing policy to ensure the money lending business is strictly in compliance with the Money Lenders Ordinance (Cap. 163, Laws of Hong Kong).

The Group is not aware of any material non-compliance with the Personal Data (Privacy) Ordinance (Cap. 486, Laws of Hong Kong), the Trade Descriptions Ordinance, the Money Lenders Ordinance (Cap. 163, Laws of Hong Kong) and other applicable laws and regulations that have a significant impact relating to advertising, labelling and privacy matters relating to products and services provided by the Group in Hong Kong in YR2023.

7. Anti-Corruption

The Group and its subsidiaries all strictly adhere to the Prevention of Bribery Ordinance promulgated by the Hong Kong SAR Government. The Group seeks to further review the customers' information through understanding customers' background by way of interview, thereby identifying and preventing the customers and employees from bribery, blackmail, fraud and money-laundering in any way. The Group will regularly review the implementation of relevant systems and put more resources in improving the mechanism, if necessary.

客戶溝通

本集團積極與其客戶進行溝通,了解客戶需要 以及對本集團所提供服務之意見反饋。如本 集團的項目與客戶的要求及期望出現一些差 異,本集團會積極配合客戶,提供補救措施, 從而達到承建商或測量行之要求。

本集團並不知悉任何嚴重違反香港法例第486 章《個人資料(私隱)條例》、《商品說明條例》、 香港法例第163章《放債人條例》以及對有關本 集團於二零二三年度在香港提供有關產品及 服務的廣告、標簽及私隱事宜有重大影響的其 他適用法律及法規。

7. 反貪污

本集團及旗下附屬公司均嚴格遵守香港特區 政府頒佈之《防止賄賂條例》。本集團通過詢問 了解客戶背景,進一步審閱客戶信息,從而識 別及防止客戶和員工以任何方式進行賄賂、勒 索、欺詐及洗黑錢。本集團會定期檢視有關制 度的執行情況及(如有需要)投放更多資源以 完善機制。

The Group has developed a Whistle-blowing Policy internally. Staff may report to relevant department managers or senior management in the event that they identify any irregularities, and the Group will protect the identity of the informer. The Group shall conduct detailed investigation on the reported event and take appropriate actions according to the result.

The Group has engaged an independent internal control and risk advisory team, which has assisted in monitoring the corporate governance of the Group and in providing an objective assessment to the Board on whether a sound internal control system is maintained and operated by management. The Group also engaged independent auditors to conduct external audit, in order to prevent and control the fraud or wrongdoings within the Group.

The Group strictly regulates the operation of its business to ensure the compliance with local laws and regulations relating to anti-corruption during the course of operation. In YR2023, there was no case of any material noncompliance with the Prevention of Bribery Ordinance and the relevant laws and regulations relating to bribery, extortion, fraud and money laundering in Hong Kong that have a significant impact. In addition, there was no report of significant fines or sanctions as a result of noncompliance with the relevant laws and regulations in YR2023. 本集團內部已制訂舉報政策,若任何員工發現 任何違規事項,可向相關部門主管或高級管理 層舉報,本集團會保護舉報人身份。本集團會 就舉報事件作詳細調查,並根據調查結果採取 適當行動。

本集團嚴格規管其業務營運,以確保於營運過 程中遵守有關反貪污的當地法律及法規。於二 零二三年度,本集團並無任何嚴重違反《防止 賄賂條例》及有關於香港有重大影響的賄賂、 勒索、詐騙、洗黑錢的相關法律及法規的案 例。此外,於二零二三年度,並無因違反相關 法律及法規而招致重大罰款或制裁的報告。

8. Community Investment

The Group is committed to and take pride in contributing to the community in a variety of forms. As a part of the community that it cherishes, the Group has put its best effort in helping the local communities and people in needs in the society and contributing to the well-being of a community beyond financial support. The Group constantly encourages its employees to contribute their skills and time to the community by volunteering its time in the community development and outreach programs. The Group has been striving to "reward the community" in different ways. The Group values its corporate social responsibility by dedicating to improve its staff awareness of community care.

The Group proactively seeks to promote the spirit of corporate social responsibility within the company by organising or participating in appropriate community activities. Through various types of events, we encourage our employees to contribute to the community so as to help the needy and improve the relationship among staff, enterprise and community.

In the coming future, the Group will continue to attach great importance to community services, and will encourage its staff members to be actively engaged in voluntary services and join hands together to disseminate the spirit of services in the community where the Group all depends on.

The total number of shares in respect of which options may be granted under the Scheme is not permitted to exceed 10% of the shares of the Company in issue at any point in time, without prior approval from the Company's Shareholders. The number of shares issued and to be issued in respect of which options granted and may be granted to any individual in any one year is not permitted to exceed 1% of the shares of the Company in issue at any point in time, without prior approval from the Company's Shareholders. Options granted to substantial Shareholders or independent non-executive Directors or any of their respective associates (including a discretionary trust whose discretionary objects include a substantial Shareholders. independent non-executive Directors, or any of their respective associates) in any 12-month period in excess of 0.1% of the Company's share capital or with a value in excess of HK\$ 5 million must be approved in advance by the Company's Shareholders.

Options granted must be taken up within seven days inclusive of the day on which such offer was made, upon payment of HK\$1 per option. Options may be exercised at any time during a period as the Directors may determine which shall not exceed ten years from the date of grant. The exercise price is determined by the Directors, and will be at least the higher of (i) the closing price of the Company's shares on the date of grant; (ii) the average closing price of the shares for the five business days immediately preceding the date of grant; and (iii) the nominal value of the Company's share.

The Scheme will remain in force for a period of ten years commencing on the date of adoption (i.e. 9 May 2015) and shall expire at the close of business day immediately preceding the tenth anniversary thereof unless terminated earlier by the Shareholders in general meeting. Accordingly, the remaining life of the Scheme is approximately 3 years.

No share options were granted since the adoption of the Scheme and there are no outstanding share options at the end of the Reporting Period. The lease agreements were entered into on normal commercial terms and in the ordinary and usual course of business of the Group where each of the relevant percentage ratios calculated for the purpose of Chapter 14A of the Listing Rules is less than 5% and the total fees payable under lease agreements are less than HK\$3,000,000. Pursuant to Chapter 14A of the Listing Rules, the lease agreements are exempt from the reporting, annual review, announcement and independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

The significant related party transactions entered into by the Group during the Reporting Period set out in the consolidated financial statements included transactions that constitute connected/continuing connected transactions for which the disclosure requirement under the Listing Rules have been complied with.

PUBLIC FLOAT

Based on the information that is publicly available to the Company and to the best knowledge of the Directors, the Company has retained the prescribed public float of at least 25% of the Company's total issued share capital as at the date of this annual report pursuant to the Listing Rules.

AUDITORS

The Company has nominated HLB Hodgson Impey Cheng Limited as the auditors of the Group during the Reporting Period until conclusion of the forthcoming AGM.

1. GENERAL INFORMATION

Wan Kei Group Holdings Limited (the "**Company**") was incorporated in the Cayman Islands as an exempted company with limited liability on 7 October 2014 under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands.

The address of the Company's registered office is Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands. The address of the Company's principal place of business in Hong Kong is Unit No. 07, 16/F, Emperor Group Centre, 288 Hennessy Road, Wanchai, Hong Kong. The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 14 to the consolidated financial statements.

The Company's share were listed on the Main Board of the Stock Exchange of Hong Kong Limited ("**Stock Exchange**") on 11 August 2015.

2. SIGNIFICANT ACCOUNTING POLICIES

(a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited. Significant accounting policies adopted by the Company and its subsidiaries (together referred to as the "Group") are disclosed below.

The HKICPA has issued certain new and amendments to HKFRSs that are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 2(c) provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current accounting period reflected in these consolidated financial statements.

(a) 合規聲明

(b) Basis of preparation of the financial statements

The consolidated financial statements for the year ended 31 March 2023 comprise the Company and its subsidiaries.

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis, except certain assets and liabilities are stated at their fair value.

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on the consolidated financial statements and major sources of estimation uncertainty are discussed in note 3.

- (b) 財務報表的編製基準

The Group has not applied any new standard or interpretation that is not yet effective for the current accounting period. Impacts of the adoption of the amended HKFRSs are discussed below:

Amendments to HKAS 16, Property, plant and equipment: Proceeds before intended use

The amendments prohibit an entity from deducting the proceeds from selling items produced before the asset is available for use from the cost of an item of property, plant and equipment. Instead, the sales proceeds and the related cost should be included in profit or loss. The amendments do not have a material impact on these financial statements as the Group does not sell items produced before an item of property, plant and equipment is available for use.

Amendment to HKAS 37, Provisions, contingent liabilities and contingent assets: Onerous contracts – cost of fulfilling a contract

The amendments clarify that for the purpose of assessing whether a contract is onerous, the cost of fulfilling the contract includes both the incremental costs of fulfilling that contract and an allocation of other costs that relate directly to fulfilling contracts.

Previously, the Group included only incremental costs when determining whether a contract was onerous. In accordance with the transitional provisions, the Group has applied the new accounting policy to contracts for which it has not yet fulfilled all its obligation at 1 April 2022, and has concluded that none of them is onerous.

(d) Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company (i.e. its subsidiaries). If a subsidiary prepares its financial statements using accounting policies other than those adopted in the consolidated financial statements for like transactions and events in similar circumstances, appropriate adjustments are made to that subsidiary's financial statements in preparing the consolidated financial statements to ensure conformity with the Group's accounting policies.

Control is achieved where the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group's returns. When the Group has less than a majority of the voting rights of an investee, power over the investee may be obtained through: (i) a contractual arrangement with other vote holders; (ii) rights arising from other contractual arrangements; (iii) the Group's voting rights and potential voting rights; or (iv) a combination of the above, based on all relevant facts and circumstances.

Consolidation of a subsidiary begins when the Group obtains control of the subsidiary and cease when the Group loses control of the subsidiary.

Income and expenses of subsidiaries are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each component of other comprehensive income of subsidiaries are attributed to the equity shareholders of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the equity shareholders of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between entities of the Group are eliminated in full on consolidation.

(e) Subsidiaries and non-controlling interests

Subsidiaries are entities controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power, only substantive rights (held by the Group and other parties) are considered.

Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

Non-controlling interests represent the equity in a subsidiary not attributable directly or indirectly to the Company, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. For each business combination, the Group can elect to measure any non-controlling interests either at fair value or at the noncontrolling interests' proportionate share of the subsidiary's net identifiable assets.

Non-controlling interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Non-controlling interests in the results of the Group are presented on the face of the consolidated statement of profit or loss and other comprehensive income as an allocation of the total profit or loss and total comprehensive income for the year between non-controlling interests and the equity shareholders of the Company. Loans from holders of non-controlling interests are presented as financial liabilities in the consolidated statement of financial position in accordance with notes 2(o) or (p) depending on the nature of the liability.

An associate is an entity in which the group or company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

The cost of the investment includes purchase price, other costs directly attributable to the acquisition of the investment, and any direct investment into the associate that forms part of the Group's equity investment. Thereafter, the investment is adjusted for the post acquisition change in the Group's share of the investee's net assets and any impairment loss relating to the investment (see note 2(k)(ii)). At each reporting date, the Group assesses whether there is any objective evidence that the investment is impaired. Any acquisition-date excess over cost, the Group's share of the post-acquisition, post-tax results of the investees and any impairment losses for the year are recognised in the consolidated statement of profit or loss, whereas the Group's share of the post-acquisition post-tax items of the investees' other comprehensive income is recognised in the consolidated statement of profit or loss and other comprehensive income.

When the Group's share of losses exceeds its interest in the associate, the Group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the investee. For this purpose, the Group's interest is the carrying amount of the investment under the equity method, together with any other long-term interests that in substance form part of the Group's net investment in the associate, (after applying the ECL model to such other long-term interests where applicable (see note 2(k)(i)).

Such elections are made on an instrument-by-instrument basis, but may only be made if the investment meets the definition of equity from the issuer's perspective. Where such an election is made, the amount accumulated in other comprehensive income remains in the fair value reserve (non-recycling) until the investment is disposed of. At the time of disposal, the amount accumulated in the fair value reserve (nonrecycling) is transferred to retained profits. It is not recycled through profit or loss. Dividends from an investment in equity securities, irrespective of whether classified as at FVPL or FVOCI, are recognised in profit or loss as other income.

Any related revaluation surplus is transferred from the revaluation reserve to retained profits and is not reclassified to profit or loss.

Depreciation is calculated to write off the cost or valuation of items of property, plant and equipment, less their estimated residual value, if any, using the straight line method over their estimated useful lives as follows:

Club membership is stated in the consolidated statement of financial position at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses (see note 2(k)).

Amortisation of club memberships with finite useful life is charged to profit or loss on a straight-line basis over the assets' estimated useful lives. Both the period and method of amortisation are reviewed annually.

Club membership is not amortised while their useful lives are assessed to be indefinite. Any conclusion that the useful life of an intangible asset is indefinite is reviewed annually to determine whether events and circumstances continue to support the indefinite useful life assessment for that asset. If they do not, the change in the useful life assessment from indefinite to finite is accounted for prospectively from the date of change and in accordance with the policy for amortisation of intangible assets with finite lives as set above.

(j) Leased assets

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

(i) As a lessee

Where the contract contains lease component(s) and nonlease component(s), the Group has elected not to separate non-lease components and accounts for each lease component and any associated non-lease components as a single lease component for all leases.

Significant increases in credit risk

(I) Other contract costs

Other contract costs are either the incremental costs of obtaining a contract with a customer or the costs to fulfil a contract with a customer which are not capitalised as inventory, property, plant and equipment (see note 2(h)) or intangible assets.

Incremental costs of obtaining a contract are those costs that the Group incurs to obtain a contract with a customer that it would not have incurred if the contract had not been obtained e.g. an incremental sales commission. Incremental costs of obtaining a contract are capitalised when incurred if the costs relate to revenue which will be recognised in a future reporting period and the costs are expected to be recovered. Other costs of obtaining a contract are expensed when incurred.

Costs to fulfil a contract are capitalised if the costs relate directly to an existing contract or to a specifically identifiable anticipated contract; generate or enhance resources that will be used to provide goods or services in the future; and are expected to be recovered. Costs that relate directly to an existing contract or to a specifically identifiable anticipated contract may include direct labour, direct materials, allocations of costs, costs that are explicitly chargeable to the customer and other costs that are incurred only because the Group entered into the contract (for example, payments to sub-contractors). Other costs of fulfilling a contract, which are not capitalised as inventory, property, plant and equipment or intangible assets, are expensed as incurred.

Capitalised contract costs are stated at cost less accumulated amortisation and impairment losses. Impairment losses are recognised to the extent that the carrying amount of the contract cost asset exceeds the net of (i) remaining amount of consideration that the Group expects to receive in exchange for the goods or services to which the asset relates, less (ii) any costs that relate directly to providing those goods or services that have not yet been recognised as expenses.

Amortisation of capitalised contract costs is charged to profit or loss when the revenue to which the asset relates is recognised. The accounting policy for revenue recognition is set out in note 2(v).

A contract liability is recognised when the customer pays non-refundable consideration before the Group recognises the related revenue (see note 2(v)). A contract liability would also be recognised if the Group has an unconditional right to receive non-refundable consideration before the Group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 2(n)).

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

When the contract includes a significant financing component, the contract balance includes interest accrued under the effective interest method (see note 2(v)).

(n) Trade and other receivables

A receivable is recognised when the Group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the Group has an unconditional right to receive consideration, the amount is presented as a contract asset (see note 2(m)).

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses (see note 2(k)(i)).

(p) Trade and other payables

Trade and other payables are initially recognised at fair value. Subsequent to initial recognition, trade and other payables are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at invoice amounts.

(q) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Bank overdrafts that are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents for the purpose of the consolidated statement of cash flows. Cash and cash equivalents are assessed for ECL in accordance with the policy set out in note 2(k)(i).

The administrator of the shares held under share award scheme in the open market for the awards to employees if applicable.

Revenue is recognised when control over a product or service is transferred to the customer, at the amount of promised consideration to which the Group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Net income from trading of beauty and skin care products are recognised when the customers takes possession of and accepts the goods.

Rental income receivable under operating leases is recognised in profit or loss in equal instalments over the periods covered by the lease term, except where an alternative basis is more representative of the pattern of benefits to be derived from the use of the leased asset. Lease incentives granted are recognised in profit or loss as an integral part of the aggregate net lease payments receivable. Contingent rentals are recognised as income in the accounting period in which they are earned.

Interest income is recognised as it accrues under the effective interest method using the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to the gross carrying amount of the financial asset. For financial assets measured at amortised cost or FVOCI (recycling) that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the assets. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset (see note 2(k)(i)).

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. The transaction date is the date on which the Company initially recognises such non-monetary assets or liabilities. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rate underlying at the dates the fair value was measured.

The results of foreign operations are translated into Hong Kong dollars at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Statement of financial position items are translated into Hong Kong dollars at the closing foreign exchange rates at the end of the reporting period. In the process of applying the Group's accounting policies, management has made the following accounting judgements:

(i) Principal versus agent considerations – Trading of beauty and skin care products

In determining whether the Group is acting as a principal or as an agent in the trading of beauty and skin care products, judgements and considerations of all relevant facts and circumstances are required. The Group is a principal in a transaction if the Group obtains control of services provided before they are transferred to customers. If control is unclear, when the Group is primarily obligated in a transaction, and has latitude in establishing prices and selecting publishers, or has several but not all of these indicators, the Group records revenue on gross basis. Otherwise, the Group records the net amount earned as commissions from services provided.

(ii) Determining the lease term

As explained in policy note 2(j), the lease liability is initially recognised at the present value of the lease payments payable over the lease term. In determining the lease term at the commencement date for leases that include renewal options exercisable by the Group, the Group evaluates the likelihood of exercising the renewal options taking into account all relevant acts and circumstances that create an economic incentive for the Group to exercise the option, including favourable terms, leasehold improvements undertaken and the importance of that underlying asset to the Group's operation. The lease term is reassessed when there is a significant event or significant change in circumstance that is within the Group's control. Any increase or decrease in the lease term would affect the amount of lease liabilities and right-of-use assets recognised in future years.

(i) Construction contracts and ground investigation service contracts

As explained in policy note 2(v), revenue from construction contracts and ground investigation services contracts are recognised over time using the output method. Such revenue and profit recognition on uncompleted projects are dependent on estimating the outcome of the contract, as well as the work done to date. Actual outcomes in terms of total costs or revenue may be higher or lower than estimated at the end of the reporting period, which would affect the revenue and profit recognised in future years as an adjustment to the amounts recorded to date.

(ii) Impairment of interests in associates

In considering the impairment that may be required for the Group's associate, recoverable amount of the associate needs to be determined. The recoverable amount is the greater of the fair value less costs to sell and the value-inuse. It is difficult to precisely estimate selling price because quoted market prices for the associate may not be readily available. In determining the value-in-use, expected cash flows generated by the asset are discounted to their present value, which requires significant judgement relating to items such as level of sales volume, selling price and amount of operating costs. The Group uses all readily available information in determining an amount that is reasonable approximation of recoverable amount, including estimates based on reasonable and supportable assumptions and projections of items such as sales volume, selling price and amount of operating costs.

The Group uses provision matrix to calculate ECLs for the trade receivables and contract assets. The provision matrix is based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. At each reporting date, the historical observed default rates are reassessed and changes in the forwardlooking information are considered. In addition, trade and other receivables, contract assets, loan receivables and debt investment at fair value through other comprehensive income with significant balances and credit impaired are assessed for ECLs individually. The provision of ECLs is sensitive to changes in circumstances and forecast general economic conditions. The information about the ECLs and the Group's trade receivables and contract assets are disclosed in note 29(a). If the financial condition of the customers or the forecast economic conditions were to deteriorate, the actual loss allowance would be higher than estimated.

(iv) Fair value of financial assets at FVPL, equity investment at FVOCI and debt investment at FVOCI

The fair value of financial assets at FVPL, equity investment at FVOCI and debt investment at FVOCI that are not traded in an active market is determined by using valuation techniques. The Group uses its judgement to select a variety of methods and determine the fair values primarily based on the purchase price paid by the Group, net asset value and taking into account of the analysis of the investees' financial trends and results, risk profile, prospects, industry trends and other factors. Independent external valuer has been involved in determining fair value of certain investments. The key assumptions adopted on projected cash flow are based on management best estimates.

On 4 September 2020, the Group completed the acquisition of 35% equity interests in Matsu Gami IP Development Limited (the "**Matsu Gami**") and related profit guarantee, call and put option arising from the acquisition by HK\$41,475,000 with HK\$21,475,000 cash consideration deposited into an escrow account and HK\$20,000,000 earnest money which had been paid by the Group during the year ended 31 March 2020. Matsu Gami holds subsidiaries incorporated in BVI, Hong Kong and PRC, which mainly engages in the business of provision of food and beverage catering services utilizing well-known intellectual property right ("**IP Right(s)**") and provision of related advising service.

Under the terms of the sale and purchase agreement and related supplemental agreements, the vendors and the vendor guarantors unconditionally and irrevocably guaranteed and warranted to the Company for each of the two years ending 31 March 2021 and 2022 (the "Guaranteed Period(s)") that: (a) the audited consolidated net profits after tax but before deduction of non-recurring income and expenses of the Matsu Gami and its subsidiaries (together referred to as the "Matsu Gami Group") according to the HKFRSs (the "Actual Profit") shall be meet the minimum profit (the "Guaranteed Profit(s)"); and (b) the Matsu Gami Group acquires at least one IP Right as designated by the Company to be used in relation the Matsu Gami's business(es) (the "Guaranteed IP Right(s)").

The Group operates a Mandatory Provident Fund Scheme ("**the MPF scheme**") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance. 28. SHARE AWARD SCHEME

On 30 June 2022, the Group adopted a share award scheme (the "Share Award Scheme") to recognise the contributions by participants and to provide them with incentives in order to retain them for the continual operation and development of the Group and to attract suitable personnel for further development of the Group.

Subject to any early termination as may be determined by the board of directors (the "**Board**"), the Share Award Scheme shall be valid and effective for a term of ten (10) years commencing on the adoption date. The Board shall not make any further award of awarded shares which will result in the nominal value of the shares awarded by the Board under the Share Award Scheme exceeding ten per cent (10%) of the issued share capital of the Company from time to time. The maximum number of shares which may be awarded to a selected participant under the Share Award Scheme shall not exceed one per cent (1%) of the issued share capital of the Company from time to time.

The Share Award Scheme shall be subject to the administration of the Board and the trustee in accordance with the rules of the Share Award Scheme and the terms of the trust deed. The decision of the Board with respect to any matter arising under the Share Award Scheme (including the interpretation of any provision of the Scheme) shall be final and binding. The trustee shall hold the trust fund in accordance with the rules of the Share Award Scheme and the terms of the trust deed.

During the year ended 31 March 2021, the Group purchased 31,645,000 of its own shares through the trustee from open market. The total amount paid to acquire the shares was approximately \$19,429,000 and has been deducted from equity and such shares were classified as held under the Share Award Scheme. No shares had been awarded by the board of directors under the Share Award Scheme during the years ended 31 March 2023 and 2022.

29. FINANCIAL RISK MANAGEMENT AND FAIR VALUES OF FINANCIAL INSTRUMENTS

Exposure to credit, liquidity and interest rate risks arises in the normal course of the Group's business. The Group is also exposed to equity price risk arising from its equity investments in other entities. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

(a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the Group.

The Group's credit risk is primarily attributable to trade and other receivables, contrast assets, loan receivables and debt investment at FVOCI. The Group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks with sound credit ratings and the Group has exposure limit to any single financial institution. Given their high credit ratings, management does not expect any of these financial institutions and counterparties will fail to meet their obligations.

The Group has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

Trade receivables and contract assets

The Group's exposure to credit risk is influenced mainly by the individual characteristics of customer groups rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. At the end of the reporting period, nil% (2022: 11%) and 22% (2022: 22%) of the total trade receivables was due from the Group's largest customer and the five largest customers respectively within the foundation construction segment.

Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are due within 30 to 45 days from the payment application date or 30 to 60 days from the certificate date. Normally, the Group does not obtain collateral from construction contract and ground investigation services customers.

The Group measures loss allowances for trade receivables and contract assets at an amount equal to lifetime ECLs, which is calculated using a provision matrix based on days past due for groupings of various customer segments with similar loss patterns. In addition, the Group performs impairment assessment under ECL model on trade receivables (and contract assets) with significant balances and credit-impaired individually. As the Group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the Group's different customer bases.

For the loan receivables, the Group's management manages and analyses the credit risk for each of their new and existing customers before standard payment terms and conditions are offered. The management assesses the collateral and credit quality of each customer based on customer's background information, financial position, past experience and relevant factors. The Group also reviews from time to time the financial position of the customers.

For all other instruments including other receivables and loan receivables, the Group measures the loss allowance equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised based on significant increases in the likelihood or risk of a default occurring since initial recognition.
